16. SB 1198 which is just read is a Committee bill from
17. the Committee on Elections and Reapportionment sponsored
18. by all members of the Committee and Senator Daniel Dougherty
19. who is the Co-Chairman of the Elections Laws Commission.
20. What this bill is, is an attempt to create a State Board
21. of Elections in the State of Illinois. I think we're
22. aware that the two bills, the one House bill and the one
23. Senate bill, dealing with...this matter - one has been
24. killed and another has been put over into the Fall Calendar.
25. It was the feeling of the Committee because of the urgency
26. to create a State Board of Elections that this bill should
27. be introduced at this time. It comes about as amended by
28. the Committee after many hours of sub-committee hearings.
29. I believe we have a bill here that will be acceptable to
30. both the Senate and the House members and therefore, Mr.
31. President, I move that Senate Bill 1198 be advanced on
32. the Calendar to the order of Senate Bills second reading
33. without reference to Committee.

1. PRESIDING OFFICER (SENATOR GRAHAM):

2. I think that...Senator Dougherty would represent
3. very specifically the left side of the aisle with regard
4. to this bill and I think that he would like to join you
5. in this motion. Senator Dougherty.

6. SENATOR DOUGHERTY:

7. Mr. President, members of the Senate, I'm very
8. happy to join in this request to place this bill on the
9. order of second reading. As a matter of fact, the bill
10. that I originally introduced that passed this Body 47 to
11. nothing, and the same subject matter was defeated in the
12. House in a whimsical manner. I believe this is an attempt
13. to solve a problem that must be solved by this Session
14. of the Legislature which means setting up a State Board of
15. elections. And I ask that it be advanced to the order
16. of second reading.

9. ...Mr. President, I am referring to four House Bills
10. which were in Local Government Committee last night, House
11. Bills 1106, excuse me, 1006, 1007, 1008 and 1009 and I, at
12. this time, would ask if the Chair would recognize Senator
13. Soper for explanation of the motion that I...would...
14. plan to make to discharge the bills from Committee.

15. PRESIDING OFFICER (SENATOR GRAHAM):

16. Senator Soper, do you wish to explain Senator Fawell's
17. motion which has not been put?

18. SENATOR SOPER:

19. Yes...the bills...are supposed to come out of Committee
20. and I thought that we voted on the bills and I was supposed
21. to handle the bills because he was in another Committee
22. and we were depending on a witness to come in. We had
23. fifty-five bills and I had these marked off as...as if
24. we had passed the bills and...there'll be no objection
25. if they're taken from the Committee, 'cause we...I checked
26. with the Minority spokesman and anybody that had any...
27. any feelings about the bills, Senator Fawell says that
28. we'll bring them out on second reading, he'll hold them
29. till we clear up any objections if there are any. I don't
30. see any objections to the bill.

31. PRESIDING OFFICER (SENATOR GRAHAM):

32. All in favor of the motion explained by Senator Soper
33. which has not been put by Senator Fawell, he hereby puts

1. that motion will signify by saying aye. Opposed?
2. The ayes have it. Gentlemen, I...I have a feeling
3. that we are bordering upon a barrage of requests to
4. discharge the various committees and it would be the
5. feeling of the Chair and I think the leaders on both
6. sides, if we're going to get into that kind of a sit-
7. uation, that my suggestion would be that both leader-
8. ships on both sides would be notified in writing so
9. we can make some decision with regard to some of
10. these motions if they continue to be a problem to
11. us. Is that agreeable with you Senator Harris? It's
12. agreeable with Assistant Majority Leader over here and
13. it's agreeable with Senator Partee. So if you're going
14. to continue to make a lot of requests to discharge
15. bills from Committees we'd like to have an advance
16. notice of it. It's helpful to the Secretary and it's
17. helpful to us. And it'll be helpful to you. Senator
18. McBroom wanted to make a motion and if he'll... All
19. right.

20. SENATOR MCBROOM:

21. Yes, Mr. President and members of the Senate. I'd
22. like to make a motion to discharge the following bills
23. from the Appropriations Committee and I'd be happy to
24. explain them. ...SB 733 and 735 those are bills of
25. Senator Savickas' that apply to the Metropolitan San-
26. itary District. I don't believe there's any discord on...
27. on...or disagreement on...on that discharge motion. It's
28. agreeable with you Senator Savickas? ...I have leave
29. of the Senate?

30. PRESIDING OFFICER (SENATOR GRAHAM):

31. The Senator from Chicago has reached an agreement
32. with the Chairman of the Appropriations Committee that
33. they be removed from further consideration of SB 733
and 755 and be placed on the Calendar on the order of

1. second reading. All in favor signify by saying aye.
2. Opposed. The ayes have it and the bills will be
3. shown on second reading.
4. SENATOR MCBROOM:
5. Mr. Chairman...
6. PRESIDING OFFICER (SENATOR GRAHAM):
7. Senator Partee.
8. SENATOR MCBROOM:
9. Well, you gave the wrong...
10. PRESIDING OFFICER (SENATOR GRAHAM):
11. I'm sorry, Senator. Senator McBroom, I thought you
12. were through.
13. SENATOR MCBROOM:
14. Well, I...
15. PRESIDING OFFICER (SENATOR GRAHAM):
16. ...I was hoping you were.
17. SENATOR MCBROOM:
18. I'm not through, I've got several other motions
19. I want to make but I'll be glad to yield to Senator
20. Partee.
21. PRESIDING OFFICER (SENATOR GRAHAM):
22. You just did. Senator Partee.
23. SENATOR PARTEE:
24. I appreciate that because I'd like for you to make...
25. include HB 70 in your next motion to discharge the
26. Committee. Now let me point out to you and I don't want
27. to take advantage of you because you don't know what
28. it is. Let me point out to you that it is appropriation
29. for another measure which may not pass. It is appropriation
30. for another measure that may not pass. Now it's not
31. going to be called unless the other measure passes but I
32. want it out of the Committee because I actually
33. neglected it and I didn't know it was in there frankly.
PRESIDING OFFICER (SENATOR GRAHAM):

1. Senator McBroom.

2. SENATOR MCBROOM:

3. Is that...is that pertain to the Secretary of

4. State's office, Senator?

5. SENATOR PARTEE:

6. That's right. Now if the other bill doesn't

7. pass the appropriation can't pass anyway but I just

8. want to get it out of Committee if I could.

9. PRESIDING OFFICER (SENATOR GRAHAM):

10. What's your pleasure?

11. SENATOR MCBROOM:

12. Now...Senator...Mr. Porter tells me that we have

13. a request to set...for Mr. Pappas to set that with their

14. omnibus bill, I...I...whatever your pleasure.

15. SENATOR PARTEE:

16. Well, let's get it out, I'll have it out of the way

17. 'cause I've got too many bills now.

18. PRESIDING OFFICER (SENATOR GRAHAM):

19. So have I Senator. What's your pleasure?

20. SENATOR MCBROOM:

21. Okay. That's fine. Leave to discharge HB 70 from

22. the Senate Appropriations Committee but, Mr. Chairman...

23. Mr. President, I've got two or three others motions that

24. I...I'd like to make here before I'm tuned off.

25. PRESIDING OFFICER (SENATOR GRAHAM):

26. I won't let anyone else interfere with your motion,

27. Senator.

28. SENATOR MCBROOM:

29. All right. Is HB 70 discharged, Mr. President?

30. PRESIDING OFFICER (SENATOR GRAHAM):

31. Have you made that motion?

32. SENATOR MCBROOM:

33. I've made that motion.

PRESIDING OFFICER (SENATOR GRAHAM):

1. All...all in favor signify by saying aye.

2. SENATOR MCBROOM:

3. Aye.

4. PRESIDING OFFICER (SENATOR GRAHAM):

5. Opposed? It will now be placed on the order of

6. second reading. Senator McBroom.

7. SENATOR MCBROOM:

8. Now. Going back to Senator Savickas' bills,

9. Mr...President, there's 733 and 735 you inadvertently

10. called one of them 755. I want to make that correction.

11. PRESIDING OFFICER (SENATOR GRAHAM):

12. We just inadvertently...we advertently now did

13. change it from 755 to 735 for the record.

14. SENATOR MCBROOM:

15. All right, now.

16. PRESIDING OFFICER (SENATOR GRAHAM):

17. The bills were 733 and 735. Senate Bills.

18. SENATOR MCBROOM:

19. Fine. Now the next motion is three bills of Senator

20. Harris', House Bills 1504, 1505 and 1506. These are the

21. retirement bills sponsored by Representatives Washburn

22. and they are...are identical to the retirement bills which

23. Senator Weaver passed out of here thirty days ago. I'd

24. like leave...or Senator Harris, pardon me. I'd like leave

25. of the Body to discharge the Appropriations Committee

26. on those three bills. I think I have Senator Hynes'

27. approval.

28. PRESIDING OFFICER (SENATOR GRAHAM):

29. You've heard the request of the Chairman of the

30. Appropriations Committee. Is leave granted? Leave is

31. granted they will be...

32. SENATOR MCBROOM:

33. All right. And this bill, HB 1849, is a bill that

1. do with Senator Hynes, the make up of the Illinois
2. Arts Council which the Chairman of the Assignment
3. of Bills Committee inadvertently assigned to the
4. Appropriations Committee. And Senator Hynes and
5. I have discussed it and we'd like leave of the
6. Body to discharge that.

7. PRESIDING OFFICER (SENATOR GRAHAM):

8. Heard the request of the Senator from Kankakee.
9. All in favor?

10. SENATOR MCBROOM:

11. Aye.

12. PRESIDING OFFICER (SENATOR GRAHAM):

13. Opposed? Your request has been granted. The
14. bill will be placed on the order of second reading.

15. SENATOR MCBROOM:

16. All right. Now, Mr. President, I'd like to...
17. get the number here Mr. President...I'd like to move
18. the Senate Appropriations Committee adopted Amend-
19. ment No. 1 to HB 295. Is Senator Netsch on the
20. Floor now?

21. PRESIDING OFFICER (SENATOR GRAHAM):

22. Will we notify Senator Netsch that she may be a
23. subject of discussion or a part of it.

24. SENATOR MCBROOM:

25. Well, I don't believe that...I don't believe
26. that there's any disagreement to this... Senator
27. Partee or Senator Rock...

28. PRESIDING OFFICER (SENATOR GRAHAM):

29. We'll have to...in the event, it's HB 295 and it
30. is where? It's on second reading.

31. SENATOR MCBROOM:

32. SB 295, Mr. President.

33. PRESIDING OFFICER (SENATOR GRAHAM):

1. SB. We will have to read the bill by title
2. before we make any motions relating to it.
3. SENATOR MCBROOM:
4. All right.
5. PRESIDING OFFICER (SENATOR GRAHAM):
6. Senator Rock.
7. SENATOR ROCK:
8. Well, my understanding is that we are not in
9. favor of that amendment. So I...
10. SENATOR MCBROOM:
11. I'm going to Table it, Senator Rock.
12. SENATOR ROCK:
13. Fine. All right.
14. PRESIDING OFFICER (SENATOR GRAHAM):
15. We will not deal with 295 or we will deal with it,
16. gentlemen? All right. We'll read the bill by title.
17. SECRETARY:
18. SB 295. (Secretary reads title of bill).
19. 2nd reading of the bill. The Committee on Appropriations
20. offers one amendment.
21. PRESIDING OFFICER (SENATOR GRAHAM):
22. Senator McBroom.
23. SENATOR MCBROOM:
24. I move to Table Amendment No. 1.
25. PRESIDING OFFICER (SENATOR GRAHAM):
26. Senator McBroom moves to Table Amendment No. 1 to
27. SB 295. All in favor signify by saying aye. Opposed.
28. The ayes have it and the amendment is Tabled. Any...
29. SENATOR MCBROOM:
30. Now.
31. PRESIDING OFFICER (SENATOR GRAHAM):
32. Senator McBroom.
33. SENATOR MCBROOM:
Thank you, Mr. President. Now I have Amendment

1. No. 2...this amendment reduces the retirement...of...
2. an...in which had been overprojected and I believe Senator
3. Netsch has got those amendments. I don't know if she's
4. delivered them to the Secretary or not.

5. SECRETARY:

6. I have one amendment here with Senator McBroom's
7. name on it. Amendment No. 2 by Senator McBroom.

8. SENATOR MCBROOM:

9. Okay.

10. PRESIDING OFFICER (SENATOR GRAHAM):

11. Senator McBroom.

12. SENATOR MCBROOM:

13. Well, I just explained that I move the adoption of it.

14. PRESIDING OFFICER (SENATOR GRAHAM):

15. Senator McBroom moves the adoption of Amendment
16. No. 2 to SB 295. All in favor?

17. SENATOR MCBROOM:

18. Aye.

19. PRESIDING OFFICER (SENATOR GRAHAM):

20. Opposed? The ayes have it and the amendment is
21. adopted. Any further amendments? 3rd reading.

22. SENATOR MCBROOM:

23. Thank you, Mr. President.

24. PRESIDING OFFICER (SENATOR GRAHAM):

25. Senator Kenneth Hall.

26. SENATOR KENNETH HALL:

27. Thank you, Mr. President. I have a motion on the
28. Secretary's desk I'd like to have read please.

29. PRESIDING OFFICER (SENATOR GRAHAM):

30. We...I would like Senator, if we could, I would like
31. to finish up any...any business we have on transferring
32. the bills then we'll get the motion. May we do that?
33. Do any of the other Senators have motions that they
wish to make relative to amendments calling bills back

1. for amendment or on that order of business at this
2. time. It'll help the Secretary if we do it now.
3. Senator Scholl.

4. SENATOR SCHOLL:

5. Mr. President, I...I would like to ask leave to
6. change the sponsorship of HB 9...change the sponsor-
7. ship of HB 930. I've discussed this with Senator
8. Ozinga and...it's agreed upon. I'd like to show my
9. name as chief sponsor of HB 930.

10. PRESIDING OFFICER (SENATOR GRAHAM):

11. The record will so show but we're confusing the
12. Secretary. I was asking for amendments, gentlemen.
13. We'll get on miscellaneous motions later, if we may.
14. Senator Latherow.

15. SENATOR LATHEROW:

16. Mr. President, I have an amendment on the desk
17. for HB 412.

18. PRESIDING OFFICER (SENATOR GRAHAM):

19. What order of business is HB 412?

20. SENATOR LATHEROW:

21. Third reading, I'd like to..

22. PRESIDING OFFICER (SENATOR GRAHAM):

23. Then your motion is...

24. SENATOR LATHEROW:

25. ...second reading for the purpose of an amendment.

26. PRESIDING OFFICER (SENATOR GRAHAM):

27. Motion is to have SB...HB 412 returned to the
28. order of second reading for the purpose of the consider-
29. ation of an amendment. Is leave granted? It is. The
30. bill is now on the order of second reading. If you'd
31. let us know in advance a little on these bills, just
32. write them on a slip, it'll give the Secretary a chance
33. to get them out of the drawer.

1. SECRETARY:
2. Amen...
3. PRESIDING OFFICER (SENATOR GRAHAM):
4. Senator Latherow.
5. SENATOR LATHEROW:
6. Am I on?
7. PRESIDING OFFICER (SENATOR GRAHAM):
8. I hope so.
9. SENATOR LATHEROW:
10. This amendment, Mr. President, has to do with the
11. taking of the name off trucks under eight thousand pounds.
12. And the amendment says when it is solely for immediate
13. family use or personal use and not for hire. That's
14. more or less the crux of the amendment; it's trying to
15. put it strictly in a position where it's only used as
16. a passenger or vacation vehicle. And I move the
17. adoption of the amendment.
18. PRESIDING OFFICER (SENATOR GRAHAM):
19. Senator Latherow moves the adoption of
20. amendment to HB 412. Signify by saying aye.
21. SENATOR LATHEROW:
22. Aye.
23. PRESIDING OFFICER (SENATOR GRAHAM):
24. Opposed? The amendment is adopted. Any further
25. amendments? Return to the order of third reading.
26. Senator Schaffer, wish to make a similar motion
27. on HB 539?
28. SENATOR SCHAFFER:
29. Yes.
30. PRESIDING OFFICER (SENATOR GRAHAM):
31. Ask leave of the Body to have 539 returned to
32. the order of second reading for the purpose of the
33. consideration of an amendment. All in favor? Leave

1. is granted. Senator Schaffer will explain his
2. amendment.

3. SENATOR SCHAFFER:

4. ...Sen...or HB 539 relates to the appaloosa
5. horse racing. Some of you may recall we received
6. some mail from Tony Scariano and the Racing Board
7. expressing some reservations of the bill. ...We've
8. gotten together with the Racing Board and the
9. appaloosa people and come up with an amendment that
10. puts the bill in shape that the Illinois Racing Board
11. finds acceptable. There's some technical changes...
12. gives them what amounts to a two year trial period.
13. ...Puts some language in relating to...medication
14. of horses of... The appaloosa people finds this
15. amendment acceptable and the Racing Board indicates that
16. with this amendment they can support the passage of
17. the bill and urge the Governor to sign it.

18. PRESIDING OFFICER (SENATOR GRAHAM):

19. All in favor...he moves the adoption...all in
20. favor signify by saying aye. Opposed? The ayes have
21. it. Any...amendment is adopted. Any further
22. amendments? Senator Schaffer, I think the Secretary
23. wants to talk to you.. Back to third reading. Who...
24. who out of that caucus do you want to talk to?
25. Senator Carroll asks leave of the Senate to have HB 1330
26. which was just previously advanced to third reading returned
27. to the order of second reading because he inadvertently
28. forgot to have us consider an amendment. Is leave granted?
29. Leave is granted. HB 1330 is now on the order of second
30. reading. Senator Carroll.

31. SENATOR CARROLL:

32. Thank you, Mr. President, I have, on the Secretary's
33. desk, an amendment that was agreed to in Committee and

1. could not be put on in Committee so I would move
2. the adoption of the amendment as Senate Floor
3. Amendment No. 1. And it raises the fees in order
4. to absorb all the costs.

5. PRESIDING OFFICER (SENATOR GRAHAM):

6. Any further discussion? All in favor of
7. the adoption of the amendment will signify by
8. saying aye. Opposed? The ayes have it. The
9. amendment's adopted. Any further amendments?
10. Back to the order of third reading.

11. SECRETARY:

12. I have an amendment here for Senator Rock on 794.

13. PRESIDING OFFICER (SENATOR GRAHAM):

14. Senator Rock, did...was that SB 794?

15. SECRETARY:

16. HB 794.

17. PRESIDING OFFICER (SENATOR GRAHAM):

18. Do you have an amendment up here on 794?
19. Would you want leave of the Body to have it returned
20. so you might consider that amendment?

21. SECRETARY:

22. 794.

23. SENATOR ROCK:

24. Yes, thank you, Mr...President.

25. PRESIDING OFFICER (SENATOR GRAHAM):

26. Is leave granted? It is and the bill will
27. now be on the order of second reading. Senator Rock
28. will explain his amendment.

29. SENATOR ROCK:

30. Yes. I might...I might call attention to
31. Senator Mitchler, I would...

32. PRESIDING OFFICER (SENATOR GRAHAM):

33. Senator Mitchler.

SENATOR ROCK:

1. ...give him a copy. This is the lead
2. poisoning bill. This amendment is a technical
3. word change amendment only. There's no substantive
4. change made...it was suggested by the Department of
5. Public Health...I will provide you with a copy. We
6. had a little fight on...on other matters in the bill
7. but this...this makes no substantive change. I would
8. move its adoption.

9. SECRETARY:

10. Amendment No. 3. Senator Rock.

11. PRESIDING OFFICER (SENATOR GRAHAM):

12. Any further discussion? Senator Rock moves the
13. adoption of Amendment No. 3 to HB 794. All in favor
14. will signify by saying aye. Opposed? The ayes have
15. it. The amendment is adopted. Any further amendments?
16. Return to the order of third reading. There is a...
17. there is an emergency attached to the passage of HB
18. on third reading 1975, Senator Shapiro. Leave granted
19. to return to the order of House Bills on third to con-
20. sider this bill of an emergency nature. Will the
21. Senator from Amboy explain his bill after we read it.
22. It has been read. Read it by title first, Senator.

23. SECRETARY:

24. HB 1975. (Secretary reads title of bill).

25. 3rd reading of the bill.

26. SENATOR SHAPIRO:

27. ...Mr. President, Ladies and Gentlemen of the
28. Senate, a year ago the Institute for Environmental
29. Quality entered into a contract with the Board of
30. Education for the...conducting of a study throughout
31. the State. ...The monies that the Board of Higher
32. Education had to spend was appropriated to the
33. Institute but there was no provision in the Institute's

1. appropriation to transfer these funds to the
2. Board of Higher Education. As a result, the...

3. PRESIDING OFFICER (SENATOR GRAHAM):

4. Gentlemen. Gentlemen. I need not remind
5. you, I hope, that we are on passage stage of a
6. House Bill and one of your colleagues is attempting
7. to explain to you the content of this bill before
8. you cast a vote on it. Could we have your attention,
9. please? Continue, Senator Shapiro.

10. SENATOR SHAPIRO:

11. ...As a result the Board of Higher Education
12. has expended approximately forty-one thousand dollars
13. of its own money with no way to get the funds from
14. the Institute of Environmental Quality. This bill
15. is a supplemental appropriation of forty thousand
16. nine hundred ninety-three dollars. It will not
17. lead to the expenditure of any additional funds be-
18. cause that amount of money will lapse in the In-
19. stitute's appropriation. And I would ask for a
20. favorable roll call.

21. PRESIDING OFFICER (SENATOR GRAHAM):

22. The motion is, shall HB 1975 pass? Secretary
23. will call the roll. Senator Partee.

24. SENATOR PARTEE:

25. I'm not sure everybody on this side was listening
26. but I urge...

27. PRESIDING OFFICER (SENATOR GRAHAM):

28. I tried to get...

29. SENATOR PARTEE:

30. ...but I urge...an aye...I urge an aye vote on it.
31. This is some very necessary legislation.

32. PRESIDING OFFICER (SENATOR GRAHAM):

33. You had better luck than I did, Senator. Secretary
will call the roll.

1. SECRETARY:

2. Bartulis, Bell, Berning, Bruce, Buzbee, Carroll,
3. Chew, Clarke, Conolly, Course, Daley, Davidson, Donnewald,
4. Dougherty, Fawell, Glass, Graham, Harber Hall, Kenneth
5. Hall, Hynes, Johns, Keegan, Knuepfer, Knuppel, Kosinski,
6. Latherow, McBroom, McCarthy, Merritt, Mitchler, Howard
7. Mohr, Don Moore, Netsch, Newhouse, Nimrod, Nudelman,
8. Ozinga, Palmer, Partee, Regner, Rock, Roe, Romano,
9. Saperstein, Savickas, Schaffer, Scholl, Shapiro, Smith,
10. Sommer, Soper, Sours, Swinarski, Vadalabene, Walker,
11. Weaver, Welsh, Wooten, Mr. President.

12. PRESIDING OFFICER (SENATOR GRAHAM):

13. Johns, aye. Senator Bruce, aye. Senator
14. McBroom indicated an aye vote. On this question
15. the yeas are 38. The nays are none. The bill
16. having received the constitutional majority re-
17. quired is therefore declared passed. One nay,
18. thirty-eight yeas and one nay. Mr. President, do
19. you have...? Yes, we have some motions...we'll
20. now be on the order of motions and hopefully we
21. can get on roll call and other passage bills.
22. Hopefully we are. You didn't miss the boat did
23. you Senator? Senator Knuppel.

24. SENATOR KNUPPEL:

25. I have filed in writing three written motions
26. to take from the Table House Bills 1029, 1437 and
27. 1646...

28. PRESIDING OFFICER (SENATOR GRAHAM):

29. If they're in writing we're going to deal with
30. them now.

31. SENATOR KNUPPEL:

32. I don't want to deal with them, I want...I just
33. wanted to have it journalized and I'd like to have them

1. heard on Tuesday.

2. PRESIDING OFFICER (SENATOR GRAHAM):

3. What bills were you dealing with? Did you
4. get them, Mr. Secretary?

5. SECRETARY:

6. ...It's HB 1029, 1437, 1646. Its written
7. motions to take from the Table and assigned to
8. Senator Knuppel.

9. PRESIDING OFFICER (SENATOR GRAHAM):

10. You have heard the request of the Senator
11. from Virginia, is...wants to have his motion
12. considered Tuesday. Is leave granted? It is
13. granted. Senator Harris.

14. SENATOR HARRIS:

15. Mr. President, I know that when final deadlines
16. finally approach that there's a crunch involved
17. and if our procedure that's been in effect since
18. early April is going to mean anything, I just
19. want to call attention to the Body that I am going
20. to resist pulling from Committees next week bills
21. that were not finally acted on by the Committees.
22. If the work we've been doing and you've been mag-
23. nificent is going to mean anything, then in the last
24. two weeks, our pulling everything out of Committee
25. that everybody had an opportunity to have heard. The
26. Chairman kept every meeting open this week until the
27. end of the call and gave people-now I understand that
28. there are occasions when we need to be two and three
29. and four places at the same time, that's always the
30. case in these final weeks-but I'm just cautioning
31. the Body that when we get to these motions which is
32. the right under the rules for members to make that,
33. we're going to make a travesty of all the work that's
gone forward and Committee evaluation. We're going

1. to start pulling all of these bills out that were
2. not acted upon by Committees. That's only by way
3. of observation and encouragement to be very careful
4. about the support of these motions that I know are
5. going to be forthcoming.

6. PRESIDING OFFICER (SENATOR GRAHAM):

7. Senator Netsch.

8. SENATOR NETSCH:

9. Mr...Mr. President, could I ask you and President
10. Harris a question about one thing that...I think has
11. confronted several of us. A bill came over, I'm sure
12. it was very late this week, I was asked by the House
13. sponsor to...to pick it up which I did. ...I immediately
14. spoke to Senator Graham about getting it assigned and to
15. the chairman of the committee where it was very likely
16. to be assigned but the whole...this was yesterday by
17. then and the whole process broke down. The bill did
18. not get officially assigned and...the bill could not
19. be heard in the last meeting of the committee last night.
20. ...Now what do we do about that? It's just...it's not a bill
21. that was acted on or the sponsor wasn't there, it
22. just simply never had an opportunity to be called.

23. PRESIDING OFFICER (SENATOR GRAHAM):

24. Senator Netsch as the Chairman of the Committee
25. on Committees...of Committee on Assignment of Bills,
26. we as a Committee did meet and we indicated a majority
27. of the Committee that there would be no further
28. assignment of bills beyond the last date of the
29. meeting of the Committee on Committees which was
30. on the 13th. Yesterday it was impossible for me
31. or the other members of the Committee to consider
32. these 30 or 40 bills that are still in the drawers
33. and going along with what Senator Harris has just
said if we're going to honor a bill then we're going

1. to be requested to honor 30, 40 or 50 bills or
2. request for them and the Committee on Committees,
3. ...Committee on Assignment of Bills is not prepared
4. to do that. Senator Bruce.

5. SENATOR BRUCE:

6. Now I have a question because I had a 11 o'clock
7. Pensions Committee meeting at which Senator Conolly
8. brought in a bill, distributed, the Clerk of the
9. Committee did not have the bill and we were told that
10. bill had been assigned this morning.

11. PRESIDING OFFICER (SENATOR GRAHAM):

12. This morning?

13. SENATOR BRUCE:

14. I don't know, he said as soon as we got back upstairs...

15. PRESIDING OFFICER (SENATOR GRAHAM):

16. There was no bills assigned this morning.

17. SENATOR BRUCE:

18. We had...had the bill in...Pensions Committee
19. today and it was distributed.

20. PRESIDING OFFICER (SENATOR GRAHAM):

21. Senator Berning.

22. SENATOR BERNING:

23. Terry Bruce, or Senator Bruce is correct insofar as
24. he goes but let me add the supplement. That bill was
25. not assigned to Committee, our actions were invalid and
26. that bill is stricken.

27. PRESIDING OFFICER (SENATOR GRAHAM):

28. We just...there was no use for the Senate to...
29. incorporating the statement made by Senator Harris and
30. I have met continuously on the Assignment of Bills and
31. this big crunch of bills that came from the House of
32. Representatives after their deadline had been adopted,
33. after we had mutually agreed, we assigned some 300 bills

1. despite the fact that they were not supposed to
2. send them to us and the Committee on Assignment
3. of Bills has adopted a rule to the...that effect
4. so I presume that to override the Committee on
5. Rules decision would take a considerable vote of
6. three-fifths of this Senate to do it. Senator
7. Harris, sorry. Senator Knuppel's motion to hear
8. his...on Tuesday? ...That leave was granted.
9. SECRETARY:

10. A motion submitted by Senator Partee on
11. SB 37 to discharge the Committee on Judiciary
12. from further consideration of the bill and place it
13. on the Senate Calendar on second reading.
14. PRESIDING OFFICER (SENATOR GRAHAM):

15. That is the one that's supposed to be heard
16. Tuesday?
17. SENATOR PARTEE:

18. Sometime next week...Tuesday would be fine. I
19. told Senator Sours, Chairman of Judiciary, that I was
20. making the motion. I wouldn't call it when he's off the
21. Floor anyway. So Tuesday would be fine.
22. PRESIDING OFFICER (SENATOR GRAHAM):

23. ...motion.
24. SECRETARY:

25. A motion by Senator Rock. I move to take HB 1652
26. from the Table and place it on the Senate Calendar on
27. the order of second reading. Signed Senator Phillip
28. D. Rock.
29. SENATOR ROCK:

30. Thank you, Mr. President, Ladies and Gentlemen
31. of the Senate, HB 1652 is that bill which...addresses
32. itself to the question of collective bargaining for
33. teachers. I would ask leave of this Body to argue

1. that motion to take from the Secretary...or take
2. from the Table on Wednesday, June 20th.

3. PRESIDING OFFICER (SENATOR MOHR):

4. Senator Rock ask leave to postpone consideration
5. on HB 602 until next Wednesday. The motion on 602.
6. 1652...is there leave?

7. SECRETARY:

8. Motion in writing. I move to take HB 602 from
9. the Table and place it on the Senate Calendar on the
10. order of second reading. Signed. Senator Kenneth Hall.

11. PRESIDING OFFICER (SENATOR MOHR):

12. Senator Kenneth Hall.

13. SENATOR KENNETH HALL:

14. Thank you, Mr. Chairman...Mr. President, I...like
15. leave of the Senate to have 602...be removed from there
16. and be heard Wednesday of next week.

17. PRESIDING OFFICER (SENATOR MOHR):

18. Senator Hall request leave to...on HB 602 to
19. have that matter heard on Wednesday. Is there leave?
20. Be heard on Wednesday.

21. SECRETARY:

22. House...I move to take HB 1949 from the Table and
23. place it on the Senate Calendar on the order of second
24. readings. Signed. Senator Harris Fawell.

25. PRESIDING OFFICER (SENATOR MOHR):

26. Senator Fawell.

27. SENATOR FAWELL:

28. Yes...this is the bill in regard to the creation...or
29. the renewal of the Commission on Criminal Diagnostic
30. Studies. I'd ask for leave to have the matter heard
31. next Wednesday.

32. PRESIDING OFFICER (SENATOR MOHR):

33.

1. Senator Fawell ask leave to have HB 1949
2. heard on next Wednesday. Is there leave? Leave.
3. Senator Merritt.

4. SENATOR MERRITT:

5. ...Just a point of inquiry, Mr. President, is
6. that just the appropriation bill, Senator Fawell?

7. PRESIDING OFFICER (SENATOR MOHR):

8. Senator Fawell.

9. SENATOR FAWELL:

10. The...it is a bill, as I understand it that,
11. renews the Commission. It is appropriation bill
12. and changes the name of the Commission. Yes.

13. SENATOR MERRITT:

14. Well, it is just an appropriation bill only,
15. I would think. There...because you couldn't have
16. it in with substantive law.

17. SENATOR FAWELL:

18. It is the bill that was heard before Executive
19. so I'll take it back, it is not simply...simply an ap-
20. propriation then I don't believe. It was heard before Ex-
21. ecutive last week. Now, I have not had an opportunity even
22. to take a look at the bill. Representative Byron Duff
23. ask that I file this motion so that we can if we
24. desire to go ahead with an argument on the matter
25. of taking it from the Table on Wednesday.

26. PRESIDING OFFICER (SENATOR MOHR):

27. Senator Saperstein.

28. SENATOR SAPERSTEIN:

29. Mr. President, Ladies and Gentlemen of the
30. Senate, I would ask leave to move SB 1148 from
31. third reading back to second for the purposes of
32. an amendment.

33. PRESIDING OFFICER (SENATOR MOHR):

1. Is there leave? All right, Senator Saperstein
2. does the Secretary have your amendment?
3. SENATOR SAPERSTEIN:
4. Yes.
5. PRESIDING OFFICER (SENATOR MOHR):
6. ...Will you explain the amendment?
7. SENATOR SAPERSTEIN:
8. What the amendment does, it strikes the figure
9. 1350 and substitutes the figure 1300...I should have
10. said...thirteen hundred and fifty dollars to thirteen
11. hundred dollars.
12. PRESIDING OFFICER (SENATOR MOHR):
13. Senator Saperstein moves the adoption...Senator
14. Saperstein moves the adoption of Amendment No. 2.
15. All those in favor signify by saying aye.
16. SENATOR SAPERSTEIN:
17. Aye.
18. PRESIDING OFFICER (SENATOR MOHR):
19. Opposed? Amendment No. 2 is adopted. Any...
20. SENATOR SAPERSTEIN:
21. Move it back to...
22. PRESIDING OFFICER (SENATOR MOHR):
23. Any further amendments? 3rd reading.
24. SECRETARY:
25. To the Members of the Senate. I do hereby
26. appoint the following to serve as members of the
27. Conference Committee on HB 24: Senators Soper,
28. Conolly, Regner, Rock and Romano. ...Sincerely,
29. Howard R. Mohr. Chairman, Committee on Committees.
30. A Message from the House by Mr. Selcke.
31. (Secretary reads message from the House).
32. PRESIDING OFFICER (SENATOR MOHR):
33. Senator Glass.
SENATOR GLASS:

1. Well, thank you, Mr. President and Senators,
2. ...I do move that we recede from Amendment No. 1.
3. The...amendment in question was in error in attaching
4. Amendment No. 2 to the bill it was sought to correct
5. that error. We should have taken off and Tabled
6. Amendment No. 1 and did not do so. So by receding
7. from Amendment No. 1 we will correct that error
8. and I so move, Mr. President.

9. PRESIDING OFFICER (SENATOR MOHR):

10. Senator Glass moves to recede from Amendment
11. No. 1. Secretary will call the roll.

12. SECRETARY:

13. Bartulis, Bell, Berning, Bruce, Buzbee, Carroll,
14. Chew, Clarke, Conolly, Course, Daley, Davidson, Donnewald,
15. Dougherty, Fawell, Glass, Graham, Harber Hall, Kenneth
16. Hall, Hynes, Johns, Keegan, Knuepfer, Knuppel, Kosinski,
17. Latherow, McBroom, McCarthy, Merritt, Mitchler, Howard
18. Mohr, Don Moore, Netsch, Newhouse, Nimrod, Nudelman,
19. Ozinga, Palmer, Partee, Regner, Rock, Roe, Romano,
20. Saperstein, Savickas, Schaffer, Scholl, Shapiro, Smith,
21. Sommer, Soper, Sours, Swinarski, Vadalabene, Walker,

23. PRESIDING OFFICER (SENATOR MOHR):

24. Bartulis, aye. Harber Hall, aye. McBroom, aye.
25. Berning, aye. Carroll, aye. Bruce, aye. Having re-
26. fused to...having received the necessary votes the
27. constitutional majority of 33 to nay, the Senate...re-
28. ceedes from Amendment NO. 1 on HB 35. All right.
29. We'll go to the order of the Secretary's desk.
30. Senator Johns.

31. SENATOR JOHNS:

32. Mr. President, I would like...

33. PRESIDING OFFICER (SENATOR MOHR):

Senator Johns.

1. SENATOR JOHNS:
2. ...I would like to move that off of the
3. Secretary's desk and place it on the Calendar.
4. No. No. I'd like to have a roll call. Move
5. its adoption, you caught me off guard here and...
6. PRESIDING OFFICER (SENATOR MOHR):
7. Move the adoption of what, Senator?
8. SENATOR JOHNS:
9. House Joint Resolution 33. Thank you,
10. Mr. President.
11. PRESIDING OFFICER (SENATOR MOHR):
12. House Joint Resolution 33.
13. SENATOR JOHNS:
14. Well, that...I'm sorry, someone just told
15. me that. I'm right, it's 33, Sir. House Joint
16. Resolution 33.
17. PRESIDING OFFICER (SENATOR MOHR):
18. On the Secretary's desk, the last number
19. House Joint Resolution 33.
20. SENATOR JOHNS:
21. If my eyes don't deceive me, it's House Joint
22. Resolution 33. Yes, Sir, but right here it is.
23. Am I not correct? I am correct. Thank you very
24. much.
25. PRESIDING OFFICER (SENATOR MOHR):
26. Senator Johns moves the adoption of House
27. Joint Resolution 33. Will you explain that...
28. the resolution, Senator?
29. SENATOR JOHNS:
30. The...resolution is from the House of
31. Representatives Minority Leader Clyde Choate which
32. asks that the Treasurer of the State of Illinois
33. throughout the State place State monies into banks

1. that will agree to make low interest loans
2. to those victims of floods in order to help them
3. ...renew their livelihood and to rebuild what has
4. been lost in the flood.

5. PRESIDING OFFICER (SENATOR MOHR):

6. Senator Harris.

7. SENATOR HARRIS:

8. Mr. President, essentially the thrust of this
9. Joint Resolution is that a Joint Committee of the
10. two Houses will call upon the State Treasurer and
11. develop a policy with the State Treasurer to pro-
12. vide some relief in the administration of State
13. funds deposited a transfer into flood areas to in-
14. crease their lending capacity - that kind of thing.
15. ...Perfectly valid...activity on the part of the
16. General Assembly, the State Treasurer would be
17. happy to see us pass this resolution. ...I have
18. been approached by...several members of the General
19. Assembly in whose areas there has been particular
20. flood...damage...and hardship. I would urge the
21. members of this side of the aisle to support the
22. adoption of this resolution.

23. PRESIDING OFFICER (SENATOR MOHR):

24. ...The question is...on the adoption...House
25. Joint Resolution 33. All in favor signify by saying
26. aye. Opposed? The resolution is adopted. Senator
27. Mitchler, Senate Joint Resolution 27.

28. SENATOR MITCHLER:

29. Yes, Mr....Mr. President, members of the Senate,
30. Senate Joint Resolution 27 is an expression of the
31. General Assembly to the Governor to proclaim the week
32. in each year containing Thanksgiving Day as Illinois
33. Family week. This is in conformance with the Federal

1. Program, they had legislation adopted by Congress
2. and I've spoken to the Governor about this, he's
3. in accord with it, he would appreciate our cooperation
4. in this effort. The thrust of the purpose behind this
5. would be to have the week of Thanksgiving...that week
6. identified as Illinois Family Week because it is a
7. week in which most families have reunions and get together,
8. emphasizing the importance of having family ties and re-
9. newing family friendships. And I would ask for a fav-
10. orable support of this Resolution.

11. PRESIDING OFFICER (SENATOR MOHR):

12. The question is, shall Senate Joint Resolution 27
13. be adopted? All those in favor signify by saying aye.
14. Opposed? The resolution is adopted. Senate Resolution
15. 99, Senator Harris.

16. SENATOR HARRIS:

17. This resolution essentially does just what the
18. Calendar says. It urges school board administrators,
19. teachers college and university administrators to con-
20. sider, and I emphasize the word consider, the utilization
21. of mass media instruction by technology through all means
22. available. This resolution was adopted in the House last
23. year...it reached my desk at the time but that I was absent from
24. Senate activity. I have a group of...educators that are
25. interested in implementation of the and utilization of mass
26. media techniques in education. It is not mandatory in any way
27. rather harmless kind of thing but one significant group
28. of Legislators would like to hear this expression from
29. the Senate as well as from the House. I would urge its
30. adoption.

31. PRESIDING OFFICER (SENATOR MOHR):

32. The question is, shall Senate Resolution 99 be adopted?
33. All those in favor signify by saying aye. Opposed? The...

1. Resolution is adopted. Senator Sours on SB 105.

2. SENATOR SOURS:

3. Yes. ...Mr. President, that was a bill passed
4. this Chamber sometime ago that attempted to avoid
5. the personal service of summons upon grand jurors
6. and petit jurors. It passed the Senate...providing that
7. the notice be sent by registered letter. Got to
8. the House and it seems like the sheriffs of Illinois
9. and the 102 counties...some of them probably not
10. having enough to do, others very busily engaged
11. thought they were being deprived of county business.
12. So the amendment put on, and I don't care, directs
13. the Circuit Clerk to send down to the sheriff the
14. notices and the sheriff mails these notices to
15. the prospective jurors. ...It's almost...now you
16. see it, now you don't. Frankly, I don't care. I...I
17. still think it's a good bill. It will save the sheriffs
18. going out in cars to serve summons on grand and petit
19. jurors. If the sheriff wants the honor, if any, of mailing
20. these notices to the recipients, that's fine with me.
21. So I move we concur.

22. PRESIDING OFFICER (SENATOR MOHR):

23. The question is, shall the Senate concur in House
24. Amendment No. 1? And on that question the Secretary will
25. call the roll.

26. SECRETARY:

27. Bartulis, Bell, Berning, Bruce, Buzbee, Carroll,
28. Chew, Clarke, Conolly, Course, Daley, Davidson, Donnewald,
29. Dougherty, Fawell, Glass, Graham, Harber Hall, Kenneth
30. Hall, Hynes, Johns, Keegan, Knuepfer, Knuppel, Kosinski,
31. Latherow, McBroom, McCarthy, Merritt, Mitchler, Howard
32. Mohr, Don Moore, Netsch, Newhouse, Nimrod, Nudelman,
33.

1. Ozinga, Palmer, Partee, Regner, Rock, Roe, Romano,
2. Saperstein, Savickas, Schaffer, Scholl, Shapiro, Smith,
3. Sommer, Soper, Sours, Swinarski, Vadalabene, Walker,
4. Weaver, Welsh, Wooten, Mr. President.

5. PRESIDING OFFICER (SENATOR MOHR):

6. Harber Hall, aye. Kenneth Hall, aye. Hynes, aye.
7. Kosinski, aye. On that question the ayes are 31. The
8. nays are 1. The Senate concurs with the House. Ask
9. the members of the Senate to remain in the area for
10. another ten minutes or so and we should be able to con-
11. clude our business but it's important that we have bodies
12. on the Floor, please. Senate Resolution 121.

13. SENATOR BARTULIS:

14. Thank you, Mr. President, members of the Senate,..
15. Senate Resolution 121 is a resolution for Jacksonville
16. State Hospital, more or less for the Governor and the
17. administration and other administration officials to
18. consider the social and economic needs for Jacksonville
19. State Hospital and to take all necessary steps to
20. effect its continued use and possible expansion. Now
21. Jacksonville State Hospital, most of you know, is the
22. first mental health facility established in the State
23. of Illinois. And during its long and illustrious 126 year
24. career has been the focal point of numerous innovations
25. in mental health field and I would hope...favorable roll.

26. PRESIDING OFFICER (SENATOR MOHR):

27. Senator Partee.

28. SENATOR PARTEE:

29. Well, I don't believe in doing by a bill what you
30. can do with a telephone call or by a walk down to the
31. second floor. But I think the thing that troubles me most
32. about the resolution is that it assumes something which
33. is not in evidence. It assumes that the Governor has

1. not taken into consideration all of the things which
2. are obvious and apparent to you. Now we could do
3. that with an awful lot of things; there have been cuts
4. in mental health and other areas in my area which
5. come as a result of a planned program of the Governor
6. and the director of that department. I think it's
7. simply wrong for us to go on record as saying by
8. inference that he is not taking into consideration the
9. things that you talk about. I am quite as disturbed
10. as you are about some of the mental health cuts and
11. cuts in some of the other programs, junior colleges
12. and others. But I don't think we ought to formulize
13. that by saying to him in a resolution...by inference
14. that we don't think he's taking into consideration
15. the basis on which he made his decision.

16. PRESIDING OFFICER (SENATOR MOHR):

17. Senator Harris.

18. SENATOR HARRIS:

19. Well, I can recall in Executive Committee reading
20. this...resolution on one of the occasions, when a
21. delegation from Jacksonville were there waiting and
22. ultimately didn't get called that day but I don't
23. think it's, the fact that this is by inference...
24. suggesting that the Governor hasn't failed to take
25. any appropriate actions in maintaining the operation
26. of this...venerable old institution. It only suggests
27. that the Governor consider the social and economic
28. need for the continued use and operation of Jackson-
29. ville State Hospital and I don't think it does any
30. more than that. Now the people within Jacksonville
31. would be reassured if the General Assembly were to
32. make this...comment, so to speak, and communicate it
33. to the Governor. I see nothing offensive about it.

1. It does not ...imply to my evaluation at all that
2. there is anything negative expressed or derogatorily
3. expressed but only that the Governor consider the
4. social and economic effect of the continued operation
5. and use of Jacksonville State Hospital. I would
6. hope that the Senate would see it in that light and
7. not conclude that there is something negative in our
8. favorable adoption of this resolution. I would urge
9. that we communicate this message by phone call in
10. addition to this...framed...nicely...prepared com-
11. munication of a Senate Resolution.

12. PRESIDING OFFICER (SENATOR MOHR):

13. ...Bartulis. The question is, shall Senate
14. Resolution 121 be adopted? All those in favor signify
15. by saying aye. Opposed. The resolution is adopted.
16. House Joint Resolution 14, Senator Partee.

17. SENATOR PARTEE:

18. There was an amendment to have been adopted to this
19. one pursuant to Senator Harris' request that the
20. membership on this committee be reduced from 16 to
21. 8. Has such an amendment been adopted? It has
22. been. Thank you. Then, Mr. President, House Joint
23. Resolution 18 would create a special joint committee
24. of 8 persons from the House and Senate to study the
25. rules and regulations of the Pollution Control Board
26. in order that they might determine the impact of the
27. rules economically and otherwise. The enforcement
28. and prosecution under that Act and be able to make a
29. periodic report to the House and Senate. Many is
30. the time in an area such as this where there is so
31. much to be known and many of us get just little facets
32. of it as it affects our individual districts we felt it could
33. ...a special joint commission of the House and Senate

1. would be very helpful to us and edifying us as to
2. what needs to be done to keep our Pollution Control
3. Board on course. And to, of course, in the interest
4. of our constituency make certain that we have as
5. healthy an environment as is humanly possible.
6. I know of no opposition to the bill and I ask for
7. its adoption to this resolution.

8. PRESIDING OFFICER (SENATOR MOHR):

9. The...any further discussion? The question
10. is, shall House Joint Resolution 14 be adopted?
11. All those in favor signify by saying aye. Opposed?
12. ...Resolution is adopted. Go down to the con-
13. stitutional amendment. First reading. Secretary.

14. SECRETARY:

15. Senate Joint Resolution 15 constitutional
16. amendment.

17. (Secretary reads Senate Joint Resolution 15).
18. 1st reading of the resolution.

19. (Secretary reads House Joint Resolution 16).
20. 1st reading of the resolution.

21. PRESIDING OFFICER (SENATOR MOHR):

22. Any other motions or business to come before the
23. Senate? I would like to move to Table HB 361. Senator
24. Carroll, do you have any of your bills that you'd like to
25. Table? It's on 3rd reading. All those in favor of Tabling
26. HB 361 signify by saying aye. Opposed? The Bill is Tabled.
27. I thought maybe that would start something here. Anybody
28. else have any bills they'd like to Table? Any further
29. business to come before the Senate? President Harris.

30. SENATOR HARRIS:

31. Just remind everybody that we're coming in at noon.
32. We will have the problem of committees off of our back
33. with one exception, Senator Ozinga has requested and...

1. and I approved, the scheduling of Executive Committee
2. to deal with resolutions and nominations. They will
3. meet next Wednesday. Executive will meet next Wed-
4. nesday at 2:15, otherwise I anticipate that our Senate
5. schedule will be as the June schedule provided.
6. This coming week we can work on Floor action and get
7. closer and closer to having this Calendar in good
8. manageable shape. I might further announce that we
9. intend to have available for distribution early in
10. the week another Agreed Bill List. But we are going
11. to work on that over the weekend as a result of the
12. bills that have...will have been reported today and
13. those that still remain on the Calendar that have
14. come on the Calendar subsequent to the last development
15. of an Agreed Bill List. So the prospect is that we
16. should be in pretty good shape next week and the only
17. exception to our preposted schedule is that on
18. Wednesday afternoon Executive will meet and there
19. will not be an afternoon Session of the Senate on
20. that day. ...Yes, and I think you are all aware that
21. Appropriations bills are exempted from the question of
22. the operation of Rule 5.

23. PRESIDING OFFICER (SENATOR MOHR):

24. Any further business? There being no further
25. business the Senate will stand adjourned until noon
26. on Monday.
