of the 78th GENERAL ASSEMBLY
November ⁸/₇, 1973

1. PRESIDING OFFICER (SENATOR MOHR):

2. The First Special Session will now come to order.
3. Reading of the Journal. Senator Shapiro.

4. SENATOR SHAPIRO:

5. Mr. President, I move that the reading of the
6. Journals for the Special...2nd Special...1st Special
7. Session, for the Journals of Tuesday, November 6th,
8. 1973 and Wednesday, November 7th, 1973 be postponed
9. until the printed Journal arrives.

10. PRESIDING OFFICER (SENATOR MOHR):

11. Senator Shapiro moves that the Journal be
12. accepted as read for November 6th and November 7th...
13. postpone the reading of the Journal on November 6th,
14. 7th until the printed copy arrives. All those in
15. favor signify by saying aye. Opposed. Motion carries.
16. We'll go into...on the 1st Special Session we'll go
17. into Senate Bills on 2nd and a number of sponsors have
18. requested the bills are to be moved with the under-
19. standing they will be...can be brought back for amendment
20. on Tuesday. We'll start with SB number 1, Senator
21. Donnewald.

22. SENATOR DONNEWALD:

23. Well, Mr. President, as to the series 1, 2, 3, 4
24. and 5, I would ask that they first of all, I would move
25. them to 3rd with the understanding that I will bring
26. them back for the purpose of amendment, if that's all
27. right with the Body. But I have...I have Amendment No.
28. 1 to SB 2 which is a technical amendment correcting a
29. date and the proper underlining of language. That's on
30. SB 2. I gave the amendments to the Secretary yesterday.

31. PRESIDING OFFICER (SENATOR MOHR):

32. All right, we're going to take these one at a time.

33. SENATOR DONNEWALD:

1. All right.

2. PRESIDING OFFICER (SENATOR MOHR):

3. ...at the request of the Secretary.

4. SENATOR DONNEWALD:

5. All right.

6. PRESIDING OFFICER (SENATOR MOHR):

7. SB 1, you wish that advanced to 3rd?

8. SENATOR DONNEWALD:

9. I would...I would advance it to 3rd with the proviso

10. that it would be returned for purposes of amendment.

11. PRESIDING OFFICER (SENATOR MOHR):

12. All right, any amendments from the Floor at this

13. time? Secretary will read the bill.

14. SECRETARY:

15. SB number 1 (Secretary reads title of bill)

16. 2nd reading of the bill. No committee amendments.

17. PRESIDING OFFICER (SENATOR MOHR):

18. Any amendments from the Floor? 3rd reading. SB

19. number 2. Senator Donnewald.

21. SB number 2 (Secretary reads title of bill)

22. 2nd reading of the bill. No committee amendments.

23. Amendment No. 1 by Senator Donnewald.

24. PRESIDING OFFICER (SENATOR MOHR):

25. Senator Donnewald, will you explain the amendment.

26. SENATOR DONNEWALD:

27. Yes Mr. President this is merely a technical amendment.

28. It correct a date, I think it said 1874, it should be

29. 1974. And the other portion of the amendment is the

30. underlining of the pertinent new language. And I would

31. move for its adoption.

32. PRESIDING OFFICER (SENATOR MOHR):

33. Any discussion? Senator Donnewald moves the adoption

1. of Amendment No. 1 to SB number 2. All those in favor
2. signify by saying aye. Opposed. Amendment No. 1 is
3. adopted. If any of the members have amendments for
4. any bill today, I think that the leadership on both
5. sides of the aisle should be provided a copy of that
6. before we get into that. Senator Donnewald.

7. SENATOR DONNEWALD:

8. Mr. President, SB 2 of course will be treated in
9. the same manner as SB 1, with the provision...the
10. proviso that it would be returned for purposes of
11. amendment, next week.

12. PRESIDING OFFICER (SENATOR MOHR):

13. Yes, we have...

14. SENATOR DONNEWALD:

15. ...desire to amend they will be returned for the
16. purpose of amendment.

17. PRESIDING OFFICER (SENATOR MOHR):

18. We have that agreement on all...all bills being
19. moved to 3rd today.

20. SENATOR DONNEWALD:

21. Yes.

22. PRESIDING OFFICER (SENATOR MOHR):

23. I think that's the understanding. SB number 3.

25. SB 3 (Secretary reads title of bill)

26. 2nd reading of the bill. No committee amendments.

29. SB number 2 should also be advanced to the order of
30. 3rd reading. SB number 4.

26. Well, I meant the series of five, that I am the
27. principal sponsor of. If it would be all right with
28. the President if we could recess this Session. There
29. are two amendments that we could probably dispose of
30. today if that's the desire of the Chair and the Body.
31. That would be as to SB 1. We will present the amendments
32. to the Chair and to the leadership...

32. I'd like to question of Senator Rock.

2. SENATOR GRAHAM:

3. You did...you did advance number 6 too Senator. I
4. am only wondering at this point in time if we shouldn't
5. search the content of these two bills to the extent that
6. they might be in conflict with the intent and purposes
7. of the construction of the State Election Board...State
8. Board of Elections which is in limbo at this current time
9. with regard to appointment of members. I'm wondering
10. if a proviso might not be well to be considered in these
11. bills amendment-wise or otherwise to the extent that if
12. in fact at the formation of the State Board of Elections
13. they might want to have this authority rather than the
14. Secretary of State. Now, I...I just think that by an amend-
15. ment now, Senator Rock we might avoid the possibility of
16. having to introduce a bill at some later time.

17. PRESIDING OFFICER (SENATOR MOHR):

18. Senator Rock.

19. SENATOR ROCK:

20. Yeah, let me assure you Senator I think the
21. thought is well taken and I will hold the bills until
22. we have a chance to discuss it and
23. iron it out. I think it's a good point.

24. PRESIDING OFFICER (SENATOR MOHR):

25. SB 11, Senator Rock.

26. SECRETARY:

27. SB 12 (Secretary reads title of bill)
28. 2nd reading of the bill. No committee amendments.

29. PRESIDING OFFICER (SENATOR MOHR):

30. Any amendments from the Floor?

31. SECRETARY:

32. Amendment No. 1 by Senator Harris.

33. PRESIDING OFFICER (SENATOR MOHR):

1. Senator Harris.

2. SENATOR HARRIS:

3. This amendment makes some technical changes and
4. correction and puts into the bill what was an inadvertent
5. omission, the word amount called for in the reports. I
6. mean it includes the word the amounts in the report
7. section...of the 15 day period prior to an election and
8. on the annual report. I move the adoption of the amendment.

9. PRESIDING OFFICER (SENATOR MOHR):

10. Senator Harris moves the adoption of Amendment No.
11. 1 to SB 11. All those in favor signify by saying aye.
12. Opposed. Amendment No. 1 to SB 12...all those in favor
13. signify by saying aye. Opposed. Amendment is adopted.
14. SB 13, Senator Nimrod, do you wish that bill moved?
15. Do you...you have another amendment? Sorry.

16. SECRETARY:

17. Amendment No. 2 by Senator Harris.

18. PRESIDING OFFICER (SENATOR MOHR):

19. Senator Harris.

20. SENATOR HARRIS:

21. This amendment provides clar...clarifying language
22. that the candidate referred to in Section 20-15 that he
23. be a candidate who is standing for election. So that
24. that question is not...going to continue. There was some
25. doubt about that. Really, I guess you'd call this just
26. a technical amendment. I move the adoption of Amendment
27. No. 2 to SB 12.

28. PRESIDING OFFICER (SENATOR MOHR):

29. Senator Harris moves the adoption of Amendment No.
30. 2 to SB 12. All those in favor signify by saying aye.
31. Opposed. Amendment No. 2 is adopted. Further amendments?
32. 3rd reading. SB 13, Senator Nimrod.

33. SECRETARY:

1. SB 13 (Secretary reads title of bill)
2. 2nd reading of the bill. No committee amendments.
