Mr. President and members of the Senate, I am rising to 1. be supportive of this committee report. This is a fairly gargantuan 2. task to be able to take from the talent and expertise and skills з. of the many members of this Body and fashion it into this kind 4. of a document, which is expressive of all of the normal and 5. natural considerations that go into making those choices. 6. Members, of course, have philosophical differences, we come 7. from different parts of the State. Our experiences, our skills, · 8. our seniorities, our personalities do vary and that's what makes 9. the world, I suppose, interesting. But, this committee has made 10. this report and it is an extension of the judgement and thought 11. process and many laborious hours of labor, from both the Rep-12. blican and Democratic leadership. And this is the report. Now 13. it is absolutely axiomatic that fifty-nine people could never be 14. absolutely satisfied with any work product. We don't live, of 15. course, in Utopia. And we only, conscientiously, applied our-16. selves to the task of genuinely trying to accommodate the over-17. whelming maj. . . overwhelming majority of the members of the 18. committee. Taken into consideration that we will perhaps get away 19. from the proxy situation, we tried to build in as few conflicts 20. as possible. My recollection of the assessment of conflicts, 21. which now exist, are perhaps two maybe three which I think in 22. of itself speaks to the excellence of the product. Now there are 23. some things that might have been done differently, but had they 24. been done differently, there would have been more problems 25. created than there were solved and I suggest to you that this is 26. a . . . an excellent committee report and its approval should be 27. forthcoming. 28.
