- 14. the debate on this particular question yesterday, Senator Rock
- 15. raised some questions about whether this particular bill
- 16. ought to come before the Body before an adequate time had been
- 17. had for committee hearing. I would like to respond to that
- 18. in this way. There are many of us who supported the Regional
- 19. Transit Authority legislation and who believed in the RTA as
- 20. a necessary agency for the six county area. I, personally,
- 21. supported it and went out on the hook, went out and debated
- 22. in favor of the RTA and was pleased to see it pass. I am,
- 23. however, extremely chagrined and disappointed at the way
- 24. that agency has been operating and those of us who feel...who
- 25. hold similar views have made an effort this Session to have
- 26. legislation passed out of the Rules Committee and sent to
- 27. a committee for hearing so that we might make reasonable changes
  - 28. in the RTA structure, and goodness knows they are drastically
  - 29. needed. It was the intention certainly in my case, and I think
  - 30. the rest of the Body, to acquire a two-thirds vote for the
  - 31. taking of any significant action by the RTA Board. That, in
  - 32. fact, is not the way that the RTA has operated. Instead of
  - 33. that, the Chairman who is not only the executive director of

the RTA, but is also a voting member has run roughshod over 1. the board and has become virtually a dictator in the operation 2. of that agency to the detriment of the entire region and par-3. ticularly to the suburban area. So, I would say to those of 4. you who have doubts about the intentions on this side of the 5. aisle. We want to make this agency an agency that works, and 6. we intend to do that if this bill comes out on the Floor. 7. intend to make needed improvements to it so that it can be 8. effective. We're certainly willing to accept reasonable amend-9. ments to the bill, at least speaking for myself, but I think 10. it's vital that we don't just let this problem languish and 11. drag on for another year and let that six-county region possibly 12. go down and aggravate the existing crisis that we have there 13. with the refusal of Mr. Pikarsky to resign and the adamant posi-14. tion of the suburban board members not to approve the budget. 15. Thank you, Mr. President and Ladies and Gentlemen of the Senate. I just wish to point out that Senator Glass at least said he was attempting to respond to my query of yesterday. The query was, in fact, that there are certain members here who purport to run under the banner of and in allegiance with common cause and sunshine government and all those good things, and then they purport to destroy the committee system and purport to bring out a bill upon which no hearing, in fact, has been held and, in fact, the public has not been invited to participate in the process. Senator Glass did not, in fact, answer that query and I maintain my position as of yesterday.

           I would respectfully point out to the previous speaker
      that as of today the membership of this Body has had more
 2
      time to consider the bill before us than we had to vote on
 3
      the original RTA package. I pointed out to Senator Egan,
 4
 5
      who's not present, yesterday he made some comments about having
 6
      their first chance to review this bill in the "John" over
      in the State Office Building. I would point out to him,
 7
      speaking as a representative of the collar counties, that those
 8
      of us in the...from the collar counties didn't feel the need
 9
      to visit the "John" until after we read the original RTA bill.
10
      I think that this motion is very germane, and I think we
11
      should definitely get at it this Session. There are those
12
      of us who have opposed the RTA who have...are not opponents
13
     of mass transit, and I think that a careful review of my record,
14
      Senator, would indicate to you that I have supported supple-
15
     mental appropriations for the CTA, because I realize that
16
     we are indeed interrelated all of us in this State, and I fear
17
18
     that the opposition the growing opposition, and you may wonder
     how opposition in an area like mine can grow when it starts
19
     out at ninety-three percent "No" and seven percent "Yes". I
20
     submit to you that if that referendum were to be held again
21
     today, the RTA would be severely defeated and the reason it
22
     would be defeated is because of the management of the Pikarsky
23
     regime. This bill addresses itself to that problem and the
24
     solution to that problem. I think it's obvious to all of us
25
     in the six-county area whether we care to admit it or not
26
     that the RTA to date has been a miserable failure. It has,
27 -
     I admit, met the financial needs of the CTA, but I suggest to
28
     you that the votes were here in the General Assembly for an
29
     appropriation to solve that problem on a year to year basis
30
     without the creation of the RTA. I think that if we are in-
31
     terested in a meaningful, and I might add a very important
32
     word, fair RTA, that this type of legislation which would for
33

- the first time create a truly regional RTA would be a major
- 2 step in that direction, and I would hasten to point out to
- 3 those of you who probably and correctly view me as a militant
- 4 opponent of the RTA, that this bill does not go as far as
- 5 Senator Schaffer, and I suspect several other Senators from
- 6 the RTA collar areas. We, of course would prefer an opt out.
- We would as a matter-of-fact be prepared to have a referendum
- 8 that took a three to one majority to let us out. We are that
- 9 convinced that out people would give us that kind of a majority.
- 10 It's obvious that that type of referendum is not in the making
- 11 whether we like it or not. Consequently, I think this type
- of legislation which would bring some balance, if you will...

- 31 the meeting, there was a quoram present, there was a vote
- 32 as to adjournment which was turned down. There was a vote
- as to recessing which was turned down. As I recall the debate

- l. yesterday and the sequence of events that took place and so, 2. my feeling as a member of that committee and as a sponsor of 3. the bill that in fact, it is here in proper order to be acted 4. upon at this time. Now, I guess all of you know how I, 5. as a Senator from Will County, one of the collar counties, 6. feel about the Regional Transit Authority. SENATOR MITCHLER:

10. Thank you, Mr. President and members of the Senate. 11. motion to discharge the committee, the Transportaion Committee 12. of the Senate, and allow this committee bill to come to the 13. Floor of the Senate is most appropriate in this Session of the 14. Illinois General Assembly. The reason I say that is because 15. of the activity of the RTA Board since its inception. 16. all of us know that when the vote was taken at the referendum 17. that all five of the collar counties, Lake County, McHenry 18. County, Kane County, DuPage County and Will County, overwhelmingly 19. voted in opposition to the Regional Transportation Authority 20. Act. They voted as high as twelve to one in opposition, and 21. also significant, the suburban Cook County area outside of 22. the City of Chicago voted in opposition to the RTA. The only 23. place that the RTA referendum carried was in the City of 24. Chicago and by virtue of a few scattered affirmative votes in 25. the five collar counties and suburban Cook County there was 26. more affirmative votes than negative votes and the Act was 27. adopted by referendum. Now, what we have here and the reason 28. that this bill should be considered, so that we can address 29. ourselves to the RTA Act this Session, because that board, an 30. appointed board, not elected by the people, has the authority 31. to impose taxes on the people. Now, the people in the six 32. county RTA area do not like that idea of having nonelected 33. people impose taxes upon the people of that six county area.

- 1 It is then admitted by the members of the Board, and particu-
- 2 larly the Chairman, that it is going to be necessary to im-
- 3 pose a five percent tax on gasoline in the six county area
- 4 in order to raise revenue to carry through the programs that
- 5 have been mandated by the RTA Board. Now, that power of
- 6 taxation should not be with nonelected people and the people
- 7 are in furor in the six county area. They dislike the Chairman,
- 8 they dislike the actions of the Board, they dislike the RTA.
- 9 They would ask that it be repealed, and that is why we should
- 10 have this bill come forward...
- 11 PRESIDING OFFICER: (SENATOR DONNEWALD)
- 12 Senator, just a moment. Your time has expired.
- 13 Senator Partee.
- 14 SENATOR MITCHLER:
- 15 And...
- 16 SENATOR PARTEE:
- 17 It seems to me that the Act we are considering came by
- 18 Executive Order or it just fell like manna from heaven.
- 19 It didn't happen that way at all. The bill we're considering
- 20 on the question of the RTA was a bill which had the approba-
- 21 tion of majority of the people in that district, and what
- 22 you say, Senator, sounds to me like the man who once said -
- 23 "I refuse to be bludgeoned into acquiescence by the mere will
- 24 of the majority". The majority is the one...or the majority
- 25 made this decision based on the law as it was constructed
- 26 with its many, many components. The law is not a easy simple
- 27 kind of bill. It is a very complexed kind of action. I'm
- 28 given to understand that the amendment which has been offered
- 29 contains some twenty pages and I am given to understand that
- 30 many of you who are speaking in favor of taking it from the
- 31 committee to bring it to the Floor are not familiar with all
- 32 of its contents. But, what you're saying really is that you're
- 33 not concerned about the committee system, nor the sanctity of

ı. the committee system, and harkening back to my initial days 2. in this Senate, there were many, many hills that I sought 3. to take from the License and Miscellany Committee then 4. headed by my friend, Senator Ozinga, and I can remember his 5. speeches that I was very much impressed with them about the 6. sanctity of the committee system, and the committee system 7. is the system where we have the opportunity to examine these 8. proposals in some detail to make certain that there are 9. amendments offered and that there are deletions made so that 10. it can be a good and salutary piece of legislation. 11. over he said that the people who are involved, both positively 12. and negatively on the question, ought to have a right to 13. give their opinions. By this action to take this bill from 14. the committee you're going to deny those same people the 15. right to say what they feel should be about the bill. I do 16. not think that any bill is in granite. As a matter-of-fact, 17. I think life itself in progression demands reexamination 18. from time to time of any American institution or any American 19. Hence, you are certainly within your rights to 20. offer another bill or an amendment to the bill consistent to 21. what you think circumstances are at the present moment. 22. certainly it ought to be done in a more reasonable and a more 23. logical fashion than to just snatch a twenty-four page bill 24. from a Calendar...from a committee and commence to hear it on 25. Thereby, in a Session with as brief as time as is 26. left, obligating a large portion of the time which should be 27. spent on matters relating to Revenue and Welfare for which we 28. are here in Appropriations should be heard. So, I suppose the 29. die is cast. The political arrangements have been struck and 30. I suppose that's the way it's going to be, but I suggest to 31. you that you are flying in the face of what you have always 32. said was another proper course of action. 33. PRESIDING OFFICER: (SENATOR DONNEWALD)

3. Thank you, Mr. President and members of the Senate. 4. I just want to speak briefly on this motion to discharge 5. the Committee on Assignment of Bills relative to Senate Bill 6. 1977. About two and a half months or so ago, Mr. President, 7. there was a new commissioner appointed to the RTA that re-8. sides within my district. I have had numerous conversations 9. with him relative to the operation of the district. 10. experiences that he has incurred, the tyranny that was ex-11. pressed by the Chairman of the Board, Mr. Pikarsky and the 12. problems generally that they as commissioners from the area 13. outside of the City of Chicago were experiencing in the day 14. to day activities of the RTA. I don't think I have to go into 15. the question of appointment of employees or attorneys or pur-16. chase of service contracts and so forth that should rightfully 17. belong to the Board. I think those questions are adequately 18. covered in Senate Bill 1977 that will definitely improve the 19. operation of the RTA. I'm informed, Mr. President, that about 20. or in excess of two-thirds of the revenue to support the RTA 21. comes from outside of the City of Chicago. In other words, it 22. comes from suburban Cook County and the five collar counties, 23. but seventy percent of that money is spent to assist and sub-24. sidize the CTA in the City of Chicago and on occasion they 25. run a few spur lines out to us in the suburbs that try to 26. pacify us. And I think we're being a little unfair in the 27. imbalance of revenue, insofar as the amount of monies that are 28. spent for we in suburban Cook County and in the collar counties. 29. I think that Senate Bill 1977 properly addresses itself to 30. this problem and I totally concur with the motion to discharge 31. the Committee on the Assignment of Bills from further considera-32. tion of Senate Bill 1977 and have it placed upon the order of 33. 2nd reading.

Well, Mr. President, I don't usually talk on these bills and I'm not that familiar with this bill, but as you all know the President just mentioned my name about the sanctity of committee. Okay, you know that as long as I have been around this place I've always recognized and always eulogized the committee system. However, this particular motion, this particular bill as you know was passed out of the committee with a majority of the votes. It is a committee bill. the Floor now for a matter of assignment to committee. This bill, as it was, as it was started with the RTA way back when and I don't intend to get in on the merits of the bill. all know that I was on that committee. I was on it until the last year of its survival, at which time I have often had my queries with regard to the present situation as is now existing, and I think the quicker we get at this matter, the quicker we amend this whole situation and get the thing before the proper authorites so that we can pass on it and get it back to the communities where it will be properly acted on again, I would respectfully say let's take it from committee now and let's get to the matter of voting on the bill.
