16. television decoder situation where the television programs
17. would also be related with the...the hand language so the students
18. could also learn. The Senate sponsor of the bill stated he had
19. no objection and if there are any...not any questions, I'd

17. in Canteen Township and I would appreciate a favorable vote.

3. City of Bartonville for use, presumably, as a library. It
4. had every other possible use in there for recreation and
5. otherwise, but for some reason, public library was left out in the
6. bonding of...the bonding people have refused to approve
7. the bonds without that language being in the Act. This is an
8. amendment to that Act, to provide that the land that was so sold
9. or transferred can be used for public library purposes.

3. 1947 for U.S. Route 40 which is now been located in
4. another place. The...it involves approximately three thousand
5. eighty-two square feet at a fair market appraised value today of
6. one hundred and fifty dollars.

8. Is there any discussion? If not, the question is shall
9. House Bill 3242 pass. Those in favor will vote Aye. Those
10. opposed will vote Nay. The voting is open. Have all voted who
11. wish? Have all voted who wish? Take the record. On that
12. question the Ayes are 54, the Nays are none, none Voting Present.
13. House Bill 3242 having received the required constitutional
14. majority is declared passed. House Bill 3244, Senator Bruce.

27. current fair market value of five hundred and seventy-five
28. dollars for vacation of an easement.

31. Bill 3244 pass. Those in favor will vote Aye. Those opposed
32. will vote Nay. The voting is open. Have all voted who wish?
33. Have all voted who wish? Take the record. On that question the

2. 3244 having received the required constitutional majority
3. is declared passed. House Bill 3245, Senator Bruce. Read the bill.

14. one thousand three hundred to the two pieces and I would move
15. favorable consideration of the bill.

18. Bill 3245 pass. Those in favor will vote Aye. Those opposed
19. will vote Nay. The voting is open. Have all voted who wish?
20. Have all voted who wish? Take the record. On that question

22. House Bill 3245 having received the required constitutional
23. majority is declared passed. For what purpose does Senator Harber
24. Hall arise?

26. Mr. President, on a point of personal privilege. We have
27. in the gallery...gallery immediately to my rear, Mr. and Mrs.
28. Popus. Takey and Ruth have been businesspeople in Bloomington
29. for many years and they're my good friends and they have with
30. them and we're honored to have him, Mr. Popie Vanopolous from
31. Athens, Greece. He is the manager of Abbott Laboratories
32. in that country and he's here looking into our governmental system.
33. And I'd like to have them stand and be recognized if they will.

2. Will our guests please rise. On the Order of House Bills,
3. 3rd reading, House Bill 3246, Senator Buzbee. Read the bill.

10. SENATOR BUZBEE:
11. Thank you, Mr. President. This vacates an easement in
12. Perry County of .56... .56 acres for three hundred dollars.
13. This is an administration easement bill. The three hundred
14. dollar value was established by an appraisal in November of last
15. year. The land was acquired in 1921 for one dollar and I would
16. move...I would ask for a favorable roll call.
17. PRESIDENT:
18. Is there any discussion? If not, the question is shall
19. House Bill 3246 pass. Those in favor will vote Aye. Those
20. opposed will vote Nay. The voting is open. Have all voted who
21. wish? Have all voted who wish? Take the record. On that
22. question the Ayes are 48, the Nays are none, none Voting Present.
23. House Bill 3246 having received the required constitutional
24. majority is declared passed. House Bill 3248, Senator Buzbee.
25. Read the bill.
26. SECRETARY:
27. House Bill 3248.
28. (Secretary reads title of bill)
29. 3rd reading of the bill.
30. PRESIDENT:
31. Senator Buzbee.
32. SENATOR BUZBEE:
33. Thank you, Mr. President. This authorizes the Secretary of

1. the Department of Transportation to convey by quick claim deed
2. for one dollar title on .45 acres to the City of Carbondale.
3. If the city ever ceases to use the land as an open space buffer
4. between a subdivision and FA Route 14, the land shall
5. revert to the State upon demand of the Secretary. And I would
6. ask for a favorable roll call.

7. PRESIDENT:

8. Is there any discussion?

9. SENATOR BUZBEE:

10. Oh, Mr. President, one other thing.

11. PRESIDENT:

12. Senator Buzbee.

13. SENATOR BUZBEE:

14. There is also an amendment that was put on by Senator Wooten
15. correcting a 1966 error in which an employee of the City of
16. Moline inadvertantly named the State of Illinois as the grantee
17. of the conveyance deed. Actually, the correct grantee was the City
18. of Moline. The Department of Transportation and the City of
19. Moline are in agreement with the amendment and Senator Wooten
20. was using my bill as a...as a vehicle after this was discovered
21. and I would ask for a favorable roll call.

22. PRESIDENT:

23. Is there any discussion? If not, the question is shall House

2. Senator Sommer.

3. SENATOR SOMMER:

4. Mr. President and members, this conveys back property that was
5. required to build Route 150 which was ultimately bypassed by
6. Interstate 74 and therefore, the holding of the property
7. is obsolete and it's subject to having been appraised and whatnot.

8. PRESIDENT:

9. Is there any discussion? If not, the question is shall House
10. Bill 3249 pass. Those in favor will vote Aye. Those opposed
11. will vote Nay. The voting is open. Have all voted who wish?
12. Have all voted who wish? Take the record. On that question the
13. Ayes are 51, the Nays are 3, none Voting Present.
14. House Bill 3249 having received the required constitutional
15. majority is declared passed. House Bill 3253, Senator Shapiro.

32. favorable roll call.

33. PRESIDENT:

1. Is there any discussion? If not, the question is shall House
2. Bill 3256 pass. Those in favor will vote Aye. Those
3. opposed will vote Nay. The voting is open. Have all voted who
4. wish? Have all voted who wish? Take the record. On that
5. question the Ayes are 52, the Nays are 1, none Voting Present.
6. House Bill 3256 having received the required constitutional
7. majority is declared passed. House Bill 3362, Senator Graham.
8. Read the bill.

12. 3rd reading of the bill.

13. PRESIDENT:

14. Senator Graham.

15. SENATOR GRAHAM:

16. Mr. President, CDB's involvement in the building of the
17. new Schaumburg High School makes it necessary that this bill
18. pass so that this land can be conveyed for the widening
19. of Schaumburg road and I ask for a favorable roll call.

20. PRESIDENT:

21. Is there any discussion? If not, the question is shall
22. House Bill 3362 pass. Those in favor will vote Aye. Those
23. opposed will vote Nay. The voting is open. Have all voted
24. who wish? Have all voted who wish? Take the record. On that

28. SENATOR ROCK:

29. Thank you, Mr. President. While we have this momentary
30. lull before we get back to Senator Bruce's bill, I would like to
31. introduce to the members of the Senate a few people
32. from the great 19th Ward, supposedly great 19th Ward,
33. George and Rose Bilecky and their children. They are
34. accompanied by the wife of our President, Judy Hynes.

17. 3rd reading of the bill.
18. PRESIDENT:
19. Senator Bruce.
20. SENATOR BRUCE:
21. Thank you, Mr. President. This bill...bill deals with
22. a problem that's been created by the Bureau of the Budget
23. in an objection they have...to the procedure of the Capital
24. Development Board paying bond funds for community college
25. buildings that have already been constructed. These were all
26. projects approved by the Board of Higher Education and
27. constructed under the rules and regulations of the Capital
28. Development Board. Many of the community colleges throughout
29. the State have done this since 1972. There are four...and we have
30. actually paid for those buildings after they have been built with
31. local funds by a reimbursement procedure using Capital
32. Development Board Bond Funds. And objection has been raised by the counsel
33. for the Bureau of the Budget, after this program has been in effect

1. many years and four projects are presently outstanding for
2. which reimbursement should...is now sought and should be paid,
3. for the College of DuPage, the Lake County College, for the
4. Oakton College and Lewis and Clark Community College.
5. I know of no objection. All these buildings have been approved
6. by the Board of Higher Education, by the Illinois Community
7. College Board and approved by the Governor for funding. I would
8. ask for a favorable vote on House Bill 2798.

9. PRESIDENT:

10. Is there any discussion? If not, the question is shall House
11. Bill 2798 pass. Those in favor will vote Aye. Those opposed
12. will vote Nay. The voting is open. Have all voted who wish?
13. Have all voted who wish? Take the record. On that question
14. the Ayes are 52, the Nays are none, 1 Voting Present.
15. House Bill 2798 having received the required constitutional
16. majority is declared passed. Resolutions.

17. SECRETARY:

18. ...Resolution 433, offered by Senator Davidson and all Senators.
19. It's congratulatory.

20. Senate Resolution 434, offered by Senator Davidson and all
21. Senators. It's congratulatory.

22. Senate Resolution 435, offered by Senator Savickas, Lemke,
23. Daley, and others and it's congratulatory.

24. PRESIDENT:

25. Consent Calendar.

26. SECRETARY:

27. Senate Joint Resolution 97, offered by Senators Nimrod,
28. Harber Hall, Mitchler and others.

29. PRESIDENT:

30. Executive. Is there any further business to come before
31. the Senate? For what purpose does Senator Bloom arise?

32. SENATOR BLOOM:

33. While we're on the Order of Resolutions, I wonder if I could

1. move 370. Senator Buzbee and I have that.

2. PRESIDENT:

3. Senator, we have other requests for resolutions on the Secretary's
4. Desk and I think we ought to go to them all at one time.

5. SENATOR BLOOM:

6. Whatever...

7. PRESIDENT:

8. And I think the appropriate time is probably tomorrow.

9. SENATOR BLOOM:

10. Thank you.

11. PRESIDENT:

12. Is there any further business to come before the Senate?
13. Senator Chew is recognized for the purpose of an announcement.

14. SENATOR CHEW:

15. Mr. President, I'd like to announce that
16. Committee on Health and Welfare would like to assemble
17. immediately after adjournment for a meeting in 400.
18. It's going to be a rather lengthy meeting and the quicker
19. we get started, the better off we are.

20. PRESIDING OFFICER: (SENATOR BRUCE)

21. For what purpose does Senator Newhouse arise?

22. SENATOR NEWHOUSE:

23. Mr. President, I'd like to seek leave of the Senate to
24. ...to alter the sponsorship of House Bill 3296. That
25. should read Newhouse - Joyce.

26. PRESIDING OFFICER: (SENATOR BRUCE)

27. Is there leave? Leave is granted. Senator Johns.

28. SENATOR JOHNS:

29. Mr. President, with leave of the Senate, I'd like to join
30. in cosponsorship with Lemke, Vadalabene on House Bill 1740. 1470.

31. PRESIDING OFFICER: (SENATOR BRUCE)

32. Is there leave? Leave is granted. For what purpose does
33. Senator Hynes arise?

1. SENATOR HYNES:

2. For the purpose of an announcement, Mr. President.

3. The pages are now distributing the schedule for the next
4. two weeks and as you can see from that schedule, it will be a
5. very busy period of time. We are scheduled to be in Session
6. from Monday, June 19th straight through until the end and that
7. is set for Friday, June 30th. So, with the cooperation of everyone,
8. we may well be able to wind up this Session by the 30th of
9. June. Secondly, a memorandum is being distributed which
10. modifies our schedule for Thursday of this week and you will
11. notice that the Session on Thursday will begin at 9:00 a.m.
12. Appropriations II, Chaired by Senator Buzbee, will begin at
13. 10:00 a.m. and simultaneously, there will be meetings of the
14. committee to draft the proposal for the personal property
15. tax amendment in Room 400 and a...the committee against the
16. personal property tax amendment. So, those Constitutional
17. Amendment Committees will meet also on Thursday morning
18. at 10:00 and 11:00 a.m., respectively. And at 12:00
19. noon, there is a dedication of the underground parking
20. facility for the information of the membership. So, the Session
21. will begin at 9:00 a.m. on Thursday. It is our intention that that
22. Session will be of a very limited nature. It will involve the
23. receipt of Conference Committee Reports, the adoption of the
24. resolutions, the Consent Calendar and other matters of a non-
25. controversial nature. And with that, Mr. President, I would
26. close by announcing that there will be a meeting of the Senate
27. Operations Committee in the President's Office immediately
28. upon adjournment.

11. am chairing. I would like to know if there is any input or
12. comments to be made by any members of the Senate, to please
13. let us know before Thursday so if they want to be heard or
14. discussed...discuss anything while we're meeting, that they
15. bring it up before so we can be prepared so we can have a more
16. orderly meeting at that time. So, I'm giving that announcement
17. at this...at this time for everyone to hear while...since the
18. President brought up the remarks about our meeting.

19. PRESIDING OFFICER: (SENATOR BRUCE)

20. Further discussion? Further announcements? Senator Buzbee
21. moves that the Senate stand adjourned until the hour of
22. 12:00 o'clock tomorrow. Is there any discussion? All in favor
