PRESIDING OFFICER: (SENATOR HALL)

PRESIDING OFFICER: (SENATOR HALL)

For what purpose does Senator Rupp arise?

SENATOR RUPP:

A point of personal privilege, Mr. President.

PRESIDING OFFICER: (SENATOR HALL)

State your point.

SENATOR RUPP:

In the gallery to the rear is a group of ladies from

Macon County Republican Women's Club. They're led by Pat Cribbit, the president. I ask that the Senate recognize their presence.

PRESIDING OFFICER: (SENATOR HALL)

Will the guests in the galleries please rise and be recognized. For what purpose does Senator Etheredge arise?

SENATOR ETHEREDGE:

Mr. President and Ladies and Gentlemen of the Senate, I have some visitors down from my legislative district. I would like to introduce Linda Rivers who's a precinct committeewoman in Geneva, Illinois, who's in the President's gallery with her sister Jenny Shearing. I would like for them to rise and be recognized.

PRESIDING OFFICER: (SENATOR HALL)

Will our guests please rise and be recognized by the Senate. Okay. For what purpose does Senator Bloom arise?

SENATOR BLOOM:

Thank you, Mr. President. I arise to seek to discharge the Committee on the Executive from further consideration of House Bill 956 and transfer it to Public Health where it more properly belongs. It's a Purchase Care Review Board bill. Could I seek leave of the Body to do that? I'm not moving it, I just...I think it will rest more comfortably there.

PRESIDENT:

Senator Bloom seeks to discharge the Committee on Executive from further consideration of House Bill 956 and asks that the bill be rereferred to the Committee on Public Health. Is leave granted? Leave is granted. Senator Joyce.

SENATOR JEREMIAH JOYCE:

Mr. President, I seek leave of the Body to withdraw as sponsor of House Bill 1373.

PRESIDENT:

1373. You just wish to withdraw? Is there anybody you're going to...

SENATOR JEREMIAH JOYCE:

No, I don't know how...how I ever became the sponsor.

PRESIDENT:

Alright. Senator Joyce seeks leave to withdraw as Senate sponsor of 1373. Is leave granted? Leave is granted. If I can have the attention of the membership. We have some special guests in the Senate today and the Chair will yield to Senator Maitland.

SENATOR MAITLAND:

Thank you, very much, Mr. President and Ladies and Gentlemen of the Senate. I am honored once again this year, as I have been in the past, to introduce to you the 1983 Illinois 4-H Report to the State Team. This fine group of young men and women are selected from among the hundred and fifty thousand 4-H'ers across this State and are indeed outstanding 4-H members. And they are in Springfield today to show you and all of us what outstanding people are involved in the 4-H program in this State. Let me introduce to you their names and the counties that they're from. David...and please raise your hands when we...when I get to your name, okay? David Bruckhausen from Union County, Lori Butler from Vermillion County, Randy Crumpton from Cook County, Debra Huber from Montgomery County, Cara Sleeter from McLean County, Kim Skeevy from Whiteside County, Todd Smith from Morgan County and David Webber from Madison County. Yesterday, this Body passed a resolution out of here congratulating the 4-H program in the State of Illinois. And to receive that resolution this afternoon for all the 4-H members in the State is Todd Smith and, Todd, let me present to you this resolution and ask you just to say a few words.

TODD SMITH:

SENATOR MAITLAND:

Todd, thank you, very much, and to the entire team, thank

you, very much, for joining us today, and thank you, very much, members.

PRESIDING OFFICER: (SENATOR BRUCE)

(Machine cutoff)...Nedza, do you have an...announcement on House Bill 345? Senator Nedza.

SENATOR NEDZA:

Yes, thank you, Mr. President. I'd move to discharge the Committee from Executive from hearing House Bill 345 and have it reassigned to the Committee on Local Government for immediate consideration.

PRESIDING OFFICER: (SENATOR BRUCE)

You've heard...you've heard the request as to House Bill 345. Is there leave? Leave is granted. The bill will be...discharged and reassigned. Committee reports.

SECRETARY:

(Machine cutoff)...Barkhausen on the Floor? (Machine cutoff)...Mahar, there is a Message from the House concerning your bill. Are you ready to go to that order? Is there...Message from the House.

SECRETARY:

A Message...a Message from the House, Mr. O'Brien, Clerk.

Mr. President - ...

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Mahar.

SECRETARY:

...I am directed to inform the Senate the House of Representatives has refused to recede from their Amendments 1 and 2 to a bill with the following title:

Senate Bill 328.

And that the House further directs that they have a Committee of the Conference, and the Speaker has appointed the members on the part of the House.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Mahar.

SENATOR MAHAR:

Yes, thank you, Mr. President. I'd move...move to accede to the request of the House to have a Conference Committee...appointed.

PRESIDING OFFICER: (SENATOR BRUCE)

Alright. You've heard the motion, is...that we accede to the request of the House and that a Committee of Conference be appointed. On the motion, those in favor say Aye. Opposed Nay. The Ayes have it. The Senate does accede to the request of the House and a Committee of Conference will be appointed. Resolutions.

SECRETARY:

The following two resolutions are congratulatory:

Senate Resolution 225, Senator Etheredge.

PRESIDING OFFICER: (SENATOR BRUCE)

Consent Calendar. Is there leave to go to the Order of House Bills 1st Reading? Leave is granted. House bills 1st reading. Senator Nedza, for what purpose do you arise?

SENATOR NEDZA:

...for the...purpose of...thank you, Mr. President. For

the purpose of...waiving the Six-day Notice for a series of bills.

PRESIDING OFFICER: (SENATOR BRUCE)

Alright, you...are you going to supply that list to the Secretary in a moment?

SENATOR NEDZA:

Yes.

PRESIDING OFFICER: (SENATOR BRUCE)

We want to read them for the record, but we'll...if you'll supply it we won't have to write so fast.

SENATOR NEDZA:

Alright, it's...

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Nedza.

SENATOR NEDZA:

...House Bill 1051, 1124, 1409 and 1610, 1788, 1842 and 2046.

PRESIDING OFFICER: (SENATOR BRUCE)

And that is to waive the Six-day Posting Notice that they might be heard when, Senator?

SENATOR NEDZA:

They'll be heard tomorrow at two o'clock in Room A-1.

PRESIDING OFFICER: (SENATOR BRUCE)

You've heard the motion on...on the bills listed by Senator Nedza. Is there leave to waive the Six-day Posting Notice that they might be heard tomorrow? Leave is granted. Alright, if I might have the attention of the Body, we have...another distinguished group. We have Mr. Pat Bosco, executive director and Lou...Handler, president of the Illinois State Bowling Proprietors' Association to give an award to one of our members.

MR. LOU HANDLER:

(Comments made and award presented by Mr. Handler)

SENATOR KELLY:

Thank you, very much for this, I'm very proud of it. I'd like to point out to the members of this Senate that I was able to have a higher score than all the members of the House, and I hope that sets a precedent when the baseball game comes up. And I just want to say thank you to the association. I always look forward to you coming down here, Pat and Lou, and thank you, very much, Mr. President and members of the Senate.

PRESIDING OFFICER: (SENATOR BRUCE)

House bills 1st reading.

SECRETARY:

House Bill 1396, Senator Jeremiah Joyce is the Senate sponsor.

(Secretary reads title of bill)

1409, Senator Grothberg.

(Secretary reads title of bill)

1708, Senator Degnan.

(Secretary reads title of bill)

1864, Senator Savickas

(Secretary reads title of bill)

2123, Senator Macdonald.

(Secretary reads title of bill)

1st reading of the bills.

PRESIDING OFFICER: (SENATOR BRUCE)

(Machine cutoff)...the members that are sponsor of those five House bills just read, you might want to take a look at them and see whether or not you plan to hear them, because it's getting late in the week. Senator Etheredge, for what purpose do you arise?

SENATOR ETHEREDGE:

Mr. President, I have an announcement that I would like to make for the...benefit of the membership. House Joint Resolution No. 22 organized a committee to consider the pos-



sibility of consolidating the alcoholism and drug abuse programs of the State. This committee has scheduled two hearings for next week. The first hearing is in Chicago on Monday morning at 10 a.m. in the State of Illinois Building, and the second hearing will be held here in Springfield on Tuesday, June 14th at 10 a.m. in the Capitol Building in Room 114.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Macdonald, for what purpose do you arise?

SENATOR MACDONALD:

I...I'm sorry, I didn't hear what you said about those five House bills that we might want to look at them to...what was the purpose?

PRESIDING OFFICER: (SENATOR BRUCE)

Well, tomorrow is our last day for committee; and once we go out of Session today, if those were going to be heard in committees tomorrow, you would have to make the motion to waive the Six-day Posting Notice on those bills once assigned to committee. So, you may want to talk to Senator Savickas very quickly to indicate where the bill is going to be assigned and make the appropriate motion, but you'll have to do that before we adjourn, and that is almost immediately. Senator Grotberg, for what purpose do you arise?

SENATOR GROTBERG:

Thank you, Mr. President. On that same issue as regards House Bill 1409 just read...just read into the record. I would like to suspend the...have leave to suspend the Six-day Posting period and have heard...

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Grotberg...Senator...it has not been assigned yet. We can't do anything till it's assigned. That's what I'm saying.

SENATOR GROTBERG:

Assign it now.

PRESIDING OFFICER: (SENATOR BRUCE)

Well.

SENATOR GROTEBERG:

Local Government, okay? I just talked to Savickas.

PRESIDING OFFICER: (SENATOR BRUCE)

Well, it's got to be read into the record. If...if it's done, we'll...

SENATOR GROTEBERG:

He just read it.

PRESIDING OFFICER: (SENATOR BRUCE)

I think they've given you a new bill, Senator. Senator D'Arco, for what purpose do you arise?

SENATOR D'ARCO:

These bills were assigned to the Insurance Committee, so I would ask for leave to waive the Six-day Posting requirement on House Bill 883, 1048, 2232, 1374, 1492, 1611, 1707 and 2267. And to be heard today...I might as well make this announcement now. The Senate Insurance Committee will meet today on the Senate Floor at 2:30 p.m. It was originally scheduled for five, but we're going to meet on the Senate Floor at 2:30 p.m. today.

PRESIDING OFFICER: (SENATOR BRUCE)

Alright. Senator D'Arco, will you bring your list down, please. Senator D'Arco, would you provide us the list too. You've heard the motion to hear the bills listed by Senator D'Arco. Is there leave? Leave is granted. The bills will...we have waived the Six-day Posting Notice and the bills may be heard today in the Insurance Committee. (Machine cutoff)...Senator Geo-Karis arise?

SENATOR GEO-KARIS:

I...Mr. President, I...members of the Senate, I'd like to have leave to transfer House Bill 1287 from Executive to Public Welfare for tomorrow. I have the clearance from the chairman of Executive on that.

PRESIDING OFFICER: (SENATOR BRUCE)

Alright, the motion is to discharge the Committee on Executive from further consideration of 1287, House bill, and the bill be referred to Public...Public Health, Welfare and Corrections. On the motion, is there leave? Leave is granted. The bill is discharged and rereferred from Executive to Public Health and Welfare, and to be...and there is leave to have it be heard tomorrow. Senator...Senator Savickas.

SENATOR SAVICKAS:

Well, on that...well, Senator Geo-Karis, I think there was a vote on that bill and it was voted Do Not Pass.

PRESIDING OFFICER: (SENATOR BRUCE)

For what purpose does Senator Kenneth Hall arise?

SENATOR HALL:

Well, I've been asked to pickup House Bill 820. House Bill 820. First...be on the first...it's on the Calendar.

PRESIDING OFFICER: (SENATOR BRUCE)

Alright, read the bill, Mr. Secretary.

SECRETARY:

House Bill 820, Senator Hall is the Senate sponsor.

(Secretary reads title of bill)

1st reading of the bill.

PRESIDING OFFICER: (SENATOR BRUCE)

Senator Lemke, for what purpose do you arise?

SENATOR LEMKE:

While we're waiting here, I'd like to have leave to...on House Bill 1847 to show the sponsorship Lemke-DeAngelis-Sangmeister.

PRESIDING OFFICER: (SENATOR BRUCE)

Alright. Senator Lemke, who's the principal sponsor now?

SENATOR LEMKE:

I am.

PRESIDING OFFICER: (SENATOR BRUCE)

Alright. So...Senator Lemke is asking leave to...on House Bill 1847 to add Senator...Senator DeAngelis and Senator Sangmeister. Is there leave as hyphenated cosponsors? Leave is granted. May we have some order, please. (Machine cutoff)...purpose does Senator Lemke seek recognition.

SENATOR LEMKE:

Leave to show the sponsorship on House Bill 1239 Lemke-Geo-Karis.

PRESIDING OFFICER: (SENATOR BRUCE)

Is there leave? Leave is granted. (Machine cutoff)...reports.

SECRETARY:

Senator Savickas,...chairman of Assignment of Bills Committee assigns the following bills...House bills to committee: to Executive Committee - House Bill 820; Higher Education - 2123; Local Government - 1409; Public Health, Welfare and Corrections - 1708; Revenue - 1864 and 1396.

PRESIDING OFFICER: (SENATOR BRUCE)

Alright, if I might have your attention, the Assignment on...of...Committee on Assignment of Bills has reported the bills, and Senator Savickas would ask leave to waive the Six-day...do you have the bills in front of you, Senator? Senator Savickas.

SENATOR SAVICKAS:

Yes, Mr. President and members of the Senate, I would move to waive the Six-day Posting Notice in order that House Bills 820, 1396, 1409, 1708 and 2123 can be heard in the respective committees that they were just assigned.

PRESIDING OFFICER: (SENATOR BRUCE)

Alright, and 1864 also, Senator?

SENATOR SAVICKAS:

And 1864.

PRESIDING OFFICER: (SENATOR BRUCE)

Alright, those are the bills just assigned. Is there

leave that the Six-day Posting Notice be waived that those bills might be heard in the committees to which they have just been assigned? Leave is granted. Senator Savickas.

SENATOR SAVICKAS:

And since Executive Appointments is not meeting, could we...I would move that we reassign House Bill 1933 from Executive Appointments to Executive and waive the Six-day Posting Notice. Also, House Bill 1089, after talking to the sponsors and to the committee chairmen, both committee chairmen, they seek leave to transfer House Bill 1089 from Revenue to Transportation and waive the posting notice.

PRESIDING OFFICER: (SENATOR BRUCE)

Alright, the motion is to discharge House Bill 1933 from the Committee on Executive Appointments and reassign it to the Committee on Executive, and House Bill 1089 from the Committee on Revenue that it be reassigned to the Committee on Transportation. Is there leave for the bills to be discharged and reassigned? Leave is granted. (Machine cut-off)...purpose Senator Degnan arise?

SENATOR DEGHAN:

Yes, thank you, Mr. President. I'd like to announce that the Finance Subcommittee on House Bill 663 will convene at two o'clock in Room 122-B in this building. As a result of that, the Elections Committee scheduled for two o'clock will be postponed till three o'clock. So, Elections will start at three o'clock in A-1 in the Stratton Building.

PRESIDING OFFICER: (SENATOR BRUCE)

I hope the Election Committee members heard. The...the committee is being postponed until three o'clock. For what purpose does Senator... (Machine cutoff)...we have one resolution. Resolution.

SECRETARY:

Senate Resolution 226 offered by Senator Jerome Joyce, it's congratulatory.

PRESIDING OFFICER: (SENATOR BRUCE)

Resolution Consent Calendar. Senator Barkhausen. Senator Barkhausen, you filed a motion for a request for a fiscal note; and under the Statute, that must be done in the house of origin. And so, unless you wish to do battle on it, the...the Statute is clear that it...the fiscal note requirement must be filed in the...in the house of origin. So, Senator Barkhausen.

SENATOR BARKHAUSEN:

Okay, I'm...I'm obviously new here. I had a fiscal note filed on one of my Senate bills over in the House, so I guess I should answer their request for a fiscal note the same way.

PRESIDING OFFICER: (SENATOR BRUCE)

Well, it just shows you that we do our business better than they do. Senator Geo-Karis.

SENATOR GEO-KARIS:

Mr. President and Ladies and Gentlemen of the Senate...on a point of personal privilege. Talking to Senator Margaret Smith, is Mayor Bobby Thompson from North Chicago, who...from my constituency, and up in the gallery is Sandra Moon from Wadsworth, and Roseann Rendl, R-E-N-D-L, from Avon Township. They're our friends from Lake County and I'd like to ask you to welcome them.

PRESIDING OFFICER: (SENATOR BRUCE)

Welcome to the Illinois Senate. Happy to have you here. Resolutions.

SECRETARY:

Senate...Senate Resolution 227 and 228 offered by Senator Berman.

PRESIDING OFFICER: (SENATOR BRUCE)

Resolutions Consent Calendar. Senator Netsch.

SENATOR NETSCH:

Thank you, Mr. President. A...an announcement to the Revenue Committee members and all of you, which includes

almost all of you, who have bills in the Revenue Committee, we will meet at two o'clock in Room 400. There is an agreed bill...a proposed agreed bill list. There have been no objections to date. It will be posted outside of the hearing room; in fact, it is posted there right now. If your bills are on that list, you may assume that you do not have to stay for the hearing. There is also a short debate list, so-called, bills which should not take a large amount of time. They will be taken first and then the full debate list will be taken last. So, if you want to know when you are likely to have to be on deck at Revenue, if you will look at that list, it will give you a pretty good idea. Thank you.

PRESIDING OFFICER: (SENATOR BRUCE)

And where is the...where is the list, Senator?

SENATOR NETSCH:

The list will be...is already posted outside of Room 400 where we will be meeting. I also have a copy on the Floor with me.

PRESIDING OFFICER: (SENATOR BRUCE)

Alright. Senator Luft and then Senator Buzbee.

SENATOR LUFT:

Thank you, Mr. President. Inadvertently my name was put on as chief sponsor of House Bill 1520 and that should be Senator Darrow.

PRESIDING OFFICER: (SENATOR BRUCE)

On 1520 the lead sponsor should indicate Senator Darrow as opposed to Senator Luft. Is there leave to make that transfer? Leave is granted. Senator Buzbee.

SENATOR BUZBEE:

Thank you. I just wanted to announce that the Appropriations II Committee will meet at two o'clock in Room 212. We only have three bills but they're biggies. They're DMHDD and Corrections. So, we'll start at two, hopefully be out by five.

PRESIDING OFFICER: (SENATOR BRUCE)

Further announcements? Senator Rock.

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. If I can have the attention of the membership.

PRESIDING OFFICER: (SENATOR BRUCE)

May we have your attention, please. Senator Rock.

SENATOR ROCK:

The committee schedule has been lengthy and is lengthy and will be tomorrow, but it appears...and I have spoke...conferred with Senator Philip, it appears it will not be necessary for us to be in Session on Friday. I'm sure that...unless everybody wants to, then we can certainly stay. Yeah, there's one. So, that I hope that the committee chairmen and minority spokesmen will bear that in mind, that we would like to conclude the committees' business on Thursday so that we can afford ourselves the opportunity to visit our districts on Friday and Monday, and we will return to Springfield next Tuesday to again commence the people's business. In the meantime, I think, again, given the heavy schedule this afternoon, to afford the members an opportunity to have some lunch, I would move that we stand adjourned until noon tomorrow.

PRESIDING OFFICER: (SENATOR BRUCE)

Any further business to come before the Senate? Motion is that the Senate stands adjourned till noon tomorrow. On the motion to adjourn, those in favor say Aye. Opposed Nay. The Ayes have it. The Senate stands adjourned until twelve o'clock noon tomorrow.
