A Message from the House, Mr. O'Brien, Clerk.

Mr. President - I am directed to inform the Senate that the House of Representatives has adopted the following House joint resolution, in the adoption of which I am instructed to ask the concurrence of the Senate, to-wit:

House Joint Resolution No. 10.

(Secretary reads HJR 10)

PRESIDING OFFICER: (SENATOR DEMUZIO)

...Senator Rock, we're doing House Joint Resolution 10 which is the Joint Session. Senator Rock.

SENATOR ROCK:

Thank you, Mr. President. Ladies and Gentlemen of the Senate, if I can have your attention for just a moment, we have before us House Joint Resolution 10 which calls for the Senate and the House to meet in Joint Session in about fifteen minutes for the purpose of hearing the Governor's address. After that address we will reconvene here in the Senate. We have two or three items of business...copies of which have been distributed to all members. I'd just ask you to take a look at those so that when we come back, it'll be approximately, I suppose, about one o'clock, we can handle our business with dispatch and, hopefully, be on the road, certainly, before three o'clock, more likely before two o'clock. There are motions to change the rules to set up a schedule. Copies of the schedule have also been distributed and the schedule...is a schedule of session days and deadlines, which I'd ask you to pay particular attention to, through the session so that all the members will have an opportunity to make their plans accordingly. I would move, Mr. President and Ladies and Gentlemen of the Senate, that we suspend the rules for the immediate consideration and adoption of House Joint Resolution No. 10 and then we will

shortly, after some more business, convene at the...at the...in the Well of the House and hear the Governor in Joint Session. I would move to suspend the rules and ask for the immediate consideration and adoption of House Joint Resolution No. 10.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, Senator Rock has moved to suspend the rules for the immediate consideration and adoption of House Joint Resolution 10. Discussion? If not, those in favor indicate...whoop, discussion? Senator Geo-Karis.

SENATOR GEO-KARIS:

I...I wonder if I could ask Senator Rock...to just wait a few minutes so...our...our...our minority leader could get here and...and they're on their way here.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Well, he's standing right next to him, Senator Geo-Karis.

SENATOR GEO-KARIS:

Is it okay with you, boss? Okay.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator Rock has moved to suspend the rules for the immediate consideration and adoption of House Joint Resolution 10. Further discussion? If not, those in favor indicate by saying Aye. Opposed Nay. The Ayes have it. Rules are suspended. Senator Rock now moves the adoption of House Joint Resolution 10. Those in favor will signify by saying Aye. Opposed Nay. The Ayes have it. House Joint Resolution 10 is adopted. Senator Hall, for what purpose do you arise?

SENATOR HALL:

A point of personal privilege, Mr. President.

PRESIDING OFFICER: (SENATOR DEMUZIO)

State your point.

SENATOR HALL:

We're...we're honored today by a group of students from

Panama. These students were sent to Lincoln Land College through Washington D.C. on a Federal Grant. It is called the Central American Peace Scholarship. They will study at Lincoln Land College for two or three years...

PRESIDING OFFICER: (SENATOR DEMUZIO)

...pardon me, Senator Hall...pardon me, Senator Hall. Ladies and gentlemen, could we have some order, please. Senator Kustra. Can we have some order, please. Senator Hall.

SENATOR HALL:

These students are from Panama and they're on what is known as a Central American Peace Scholarship. They will study at Lincoln Land College for two or three years and will attend another college somewhere in Illinois. Illinois was chosen by Washington for these students and Illinois is the only state that receive students on this scholarship. So, they have their professor, Nan Kelly, with them and I'd like for the Senate to have them stand and be recognized, and before I do that, I would like to defer to Senator del Valle who wants to greet them.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator del Valle.

SENATOR DEL VALLE:

(Senator del Valle addresses the students in Spanish)

PRESIDING OFFICER: (SENATOR DEMUZIO)

...will our guests in the gallery please rise and be recognized by the Senate. Please rise. Welcome to Springfield. I...I am...Senator Rock, I'm...I'm sure our transcriber is going to have a...a great deal of homework to do this evening. Senator Hall.

The membership of the following standing committees shall be selected by the Committee on Committees, such...such...selection to presented to the Senate for its

approval: Agriculture and Conservation, Appropriations I, Appropriations II, Assignment of Bills, Elementary and Secondary Education, Higher Education, Elections and Reapportionment, Energy and Environment, Executive, Executive Appointments, Veterans' Affairs and Administration; Finance and Credit Regulations, Insurance, Pensions and Licensed Activities; Judiciary, Labor and Commerce, Local Government, Public Health, Welfare and Corrections; Revenue and Transportation.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Rock.

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. The first of two motions in writing which will be presented is an amendment to temporary Rule 7 which will reflect the committee structure as was discussed by Senator Philip and myself. You will notice that Agriculture, Conservation and Energy has been split off because of the obvious workload and a new committee has been created called...Energy and Environment; and in addition, because of request by members, the Judiciary Committee which was formerly Judiciary I and II, there is now a single Judiciary Committee which will be handling all the civil and criminal proposals that come before this Body. I know of no objection and I would solicit a favorable roll call for the adoption of this motion to amend temporary Rule 7 to reflect the committee assignments as agreed upon between Senator Philip and myself.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right, you've heard the motion as posed by Senator Rock. Is there any discussion? All right, Senator Rock has moved...Senator Rock has moved to amend temporary Rule 7 by deleting Paragraphs A and he substituted the following language on the...that has already been read into the record. Those in favor of the motion will vote Aye. Those opposed

will vote Nay. The voting is open.

PRESIDING OFFICER: (SENATOR DEMUZIO)

In odd numbered years the...the following schedule and timetable shall be applicable to all bills; April 10, final day for introduction of bills; May 8, final day for standing committees of the Senate to report Senate Bills including Senate appropriation bills; May 22, final day for reading bills...for 3rd reading and passage of all Senate Bills; June 12, final day for standing committees of the Senate to report House Bills except House appropriation bills; June 13, final day for standing committees of the Senate to report House appropriation bills; June 25, final day for 3rd reading and passage of House appropriation bills; June 26, final day for 3rd reading and passage of all other House bills. In even numbered years all bills introduced in the Senate during the Regular Session shall be read a first time and shall be referred to the Rules Committee.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Rock.

SENATOR ROCK:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. This second motion in writing is a...to an amendment to temporary Senate Rule 5 and it outlines our schedule. I have distributed, and I...I hope all members have on their desk, a copy of the Senate schedule so that we can all make plans accordingly for the ensuing few months. It will outline what the deadlines are and what days we will and will not be in session. I would encourage you to take a look at it and study it. Senator Philip and I met with the House leadership this morning. They have agreed to the same set of

deadlines that we have and so we expect the Houses will be at least in that respect...acting in concert so that we will all be on the same time schedule. I don't know of any objection and I think, by virtue of...the adoption of this motion and the amendment to this rule, that validates the schedule and so we can all plan our next couple of months around our Senate responsibility and I would move for the adoption of this motion to amend temporary Senate Rule 5.

PRESIDING OFFICER: {SENATOR DEMUZIO}

All right, you've heard the motion as posed by Senator Rock. Is there discussion? Again, for the benefit of those who were not in the Chamber earlier, we will have to take an oral roll call since the machine is wired properly, however, the paper that is printed to record you properly has not been printed as of yet. Senator Rock has moved the adoption of this amendment on this motion to temporary Rule 5, which in effect is the schedule. Madam Secretary, would...Senator Davidson, for what purpose do you arise?

SENATOR DAVIDSON:

Inquiry of the Chair...it...would it be possible for a motion to use the previous roll call? I would move that the roll call on adoption of temporary rule prior...immediately prior adopted stand for the motion on this rule.

PRESIDING OFFICER: {SENATOR DEMUZIO}

All right, Senator Rock has moved the adoption of this motion which is the amendment to temporary Rule 5.
