Rules Committee. Senator Smith, for what purpose do you seek recognition?

SENATOR SMITH:

Thank you, Mr. President and members of the Senate. I'd

like to move to discharge the Rules Committee for the purpose of Tabling Senate Bill 1537.

PRESIDENT:

All right. Senator Smith has moved to discharge the Committee on Rules from further consideration of Senate Bill 1537 for the purpose of Tabling. All in favor of the motion to discharge indicate by saying Aye. All opposed. The Ayes have it. The motion carries. Senator Smith now moves to Table Senate Bill 1537. All in favor of the motion to Table indicate by saying Aye. All opposed. The Ayes have it. The motion carries. Senate Bill 1537 is Tabled. All right. Ladies and gentlemen, with leave of the Body, we'll move to the Order of Supplemental Senate Calendar No. 1. The Secretary has informed me that copies of the Conference Committee Reports have been distributed and have been on the desks for a short amount of time. On the Order of Conference Committee Reports is Senate Bill 688. Madam Secretary.

SECRETARY:

First Conference Committee Report on Senate Bill 688.

PRESIDENT:

Senator Poshard.

SENATOR POSHARD:

Yes, thank you, Mr. President, Ladies and Gentlemen of the Senate. Senate Bill 688 makes various changes in the Comprehensive Health Insurance Plan Act. These are...mainly some substantive, technical and clarifying changes. I'll go over these because I think these are important to delineate since some of them are substantive. The CHIP board has identified various changes needed to clarify the Act before it becomes effective on April the 1st of this year. There has been some confusion which exists as the eligibility of those both under sixty-five who are disabled and those over sixty-five who qualify for Medicare, and this amendment attempts to resolve that by authorizing the board to offer

Medicare supplement policy. It clarifies that to be eligible for the Medicare supplement...one must have been rejected for similar insurance by another company. It enumerates circumstances such as death, change to out-of-state residence, request of the enrollee, and so on under which the CHIP coverage ceases including failure to respond within thirty days to an inquiry concerning an enrollee's residence. It clarifies that payment by CHIP for a second surgical opinion shall not be charged to the policyholder's deductible. It clarifies certain circumstances under which CHIP will not pay expenses and I think those are outlined for your...synopsis. It specifically excludes from coverage the cost of hearing aids, contact lenses, routine physical examinations and other items normally excluded from an insurance policy. It eliminates the option for a policy with a two hundred and fifty dollar deductible which was part of the original CHIP plan leaving only two choices, a five hundred or a one thousand dollar deductible. It clarifies that any deductible shall be added to and not included in the maximum out-of-pocket limitation on copayments. The CHIP policy contains a stop loss of fifteen hundred dollars per individual and three thousand dollars per family on out-of-pocket copayments. There are some other...minor technical changes to clarify the intent of the bill but these are basically the substantive changes here.

PRESIDENT:

Discussion? Is there any discussion? If not, the question is, shall the Senate adopt the Conference Committee Report on Senate Bill 688. Those in favor will vote Aye. Opposed vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 50 Ayes, no Nays, none voting Present. The Senate does adopt the Conference Committee Report on Senate Bill 688 and the bill having



received the required constitutional majority is declared passed. Conference Committee Report on Supplemental No. 1 with respect to Senate Bill 897. Madam Secretary.

First Conference Committee Report on Senate Bill 897.

PRESIDENT:

Can the Chair inquire who's going to present this report? The sponsor is not with us. Oh. Conference Committee Report on Senate Bill 897, does anybody wish to present that? Well, if there's no presenter, we're going to move on. Madam Secretary, on the Order of Supplemental...Senator Jones.

Yes,...thank you, Mr. President and members of the Senate. Conference Committee Report No. 1 to Senate Bill 897 would allow a referendum be issued whether or not an elected school board member at large or by a district to appear on the General Election ballot as well as on the regular school election. The purpose of this is to solve a problem out in the south suburb of my district as well as I think Senator Mahar's district...equally as well, and it would allow for that referendum to appear on the ballot this November rather than in 1989 to solve a very serious problem out there. And I move the adoption of Conference Committee Report No. 1. PRESIDENT:
