It got back to the House and. frankly, the feeling of the House was while they agreed, with some reluctance, I might add, but nonetheless agreed that the Senate amendment was a wise idea in terms of keeping the bipartisan nature of this group, they did not feel it...feel that it was important that the Governor's Office of Planning have a vote on this committee. It is exactly the same as...as House Joint Resolution 198 from last Session• as House Joint Resolution 1 which we argued about at some length and passed out of here unanimously with the sole exception that we are saying to the Governor's Office of Planning, you can sit in and...and...and lend your expertise, but you may not vote, and I would ask for a favorable roll call.

Thank you, Mr. President, Ladies and Gentlemen of the Senate. Today has been commemorated by resolution as the day of remembrance for the Holocaust commemoration. A number of us had the privilege of attending a ceremony this morning at eleven o'clock at the Old State Capitol in which we had

clergymen of various faiths, a number of elected officials, the Governor of the State of Illinois who participated In Hebrew this day is known as Yom. memorial service. Hashoah, day of remembrance. I think it's important for who lived during the years of the Second World those of us War to take a moment of our time to remember of man's inhumanity to man, and for those of you who do not remember those days to take a moment to reflect upon one of darkest periods of our history. I am wearing an armband, a yellow armband with the Star of David, it was distributed at the memorial service. It is a tribute not only to the six million Jews who passed away but to the Jews and the non-Jews that were the victims of that terrible period, and a tribute to the non-Jews in particular who wore this armband to protest the treatment that was being inflicted upon the Jewish communities in Europe. I appreciate the time that we have taken, I hope that next year we will make it a point personally invite each of you to attend. It is a very moving ceremony. I apologize for not perhaps making an announcement yesterday so that more of you could have joined us. I know that a number of you have participated with us in the past. It's important. It's just important to remember and never to forget what can happen when we are less than vigilant for the protection of the freedoms that each of us cherish and each of us should have for the other. Let me close this...these short comments by reading a three-line prayer. inscription that was on the walls of a cellar in Cologne, Germany where Jews hid from the Nazis. "I believe in the sun even when it is not shining. I believe in love when feeling it not. I believe in God even when He is silent."
