Basically the bill does two things. The original bill says that if there are...support orders and there is a couple, for instance, from DuPage that have gone to Cook for the divorce, that that support order will then come back to DuPage to be handled by the DuPage clark and vice versa, and this has been agreed to by the Illinois dar Association and the Clerk's Association and all those concerned. The second part of the bill is the Federal portion that we must pass that basically allow...says that support orders from now on in will be automatically...will be judgments...the...judge will no longer be able to, in effect, wipe out the arrearage not only in this state but in other states which will prevent...errant fathers from crossing a state line, going to...another jurisdiction and getting the child support that they owe wiped out. I think it's an excellent bill. I would...strongly urge you to vote for it. It must be signed today and, therefore, I ask for your Ave vote.
