#### SENATOR POSHARD:

Yes, thank you, Mr. President, Ladies and Gentlemen of the Senate. Mr. President, the members of the United Automobile Worker's Local 376 were forced to strike the Colt Firearms Company of Hartford, Connecticut on January 24th, 1986, after the company refused to bargain fairly for a contract. Despite a profit of a hundred and thirty-two million dollars in 1985, Colt Firearms demanded a wage freeze and a reduction in health insurance benefits. The company has now called in strike breakers. In September of 1986, the United Auto Worker's locals unconditional offer to return to work was spurned by Colt Firearms Company, and the Connecticut State Labor Department has now ruled the situation a lockout for the purposes of unemployment insurance. Mr. President, I would urge that the members of this Senate express our solidarity with the striking workers of Colt Firearms Company and call upon Colt to resume bargaining with the union in good faith; and I would further urge that the Illinois Secretary of State, the Department of Corrections and the Department of State Police boycott products of the Colt Firearms Company while the strike continues. I would ask for consent of this resolution by this Body.

PRESIDENT:

All right. The gentleman seeks unanimous consent to have the resolution immediately heard. I assume, Senator Philip, that's going to be...Senator Philip.

## SENATOR PHILIP:

Yeah. Thank you, Mr. President. I'm afraid I'll have to object, it's a very controversial issue. It ought to be heard in Exec. Committee. And...and, quite frankly, we have that Colt Gun Company...is our guest in the State of Illinois and our guest in the City of Chicago for their national convention. Now we want them to come back to Illinois, Senator. But if we're going to pass resolutions telling Connecticut what to do and encouraging people to demonstrate at a Chicago hotel against the Colt Company, I don't think it's in the best interest of the City of Chicago or the best interests of the state. We've only heard your side of the story, we have not heard the other side of the story, and I think in...in good conscience this ought to go to Exec. and we ought to hear both sides.

# PRESIDENT:

All right. Further discussion? Senator Hudson.
SENATOR HUDSON:

Well, thank you, Mr. President. I can only echo what...what Senator Philip has said in this regard. I think it would be ill-advised to discharge this bill...this resolution from committee at this time on such summary notice. I...I...I don't know whether the resolution, in fact, has been distributed or not. I don't know that the members have a copy of it, they're conversant with it. And, furthermore, it would seem to me to be establishing bad policy to begin to do this kind of thing because there are...forty-nine...there

are a lot of other states...forty—nine other states in this country that all have labor disputes of some kind going on and I suppose if we set a precedent and do this for this...do this in this case, we can do...something similar for all of the rest of them that come along. And I...I, too, would speak against discharging, I think it belongs in committee, should be deliberated...with some thought and some reason rather than a preempt..preemptory consideration of this kind.

All right. Senator Poshard, what is your pleasure? There have been two objections to the request for unanimous consent.

#### SENATOR POSHARD:

Well, Mr. President, I very well understand when some companies are under duress for whatever reasons financially and...unable perhaps to realize a fair profit. I understand that and I understand those people going to the appropriate labor authorities and negotiating around the table. been one of the foremost proponents in this Senate of labor management...legislation for this state. But the uncontestable thing, Senator Philip, that I think we have to look at in this particular case is that no one contest that Colt Firearms realized a one hundred and thirty-two million dollar profit in 1985. To ask for wage freezes and further concessions seems to me to be an unreasonable request under the circumstances. And, Mr. President, because of that unreasonableness, I would make the motion to suspend the rules to discharge the Committee on Executive from further consideration of Resolution 239 and ask for immediate consideration of the Senate.

## PRESIDENT:

Well, we were on the Order of Resolutions. The gentleman does now seek...or move to suspend the appropriate rules for the immediate consideration of Senate Resolution 239.

Discussion on the motion? Senator Fawell.

Mr. President, only to add one other thing, perhaps, and that is that the National Labor Relations Board recently issued a complaint charging Colt with numerous unfair labor practices. So that should be uppermost in our thoughts as we vote on this resolution.
