It is a day we also honor our living servicemen and servicewomen. So please join together in this program of reverence and respect for both the living and dead. We will now have Bugler Steve Hall play the "Battle Hymn of the Republic," accompanied by Drummer Joseph Richiusa.

SENATOR VADALABENE:

I now recognize Senator Margaret Smith who will read the poem, "Memories" by Velma Taliaferro. Senator Smith. SENATOR SMITH:

Thank you, Mr. Chairman, Senator Vadalabene. Mrs. Velma Taliaferro had great and unexpected results from her poem "Memories." It was written with the intent of being read at the grave of her soldier son, Jack, who was buried in Holland during World War II. A newspaper in Masterich printed the

essay and an outpouring of empathy and love from the Dutch was the results. Due to their generosity, Mrs. Taliaferro at the age of eighty-seven was able to travel to the Netherlands for a two-week all-expense-paid trip and sprinkled soil from her Oklahoma garden on her son's grave. The poem "Memories."

SENATOR VADALABENE:

I now recognize Senator Penny Severns who will read "In Flanders Field" by Colonel John M. McCrae. Senator Severns. SENATOR SEVERNS:

Thank you, Senator Sam. The best known poem of World War I, perhaps the most loved war lyric of the twentieth century, was written by an obscure Canadian who's almost forgotten today. It was John McCrae, a soldier positioned in...who penned in Flanders Field a poem as permanently associated with the great war as the poppy is with the American Veterans. His story is a tribute to him, to his nation and to the ideals for which he died. This is his poem published in punch December 8th, 1915.

(Senator Severns reads "In Flanders Field")
SENATOR VADALABENE:

(Machine cutoff)...now have Bugler Steve Hall and Drummer Joseph Richiusa play "When Johnny Comes Marching Home."

STEVE HALL AND JOSEPH RICHIUSA:

(Steve Hall and Joseph Richiusa play "When Johnny Comes Marching Home")

SENATOR VADALABENE:

(Machine cutoff)...recognize Senator Judy Topinka who will read the poem "Memorial Day" by William J. Aker. Senator Topinka.

SENATOR TOPINKA:

Thank you, Senator Sam. William J. Aker was a native son, he wrote this poem when he was ninety—one years old. He was born and raised on a farm in Waterloo, Illinois and ulti—

mately served in World War I under General John J. Pershing. He was asked by the Veterans' Administration to write a commerative poem, and so he did, updating a poem he had written in 1941 and called it "Memorial Day."

(Senator Topinka reads "Memorial Day")
SENATOR VADALABENE:

(Machine cutoff)...would like to recognize at this time seated in the President's Gallery, Department Commander Joseph White of the AMVETS and Bernard Kruger, commander of the VFW and Commander James Larr of Disabled...Disabled Veterans. Let's give them a hand, please. I now recognize Senator Adeline Geo-Karis, who served in World War II as a lieutenant commander in the United States Navy Reserve, for the purpose of introduction...introducing our guest speaker. Senator Geo-Karis.

SENATOR GEO-KARIS:

Thank you, Senator Vadalabene, Senator Mitchler and friends. Rear Admiral John F. Calhoun who is the commanding officer of the Naval Recruit Training Command at Great Lakes, Illinois, probably the greatest naval training base in the country. He's a native of Springfield, Missouri and attended the Missouri School of Mines before joining the Navy as a naval aviation cadet in 1957. He was commissioned an ensign and designated a naval aviator in October 1958. His first assignment as a navigator was with Patrol Squadron 46 flying P-5Ms and P-2V aircraft. Rear Admiral Calhoun's subsequent assignments included flight instructed duty in Patrol Squadron 31, two years as a student at the United States Naval Postgraduate School and a tour in USS Curatuck AV 7. 1967, Rear Admiral Calhoun completed jet transition and replacement pilot training in the 84 Aircraft, it was...and was assigned to Attack Squadron 55 completing two combat deployments to Southeast Asia in the USS Hancock. His next assignment was with Attack Squadron 174 for a transition to

the 87 Aircraft. He served as a maintenance officer and executive officer of VA-174 prior to assuming command of Attack Squadron 12 on board the USS Independence in October In 1975, Rear Admiral Calhoun was assigned to the Office of the Chief of Naval Operations at the 87...program coordinator, a position he held until July 1977 when he assumed command of Attack Squadron 174. From March 1979 until November 1980, Rear Admiral Calhoun served as executive officer of the aircraft carrier USS Independence, and from July 1981 until February 1983, he commanded the fast combat support ship USS Detroit. Following command of the USS Detroit, he was assigned as executive assistant to the chief of staff supreme allied commander Atlantic from March 1983 until April 1984. In July 1984, he assumed command of aircraft carrier USS Constellation and served as commanding officer until selected for flag rank...in December 1985. Rear Admiral Calhoun served as deputy director and director of Strategy, Plans and Policy Division in the Office of the Chief of Naval Operations from March 1986 until June 1987. In July 1987, he assumed the duties of commander Naval Training Center, Great Lakes. Rear Admiral Calhoun has been awarded the Legion of Merit, Distinguished Flying Cross, Defense Meritorious Service Medal, Meritorious Service Medal, Air Medal and the Navy Commendation Medal. He and his wife, the former Claudia Schmel of Pensacola, Florida, have a daughter Catherine Anne. He's doing a very fine job at Great Lakes and I ask you all to help me welcome Admiral Calhoun to our Navy Center...to...to our Senate rather.

ADMIRAL CALHOUN:

(Remarks by Admiral Calhoun)

SENATOR VADALABENE:

Thank you, Admiral Calhoun. We are honored to have you attend our annual Senate Memorial Day Program and be our guest speaker. (Machine cutoff)...privileged to call upon

Major General Sam Leroy Mendel, the Illinois State Militia, who is commander—in—chief of the Spanish—American War Veterans to give the closing prayer and possibly a closing song. Commander—in—Chief Mendel is one of the two survivors...surviving member of the Spanish—American War Veterans. The other is Captain Cook of Tempe, Arizona who served for forty—four years in the United States Navy. Let's give him a rounding applause. General Mendel.

GENERAL SAM LEROY MENDEL:

(Remarks given by General Mendel)

SENATOR VADALABENE:

(Machine cutoff)...General Mendel is Jim Philips who takes him around and takes care of him real well. (Machine cutoff)...now recognize Senator Earlean Collins who will sing "God Bless America." Earlean, you're following up a good singer here.
