PRESIDENT:

Mr. President, with leave of the Body, I $^{\circ}$ d like to be added as hyphenated cosponsor to Senate 3ill 1244.

PRESIDENT:

Senate Bill?

SENATOR BROOKINS:

Senate Bill 1244.

PRESIDENT:

All right. The gentleman seeks leave of the body to be added as the hyphenated cosponsor on Senate Bill 1244. Without objection, leave is granted. Senator Savickas, for what purpose do you arise?

SENATOR SAVICKAS

Mr. President, I rise on a motion to reassign House Bill 542, and I would move that House Bill 542 be discharged from

the Committee on Executive and reassigned to the Committee on Judiciary.

PRESIDENT:

All right. Senator Savickas, in his capacity as chairman of the Committee on Assignment, has moved to discharge the Committee on Executive from further consideration of Senate Bill 542 and asked that that bill be reassigned to the Committee on Judiciary. Is there any discussion? If not, all in favor indicate by saying Aye. All opposed. The Ayes have it. The motion carries and it is so ordered. 542 to Judiciary. Senator Jones, for what purpose do you arise?

Yeah, thank you, Mr. President. I'd like to relinquish the sponsorship of House Bill 2336 and put Senator Schuneman as the lead sponsor on House Bill 2836.

PRESIDENT:

SENATOR JONES:

PRESIDENT:

SENATOR JONES:

PRESIDENT:

Will our guests please stand and be recognized. Welcome to Springfield. Senator Mahar.

SENATOR MAHAR:

Thank you, Mr. President. I would seek leave of the Jody to be added as a hyphenated cosponsor to House Bill 1543.

PRESIDENT:
