And...it just goes on about...the amendment covers Section 6T, which...and that's not where the change is, the...the other change is on page 3 of the amendment, "that shall be also paid and...all builders rīsk insurance policy proceeds and all other funds recovered from contract assurities, architects, material suppliers or other persons contracted by the Capital Development Joard for capital improvement projects which are received by way of reimbursement for losses resulting from destruction of or damage to improvement projects while under construction by the Capital Development Board. And the next paragraph on page 3 of the amendment, and this is the new language, "Contributions, insured loss for reimbursements or other funds received as damages through settlement or judgement for
