This language will restrict the supplemental license to an area where the dealer is...is primarily licensed. House Bill 420 as amended will ensure consumers the dealer from whom they purchase a vehicle will have service facilities available, have office and sales personnel to properly handle the title and registration procedures and other services expected from a licensed dealer. This amendment is supported by the twelve hundred franchised new car and...and truck dealers. PRESIDENT:

All right, Senator O'Daniel has moved the adoption of Amendment No. 1 to House Bill 420. Discussion? Senator Davidson.

## SENATOR DAVIDSON:

Mr. President and members of the Senate, I rise in support of this amendment. As you all know that there's fifteen hundred licensed car dealers in Illinois who employ thirtyfive thousand people who pay eleven percent of the sales tax into the state coffers and this is just trying to give those people who...that investment and those kind of talent and people employed some protection against the people who...thay've done here recently...come down and rent a vacant lot and put up a tent and sell the cars and then disappear and there's no place for service or any complaints if the car doesn't do what it's supposed to be. I urge an Aye vote on this amendment.

## PRESIDENT:

Further discussion on Amendment No. 1? Senator DeAngelis.

## SENATOR DEANGELIS:

Thank you, Mr. President, and here we go again. I have a question of the sponsor.

Sponsor indicates he will yield, Senator DeAngelis.
SENATOR DeANGELIS:

I believe there was a bill that was not picked up that did the same thing. Can I ask why you chose not to pick up the bill and decided to try this end-around by putting it on as an amendment?

## SENATOR O'DANIEL:

Senator DeAngelis, the reason I didn't pick that bill up,
I thought you were intending to or I would have probably
picked it up.

# SENATOR DEANGELIS:

Well, let me point out to the members of the Body, this bill is...this amendment is nothing new. It's been tried several years and what it is is...it's the fifteen hundred

against the eleven million. We're going to take care of about fifteen hundred people by sticking it to about eleven million people. This is the get the little guy bill. If you'll recall, this...and I really do get upset with the automotive people because...they are the same people that come down to Springfield and want free enterprise till the time comes that they can do something to somebody else. We put a Sunday closing law. He created exclusive franchises. This has gone way too fare. In addition, I think you ought to know that this...will also stop those credit union sales and, Senator Davidson, those cars that are sold by those people have longer warranties than the car dealers you're representing have.

#### PRESIDENT:

Senator O'Daniel.

# SENATOR O'DANIEL:

Mr. President,...you know, I totally disagree with...with Senator DeAngelis. It's hard enough to get service on a...on a vehicle if you buy it locally and...and rely on the local dealers to...to service this vehicle and this isn't being in opposition to the...to the eleven million. It's...it's in support of those people because it guarantees them service after they purchase vehicle and he's talking about people that can come in, sell a car, leave the country, leave the...the area, then you have to try to depend on the local dealer to service this vehicle, and...and I think this is a good amendment and should be adopted.

#### PRESIDENT:

Further discussion? Senator D'Arco.

#### SENATOR D'ARCO:

Thank you...thank you, Ar. President. This bill...this amendment to this bill is a bad amendment and we beat it back many times before, and what this is saying is that the consumer, the person who buys the used car, is going to pay more

for the car because he can't buy the car from a rental car agency anymore. He's got to buy the car from the new car dealer that sells used cars in that territory and he can't buy the car with a loan from his local credit union that gives him a cheaper rate of interest than the car dealer his bank gives him. This legislation is anticonsumer legislation, and as far as the warranty provisions are concerned, the rental car dealers give them more extensive warranties than the local car dealers do anyway; and as far as servicing the vehicles are concerned, the rental car dealers have service agreements with all new car agencies not only in Illinois but all over the United States of America. They can get their...if they're out of state, they can get their car serviced in New Hexico or California, wherever that rental car agency has a service agreement which is all over this country and including Illinois. This is a bad piece of legislation. We've beaten it before and it should be defeated again.

## PRESIDENT:

Further discussion? Senator Savickas.

# SENATOR SAVICKAS:

Yes, Mr. President, not only was Senator D\*Arco hitting the nail on the head on the technical and service areas, this bill was introduced as a whole...this amendment was introduced as a whole bill, the sponsor did not wish to call it and I could imagine why in Transportation because all the credit unions are against it, there was no support except the few...new car dealers that feel intimidated by the sale of these. This was declared unconstitutional. We passed this out of this Legislature once before, it was declared unconstitutional and, yet, they continue to...try to intimidate the...the rental car outfits by introducing this legislation. If these people were sincere in what they were doing, they would have had that heard in Transportation, they would have

presented their case and found out that they didn't have that support, especially after it was declared unconstitutional and I think this is the wrong way to try to circumvent the committee structure by sneaking this bill on as an amendment when they refused to call it for a hearing.

PRESIDENT:

## SENATOR SEVERNS:

Thank you, Mr. President and members of the Senate. 1 rise in support of this amendment and I believe that this amendment is for the consumers. I have some firsthand experience more than I would like, in dealing with the rental cars and the condition of those cars. I'm in one right now, when checking the oil, it couldn't even register on the dipstick. Only three years ago, I went through eight rental cars in eight weeks. I think we're doing the consumers a favor by not allowing these operations to come in by night and leave by the next day without any real effort or concern as to what condition that car is going to be left and what the consumer...how the consumer is going to deal with it after they purchase the car for what they believe is a good price. I think if you're for the consumers, you should be for this amendment and I urge its adoption.

## PRESIDENT:

Further discussion? Senator Davidson for the second time.

# SENATOR DAVIDSON:

I'm sorry, Mr. President, to rise a second time, but Senator Savickas didn't quite give us an accurate statement. The bill wasn't declared unconstitutional, the Governor vetoed it. Let's not be misled by saying it's unconstitutional 'cause it...that question has never been asked and never been decided and I urge an Aye vote for this amendment. PRESIDENT:

## SENATOR DeANGELIS:

Well, I apologize, but, Senator Davidson, you are incorrect. I read a letter to this Body on 787 in which the Secretary of Commerce indicated that the bill was in restraint of trade, and you're right that it wasn't declared unconstitutional, but the letter further stated that if it proceeded to the Justice Department, it would be found in restraint of trade and subject to repeal. I urge the killing of this particular amendment.

## PRESIDENT:

Any further discussion? Further discussion? Senator O'Daniel...oh, I beg your pardon, Senator Barkhausen.

SENATOR BARKHAUSEN:

Mr. President and members, I just wanted to make one point that I think may not have been made in...in the earlier debate and is one that's come up in the previous debates on this and that...and that is the question of revenue impact. And it...it was pointed out at a last time we had this debate that to...to limit the potential for...for rental car sales Illinois will in all likelihood drive consumers who are looking for this kind of a bargain from rental car companies to our neighboring states, and those states would therefore reap the sales tax revenue which otherwise now accrues to...to our state because these sales are able to take place here. In response to the point that was made about the rental car companies not being able to repair their...their cars. All of these companies have...have repair contracts with the individual dealers, so you take the car to whatever dealer is...is nearest you and it's no more or less convenient than it is to buy a new or used car from a regular dealer.

## PRESIDENT:

Further discussion? Any further discussion? Senator Welch.

SENATOR HELCH:

I'd just like to contradict what...Senator Thank you. Barkhausen said. You know, the local dealer even if he does have a contract with Avis or Hertz isn't going to be thrilled to see some Hertz car come to his dealership. You're not going to get the same service, the consumer isnot going to get his car fixed as quickly, he's not going to get the same kind of treatment. So to say that this pro...anti...this is anticonsumar amendment, I think is incorrect. You've got local service, they're local dealers that you deal with all the time. Many of us who go into the dealers know who the dealer is, we see them on the street, it's not a one-time deal. What we've got here, I think, is a differential between buying cars in these big sales lots in Chicago and buying them downstate where we know these people. You know, I know my car dealer very well. I...you know, was complaining to me this weekend about what the credit unions were trying to do. I think that the consumer side of the issue is voting to put the amendment on not voting to keep it off. Number one, you're going to get better service. Number two. you're going to know what you're going Number three, the...the consumer isn't particularly astute in going in and...and buying a...a used car particularly one that's been used for a rental purpose which are usually harder driven than the normal car. Think of it yourself, when you use a rental car, you don't treat it exactly the same as you do your own car or a friend's car, it just stands to reason. So I think that the consumer position is to vote for this amendment not to vote against.

## PRESIDENT:

## SENATOR O'DANIFL:

Thank you. Mr. President. You know, I think one thing that hasn't been said that these twelve or fifteen hundred

dealers over the state, they...they play a very vital role in that community. They pay taxes there, they support civic organizations, they hire several thousand people and I think they...should have some protection and not allow these other agencies just to come in overnight and then leave. And I...I think this is a good amendment and would appreciate favorable consideration.

SENATOR DUDYCZ:

An autonomous city. They haven't decided what name they

were going to call themselves. They still would require permission...Dudyczville, right. They would still require permission from any municipality within a one and a half mile radius which would still require permission from the City of Chicago and the other villages.

#### SENATOR NETSCH:

Thank you. But even if it did not...or if it were not directed at Chicago, which I get the distinct impression it may be, if, in fact, you are reducing the population limit for incorporation even in unincorporated areas, even in other parts of the state, it seems to me that that's going in exactly the wrong direction from what almost anyone who has any concern about the vitality and validity of local government would be recommending; because if you get that population base too small, you have a...an area that is just simply not able to perform or to offer the services and so the...the direction has been exactly the opposite and it seems to me with very good reason. # SENATOR DUDYCZ:

Yes,...Senator Netsch, this is a small unincorporated area on the west...northwest side of the Chicagoland area, it's completely surrounded by the city. Over the years, the City of Chicago has been gobbling up all this property creating this hole in the doughnut and the people of this...unincorporated area just do not wish to be annexed and they're fearful of the city annexing them, and they would like to remain autonomous and become...a city in themselves and I ask for a favorable consideration.

prohibition on home rule authority except for the City of Chicago. The reason for this being the City of Chicago is in the process of drawing their own legislation in regards to...to this particular item.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Jacobs has moved the adoption of Committee Amendment No. 1 to House Sill 755. Is there discussion? Senator Geo-Karis.

SENATOR GEO-KARIS:

Committee Amendment No. 1 says that no unit of local government include any home rule unit except for the City of Chicago may in any way regulate, limit or license manufacturing housing. T thought you'd like to know that...Municipal League has come out against this because it does deprive local governments from...taking care of their own rules on housing. I think it's a bad amendment and I think it should be defeated and I would like...your indulgence for a second. Well, this...the amandment would preempt all local governments except that it excludes any municipality of two million or over, so it excludes Chicago, but it does apply to all the other local governments. I think it...this...this bill would repaal with this amendment all local building code authority over manufactured housing. You could open the door up for ... a mobile home to be brought in and placed on a permanent foundation. So I would like to call your attention to this amendment. It's a bad amendment and I urge its defeat, much as I like the sponsor of the bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator Collins.

SENATOR COLLINS:

Question of the sponsor, please.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Sponsor indicates he will yield. Senator Collins.

#### SENATOR COLLINS:

Yes, Senator, you're...you're saying that you did exempt Chicago from this bill so that this bill...this amendment as it is now would not preempt the...all of the city ordinances as it relates to local building codes?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Jacobs.

### SENATOR JACOBS:

Yes, Senator, this...this amendment was offered by Senator Brookins at the request of the City of Chicago.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Further discussion? Senator Weaver.
SENATOR WEAVER:

Well, I see no reason to exempt the City of Chicago. Many other downstate cities have certain building restrictions that should be given preferential treatment if we're going to give Chicago preferential treatment. I...I think if it's good for the total state, it's good for the total state; otherwise, I would object to the amendment.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Further discussion on Committee Amendment No.

1? Senator Brookins.

## SENATOR BROOKINS:

In...in response to Senator Weaver, yes, it is good for...Chicago, as you had indicated, and Chicago has already this legislation in their city ordinance, and...and that's why that they didn't feel that they needed it and that's why the sponsors of the bill exempted them out.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator...Senator D\*Arco. I\*11 come back and pick you up the second time. Senator D\*Arco.

SENATOR D\*ARCO:

Chicago does not have an ordinance that allows for prefab housing in the City of Chicago. Well, wait a minute...wait a minute. There's...you know, that's like saying a bill is in the works; I mean, there's a difference between a bill passing the Legislature and a bill pending. So an ordinance pending in the City of Chicago doesn't mean it's been enacted. Yeah, it's pending, there's a big difference between it pending and being passed, and I agree with Senator Weaver, what's good for the state is good for Chicago.

PRESIDING OFFICER: (SENATOR DEMUZIO)

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator...Senator Geo-Karis for a second time.

#### SENATOR GEO-KARIS:

I...I apologize for rising and speaking a second time and not because I'm a mayor, but I do not believe that we should deprive local governments from stopping the types of structures from being built according to the local standards that all other structures have to meet and this...well, Chicago is out of it, Chicago doesn't have to worry about it, but all the other municipalities are in it and this is a bad amendment and I think you'll be doing a disservice to people in...in your cities...when...if you support it. You are preempting the local governments from controlling the type of structures from being built according to local standards in their municipalities. I speak against the amendment.

All right. Further discussion? If not, Senator Jacobs

## SENATOR JACOBS:

First of all, let me state to Senator O'Arco, you're absolutely correct. There is a ordinance that is in the works, it has not been adopted yet, but that was the reason at the request of the mayor that we did exempt them at this particular time. They can always be included at a later date. Secondly, in regards to the Municipal League coming on like gangbusters, having been a mayor for fourteen years, we

don't always agree, but yet the Aunicipal League did not give any oral testimony in committee, so I think for them to come at a late date like this is...is really a little bit underhanded, Miss Mayor, if I could, and I ask for its adoption.

PRESIDING OFFICER: (SENATOR DEMUZIO)

It seems to me that two is just as meaningless as one and we should defeat this amendment as well.

Thank you, Mr. President. Daja vu, ladies and gentlemen, this is the debate on the bill that would prohibit the prescription of contraceptives by clinics which are based in schools. The amendment that was placed on the bill in the Committee on...on Elementary and Secondary Education adds the phrase, "without parental consent," which means that no contraceptives could be prescribed in these clinics unless there is parental consent. I oppose Senator Kelly's motion to Table for a number of reasons. One is that the...the amendment was thoroughly debated, it was the will of the committee by a majority vote that that amendment be adopted. and I think if we're going to give any credence to the committee process, this motion should be defeated. In other words, the amendment should be adopted. By the Wavesea parliamentary inquiry. Is the...is the vote on Senator Kelly's motion to Table, so that if you agree with Kelly, you vote Yes; if you agree with Berman, you vote No. Is that the way the board will ba?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Kelly has made a motion to Table. Those voting in the affirmative will be voting Aye. Those in opposition supporting your position will be voting Nay.

# SENATOR BERMAN:

Thank you, Mr. President. Let me just go a little bit further so that we clarify it, and I apologize for taking us through this again, but I'm sure we may hear about this a few more times before the Session is over. I have distributed to all of you an item which I think is very relevant. Ladies

and Gentlemen of the Senate, these are reprints from two articles, one is an article...an editorial from the Chicago Tribune urging local control of school clinics. Now the relevancy of that editorial to this motion is that in Chicago In particular, the Chicago Board of Education holds local community meetings before school based clinics are put in to any local schools and there are two of them. In addition, there is thorough consultation between the parents and the children and the...and the staff of these clinics and there's counseling that is performed before any health services including contraceptives is given. And there is a consent form which not only addresses the prescription of contraceptives, but to all other types of medical treatment so that we have the parents involved, and, Ladies and Gentlemen of the Senate, you know that the greatest fault in the efficient operation of any of our programs is the fact that parents are If you don't want parents involved, then you not involved. vote Yes. If you want parents involved, vote No. Now let me point out to you on the other side of this editorial handout. Here are two articles, one is from the Sun-Times...they're both from the Sun-Times and it stresses twenty percent of the...of girls have sex by age sixteen and it also shows that the last year and the year before eighteen and a half percent of the children born in Chicago were born to teenagers. Now, ladies and gentlemen, we cannot avoid the regrettable facts, children are having children. These clinics are important. Senator Kelly's bill does not eliminate the clinics. I don't want to mislead you, but his bill prevents the prescription of contraceptives even with parental consent. I think that's the wrong way to go. Vote against the amendment to Table, allow the parents to have a voice in addressing the very serious needs of our children in today's schools. I urge a No vote on Senator Kelly's motion to Table.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right...Senator Berman, while the Chair was deciding the...the question of...of the...of your inquiry...the Chair neglected to inform the membership that a motion to Table is also nondebatable. So...all right. All right...now...given that, I have three lights. Senator Geo-Karis.

Mr. President, Ladies and Gentlemen of the Senate, I'm glad you made your statement, but I do believe in parental control and the parents should be involved so I speak against the amendment,...against the motion to Table.

I apologize, Mr. President, for debating a nondebatable issue but it's been done before. Senator Berman makes the point that this bill should be left in the form that it came out of committee. Now, Senator Geo-Karis just got completed in striking an amendment that was put on in committee and this has been done before. There's nothing wrong with this procedure and Senator Berman mentions deja vu and it may be. We have deja vu but we have another chance. I think, to rectify and to vote right in this case. It just seems to me to put it succinctly that there are some things that our schools should be dedicated to and used for which is basically the primary basic education of our young people so they can cope in this world, but to say that they're going to do it anyway, so let's...let's give them the implements and give them an assurance that they can do this safely or avoid disease perhaps or AIDS or whatever it may be seems to me to be using our schools for something...that our schools should not be used for. We don't do it with alcohol, kids are using alcohol and we know they're using alcohol but we don't say. well, let's give them a couple of bottles of booze in the classroom, teach them how to drink safely, give them...tell

them that all they need is two or three shots, they shouldn't take six or seven or eight, it'll make them drunk and send them out and figure that they're safe. I think this is a mistake and I think Senator Kelly's amendment here that would strike Senator Berman's rather, in my opinion, foolish amendment and dangerous amendment, I think he's on the right track, we have another chance to do the right thing, let's do

PRESIDING OFFICER: (SENATOR DEMUZIO)

Well, ladies and gentlemen, let's...now we're...we're in a nondebatable situation. We have...now we have two...three additional lights. Let's just...admonish the membership. Senator...Senator DeAngelis.
