They're about twenty-five to thirty selected for the program. We have two teens who were chosen to visit the Midwest this year - Chicago, Springfield, Milwaukee, Detroit, Indianapolis, St. Louis, and Minneapolis/St. Paul. And we have Joshua Fromkin, who was born in neighboring -- Lafayette, Indiana, and then moved to Canada, and ultimately to Haifa in Israel. He is -- his stepfather is the public relations director for the Arts School in Jerusalem. His older brother, of course, is in the Air Force. Joshua is in the eleventh grade, majoring in
