Thank you, Mr. President, Ladies and Gentlemen of the Senate. I'd ask for the attention of the Membership. This resolution revolves around a rather momentous decision. And the resolution, if I may, with leave of the Body, Mr. President and Ladies and Gentlemen, recites:

WHEREAS, Jerome J. Joyce was elected to the Illinois Senate in 1974, and was subsequently re-elected in 1978, 1982, 1984 and

1988; and

WHEREAS, Jerome J. Joyce has, during his seventeen-year tenure in the Senate, served with distinction as the Assistant Majority Leader, Chairman of the Senate Committees on Local Government, Agriculture, Conservation and Energy, and Executive, and as Chairman of the Legislative Redistricting Commission; and

WHEREAS, Jerome J. Joyce, who owns and operates a 520-acre farm near Essex in Kankakee County, has worked tirelessly on behalf of farmers, agriculture and rural Illinois; and

WHEREAS, In his effort to keep agriculture our State's number one industry, Jerome J. Joyce has sponsored, among other things, landmark farmland assessment legislation, legislation designed to spur increased ethanol production, legislation to provide financial assistance to drought-stricken farmers, the State's first program to curb soil erosion, and farm debt mediation legislation; and

WHEREAS, Jerome J. Joyce has likewise been recognized as one of the nation's foremost authorities on nuclear energy, and has been a staunch environmentalist while serving in the Senate; and

WHEREAS, In recognition of his expertise, Senator Joyce was appointed by President Jimmy Carter to the States Planning Council on Radioactive Waste Management in 1979; and

WHEREAS, Jerome J. Joyce received national recognition by sponsoring and passing legislation which successfully banned the importation of nuclear waste in Illinois for five years; and

WHEREAS, Senator Joyce has authored legislation creating an Illinois-Kentucky compact for the disposal of low-level nuclear waste, and helped create a three-member commission to decide where the repository will be located; and

WHEREAS, Jerome J. Joyce sponsored the legislation creating the Citizens Utility Board and played a major role in the rewriting of the Public Utilities Act to make utilities more

accountable to ratepayers; and

WHEREAS, Senator Joyce also co-sponsored the State's first groundwater protection legislation; and

WHEREAS, When the State of Illinois closed the Manteno Mental Health Center in 1983, Senator Joyce was the driving force behind the creation of the Illinois Diversatech campus on the site of the former Mental Health Center, creating many new jobs; and

WHEREAS, Jerome J. Joyce sponsored the legislation creating the Kankakee River Valley Airport Authority and the Kankakee River Commission; and

WHEREAS, Jerome J. Joyce also co-sponsored legislation abolishing the inheritance tax and removing the sales tax on food and medicine; and

WHEREAS, To spur increased economic development in Illinois,

Jerome J. Joyce participated in two trade missions to the Soviet

Union to find new markets for Illinois products; and

WHEREAS, Jerome J. Joyce will end his distinguished tenure on behalf of the people of the 43rd District and the people of the State of Illinois by retiring from the Illinois Senate on April 29, 1992; therefore, be it

RESOLVED, BY THE SENATE OF THE EIGHTY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we extend our warmest congratulations to our colleague, Senator Jerome J. Joyce, on the occasion of his retirement from this Body, and thank him for his seventeen years of service; and be it further

RESOLVED, That a suitable copy of this preamble and resolution be presented to Jerome J. Joyce, along with our best wishes for good health, happiness and prosperity.

It's -- after Senator Rock read Thank you, Mr. President. that, it's a good thing I'm getting out of here. I must have cost the State of Illinois billions. But thank you, Senator Rock. I guess I have been here a long time. I know when I came down here the first time, my kids were small, and now I'm -- when I'm leaving, my grandchildren are the same age that my kids were when I came down. So I think that's time to -- to wrap it up. look forward to bringing those grandkids down here to Springfield, and when I can take them by the hand and point to the august site across the street at Second and Monroe that's now the beautiful State Library, and tell them how much time as a Senator I spent there on that site. Of course, it was the Capitol Way Inn then. Through all the victories and rivalries and -- I'm not without regrets. I think that as a Democrat, I would have liked to have had the opportunity to serve more than a couple years under a Democratic Governor. I regret that we were unable to fund education to the extent that we should have, or to protect the environment to the extent that we should have. But the deepest regret I think I'm going to have, and the one that's going to haunt me for many days when I leave this building, is I that I'll be unable to vote on the pension bill that comes around next November. I also had the good fortune to witness many historic events in this building. I witnessed landmark debates over the Equal Rights Amendment. I was witness to President Carter's visit to the Capitol. I witnessed the tense debate over -- the death penalty. I saw Jim Thompson ride a horse in the 2nd Saw John Knuppel throw soup on Charlie Wheeler. Floor Rotunda. And once I thought I saw Dawn Clark Netsch make up her mind, -- and that was truly a miracle. I've also witnessed vast changes during my service here. I saw Dick Durbin, once our capable parliamentarian, turn into a powerful and respected Member of Congress. I saw our Leader, Phil Rock, turn from just a

run-of-the-mill Chicago legislator into perhaps the greatest Senate President in our history. I can't tell you how many times, for you members of the press, that I've seen Bill O'Connell turn into a saloon. You know, some of the things that I'm sorry about, I -- the, you know, reporters this last Session were complaining about campaign funds and how we spend our money. And all I can say to you is now that I'm leaving, I can spend it anywhere I want to and I don't have any left. But I will be thinking of all of you during the years that come and the times that I've had here with you and the -- the heartbreaks and the fun and all of the rest of it. And particularly, I'll be thinking of you this June 30th and probably July 30th and August 30th. But I will miss this -- this great place, and it's been very fulfilling, and I'll always have a place in my heart for all of you. So thank you very much.

you, Mr. President. Jerry Joyce possesses those Thank qualities that the Irish admire the most in people, and that that he was always faithful and loyal to his friends. Lately, he's not been too helpful - now I know why. But he was always gracious. And when I was overly serious about a situation, he injected humor to bring me back down to earth. Truly, I think that the people of Illinois today lose a good Member, a Member that both sides of the aisle can recognize as a formidable foe, who would look you in the eye and tell you what he thought, and sometimes you didn't want to hear it. And I got a good example of that last week in a bill, when he killed one of my bills in committee. But you could count on that, and that's
