It is a technical and substantive reworking or rewrite of the Illinois Domestic Violence Act. It is a very lengthy amendment - one that was discussed at

some length over the past -- particularly over the past eighteen months, by various -- both -- both Bar associations and those interested in the operation of the domestic violence law. It contains about fifteen substantive changes, all of which have met with universal agreement. I know of no objection, and I intend to offer a Floor amendment to solve the one problem that was brought to my attention. So I would move the adoption of Committee Amendment No. 1.

SENATOR ROCK:

Thank you, Madam President, Ladies and Gentlemen of the Senate. Amendment No. 2 attempts to solve the problem that was brought to my attention by -- by the protection and advocacy group led, obviously, by Dolly Hallstrom. The question concerns itself with the access to the Act and its remedies on the part of adults with disabilities, who are certainly vulnerable to abuse and neglect and exploitation. A couple of years ago we, in fact, put in this group of persons as protected under this Act. They were inadvertently left out. Amendment No. 2, offered at this moment, puts them back into the Act, so that the Act will again apply to

and afford the remedies for those adults with disabilities. And I would -- I know of no objection, and I would move the adoption of Amendment No. 2.

SENATOR CULLERTON:

Thank you, Madam President, Members of the Senate. This

amendment reflects an agreement that I have worked out with the National Rifle Association and with the Illinois State Rifle Association. The bill deals with the issue of the sale of BB guns to children. And what this amendment says is that — and it — right now, by the way, an air rifle cannot be sold to a child under the age of thirteen. This would say that the air rifle cannot be sold to a person under the age of sixteen, unless they have the written permission of a parent or a guardian. And this is agreed by the National Rifle Association and the Illinois State Rifle Association. And of course, if it wasn't, I wouldn't even be here presenting this amendment, because I know that we have to have their support, and thank God, we do.

PRESIDING OFFICER: (SENATOR COLLINS)

Senator Cullerton has moved the adoption of Amendment No. 1 to -- to Senate Bill 1665 <sic> (1565). Discussion? Senator Davidson.

SENATOR DAVIDSON:

Ouestion of the sponsor.

PRESIDING OFFICER: (SENATOR COLLINS)

He indicates he will yield. Senator Cullerton.

SENATOR DAVIDSON:

Senator Cullerton, does this also include the ones who are under sixteen, I believe it is, with the normal BB gun - one that you can't pump up - would be excluded from having to have a FOID card?

PRESIDING OFFICER: (SENATOR COLLINS)

Senator Cullerton.

SENATOR CULLERTON:

Yes. The current law is a little complicated, because it talks about muzzle velocity. Anything with a certain muzzle velocity over seven hundred would require you to get an FOID card, which you can't get if you're -- unless you're, I believe,

seventeen or eighteen. So what we've done is we've -- we've struck that language, and we've clarified it so that now you don't need to get an FOID card to have a BB gun. But you -- you -- we are saying if you're under -- between thirteen and sixteen, you have to have parental permission to purchase it. You can still possess it without parental permission. It's just the purchase that this has affected.

PRESIDING OFFICER: (SENATOR COLLINS)

Senator Davidson.

SENATOR DAVIDSON:

Well, Madam President, I'd like to rise in support of this amendment. This is as the sponsor stated. This is a worked-out agreement of all parties concerned, and I'm delighted to support this. And at opportune time, now that it's been amended, I will go on as a hyphenated co-sponsor of this bill.

PRESIDING OFFICER: (SENATOR COLLINS)

Further discussion? If not, those in favor will indicate -Senator Cullerton has moved the adoption of -- of Amendment No. 1

SENATOR KEATS:

Question of the sponsor.

SENATOR KEATS:

I don't have a copy of the amendment. So -- I wanted to do is slow this bill down so people can find out exactly what's going on. You said the penalty starts July 1st. Knowing the efficiency of the Legislature, there are many times there is no budget July

PRESIDING OFFICER: (SENATOR COLLINS)

Senator Carroll.

SENATOR CARROLL:

Thank you, Madam President. Senator Keats, I apologize. I did misspeak. When we eliminated prompt payment, it was supposed to be for the year, many of us thought, and that was not automatic. You had to file for it. This obviously would not become effective till it becomes law. It has no special date in it. So upon the Governor's signing it, and then it applies as automatic sixty days after the bill should have been paid. And the difference is, instead of having to go through the process of waiting till you're paid and then applying, which could be a year later, it would be an automatic at the sixty-day level.

PRESIDING OFFICER: (SENATOR COLLINS)

Senator Keats.

SENATOR KEATS:

Would this include some of the pinstripe patronage legal contracts if they've been not been paid on time? Because two percent a month is a fairly high interest rate, remembering prime's about six and a half. So are we, in reality, including a few of our pinstripe patronage guys in this?

PRESIDING OFFICER: (SENATOR COLLINS)

Senator Carroll.

SENATOR CARROLL:

I would be happy to accept an amendment to take them out. The law, as it says now, allows them to get it by applying. The difference is that they, like everyone else, has to apply after they've gotten paid. This would say it's automatic, so that small business and everyone else would be entitled to what the State now provides, and that's two percent. The difference is whether they get it and get it on a monthly basis, or have to wait six, eight

months. And -- you know, if you want to go into that issue, I think we've all heard from a lot of businesses who have unfortunately done business with the State, many of whom have been forced to close because they were never paid. They couldn't even get interest payments from the State, because of the silliness of our existing law that you can't even apply until after you got paid. This makes all of that automatic. But if you have a problem with any particular Section, particularly as to the pinstripe patronage, be more than amenable to taking that out totally.

Senator Keats.

SENATOR KEATS:

Final question then. We may be back with an amendment, because the previous bill -- every word you've said I totally agree with. I'm not sure this bill really deals with exactly what you said, 'cause I agree with what you said. But last year when we passed it, we said the agencies would work out a formula. Now we're leaving it completely in the hands of the Comptroller, who we all have the greatest confidence in. But if you don't mind, we will try to get back to you with an amendment; although, the basic direction of the bill is fine, and again if -- I just think it might be fine-tuning.

These would be characterized as -- as having some characteristics of partnerships, on the one hand - that is, the ability to be treated for tax purposes like a partner, but at the same time be treated as a corporation from the standpoint of having one's potential liability limited to the extent of one's investment in this particular entity. There have been, up to this point, nine states which have adopted legislation authorizing limited liability companies. This product has gone through two or three years of Advisory technical review by the Business Corporation Act Committee of the Secretary of State's Office. I would be glad to attempt to answer any of your questions, and would otherwise, move

Ten of those

amendments were adopted at that time. This one was not, we've heard read into the record -- that numerous states have subsequently ratified this particular amendment, the most notable ones being last week, the thirty-eighth state, which was Michigan - New Jersey following it. Should we ratify this amendment, we would be the fortieth. Conceivably, we could even yet be the thirty-eighth state, should there be any challenges to this particular amendment, which would ask that the original eight states that voted this in in the seventeen hundreds be asked to reconsider and to continue to support their position, because of the extreme age of this amendment. What this amendment verv simply does is allows for an intervening election to occur before congressmen can raise their salaries. It has been discussed on at least seven times in the General Assembly here. It has gotten through the House. I would urge its adoption so that we can take our place with others who would like to regulate salaries on the congressional level, much as we do here in the State of Illinois, and I would ask your favorable vote.

PRESIDING OFFICER: (SENATOR COLLINS)

Senator Topinka has moved the adoption of HJRCA 2. Further discussion? Senator Rock.

SENATOR ROCK:

Well, I'm -- I'm probably wailing at the wind, Madam President. But the fact is, I have, for one, a great deal of confidence in James Madison - at least from what I have read. And I think if, indeed, he had been truly interested in putting this into the Constitution, he would have done it. He was sitting there the whole time. Just seems to me that we have bigger fish to fry than this. This is over two hundred years old, and frankly, I don't think our ratification is legal. So I intend to vote No.
