I -- I really can't answer whether the labeling would also require, as you indicated, hormone or other types of feed additives.

That message is that the sacrifice will apply across the board, that we will demand as much as ourselves as we will of the bureaucrats, and that we will not place the less privileged in front of either one of us. Let me just say to the Body that I have never raise since I've been a Member of the Senate, which is six It seems that every time the vote was taken, that I either been elected or not running for election. And by no means would I be able to benefit one way or another from this pay raise that is being proposed, or was proposed, by a committee that was established to -- to give pay raises to the Senate Representatives and officials of the State of Illinois. But I think that we're doing our public and our elected -- our constituents a disservice when we reject, out of hand, something which is -- has been studied, which would be good for the State of Illinois, meaning that we would attract the type of legislators and the type of people that would be dedicated to do the service of the State of Illinois. I think it's a dumb move on the part of you, as a Body, to reject something which has been studied over the years. I think that it is kind of misleading into the public and hypocritical that you're doing this or taking this type of action, though you feel that your constituents do not understand they're too stupid to understand what you're attempting to do, because it's an election year. So I just wanted to make them remarks to you. Thank you.

## SENATOR TOPINKA:

Mr. President and Ladies and Gentlemen of the Senate, this resolution asks the Governor and the State's Congressional Delegation to oppose the proposed reductions of the Illinois National Guard and Reserve Units and any similar proposals in the future, on the basis that indeed it costs less to keep these kind of part-time units in place than it does, you know, for a

full-time military. So if cuts are to be made, maybe look there first. I think our people have proven that if they're called into action in such melees as Desert Storm, they are quite equipped to do this, even when they come from part-time training. Also, by virtue of their being here, they do manage to flush out federal funding, which we would lose in any other way, and I think with the closing of Chanute Air Force Base and Fort Sheridan, we've already taken our fair share. So that is the resolution. I would seek your favorable vote.

But it does urge the General Assembly to consider - at least consider - changing the rules that would have us -- have a Session ending date of May 1st. And it does so by putting trigger dates on the introduction of bills and deadline for getting bills out of committee. I think we've discussed this for quite a number of years, of changing the Session date to a different date than June 30th. And this resolution is certainly asking the General Assembly to consider adopting rules to change the Session date.

Thank you, Mr. President, Ladies and Gentlemen of the Senate. I rise in opposition to Senate Joint Resolution 148. I frankly just feel that it's probably not going anywhere anyway. But if the Members would take the time to read it, as I suppose -sympathetic as I am to the length of time and the amount of time that the General Assembly spends on the people's business, this schedule, as presented, calling for deadlines to be established, simply is unworkable. Remember, if you will, please, constitutionally and statutorily call for the Governor to make budget recommendations to the people of Illinois and us in a Joint Session on the first Wednesday of March, and that literally is when the Session begins, for all practical purposes, because the entire -- any program is driven by the budget and budget considerations. Under this proposed set of deadlines, you wouldn't have enough time to thoroughly analyze, scrutinize and reorder the priorities in a twenty-six-billion-dollar annual expenditure. I suppose it sounds good, but the fact is, unworkable, and I intend to vote No.

Further discussion? If not, Senator Woodyard may close. All right. Senator Woodyard has moved the adoption of Senate Joint Resolution 148. All in — all in favor, indicate by saying Aye. Opposed, Nay. This resolution would urge the Federal Congress to repeal mandates that infringe upon states' rights to govern motor vehicle safety, and particularly with regard to the imposition of them on the motorcycle helmet law, in which, by threat, have asked states to adopt that particular law and hold us hostage by mandating that we must transfer some of our road construction funds into educational programs.

Senator Woodyard.

SENATOR WOODYARD:

Well, Senator Cullerton, it's a constitutional right of each state, it's my understanding, to govern their own motor vehicle safety.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Cullerton.

SENATOR CULLERTON:

Well, you've raised a very interesting point, Senator. It's too late; the Federal Government has acted. And they -- it's very interesting, and I think the public should know what the Federal Government has done. Whether you like it or not, they have passed a law that will start -- go into effect next October, where the State of Illinois, unless we pass a motorcycle helmet law, will

lose, for road construction, millions of dollars. In fact, the Illinois Road Contractors were initially unaware of this, but goes into effect. I think it's about five million dollars the first year; nine million dollars thereafter. In addition, there's about seven hundred -- almost eight hundred thousand dollars that we can obtain from the Federal Government if we pass the law, in addition, of course, to saving lives and money. So it's too late to pass such a resolution, even if you think that the Federal Government shouldn't be involved. There's plenty of instances where the Federal Government has done this. As a matter of fact, back in 1969 we passed a motorcycle helmet law as a result of federal action. We did the same thing in other safety areas, and I think this is a very bad resolution and a needless resolution to vote on and vote for. Urge a No vote.

Who knows what the next issue — they'll say, "If you don't do this or that, we're going to take some money away from you." You know, they're pretty good at handing us bills and walking away. But this is — this is, I think, sending Washington a message — not just on this issue, but on all issues — that this is not an effective way — way for the Federal Government to deal with the State Government, any more than our municipalities would be happy if we sent through some law that said, "We're going to take half your motor fuel away if you don't have a bicycle safety

program in your city hall." We don't operate that way, and the Federal Government shouldn't operate that way.

It's a very indirect way of trying to get this accomplished. It's very unfair. I think it puts us at risk unnecessarily. And really and truly, they seem to have an opinion on so many things in Congress — let them stand up on their end and do it, and not shove it back to us in this type of a backhanded manner. It's really an ugly way to do business, and I think the resolution addresses that.
