First, let me say that most of us who served in the House and in the Senate remember Judge Calvo for his graciousness and for his loyalty to his area. I lost a -- a great friend in Judge Calvo. When I was sick, I was sworn in -- into the Legislature, he came to my home. He's a great guy, and we're going to miss him. I move for the consideration of this resolution.

PRESIDENT ROCK:

All right. Senator Vadalabene has moved the adoption of Senate Resolution 4-8-7. Those in favor, please rise. The resolution is adopted. The Senate stands adjourned until twelve-thirty tomorrow. Twelve-thirty. Senator Geo-Karis has asked me to remind you there's a Republican Caucus immediately in Senator Philip's office. The committees will begin at two o'clock.
