Thank you, Mr. President, Ladies and Gentlemen of the Senate. This is the next in our ongoing series of supplemental appropriations for the operation of State Government. Most of this is federal funds for grants that have come into the State. Some of it is Capital Development money as well. It is a total of about a hundred and five million dollars, of which about sixteen and a half million is in General Revenue Funds. I would ask for a favorable roll call, and answer any questions.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Is there discussion? Senator Watson.

#### SENATOR WATSON:

Yes. Thank you. Question of the sponsor on Section 9, the Nuclear Safety provision that says 7.8 million dollars additional appropriation for the processing of the low-level radioactive waste facility. What is that money for, Senator?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Carroll.

#### SENATOR CARROLL:

It's my understanding that is the continuing payment for the contractors on the siting commission to continue their efforts for the facility development. It...(machine cutoff)...it is a request of the Governor, and it's my understanding it's -- it's the contractors' funds to continue the operations and the studies that are going into the site development.

Do you have any idea, Senator Carroll, how much money we have spent on this -- this site development to this point?

SENATOR CARROLL:

Best of my recall, Senator Watson, it is exceeding twenty-five million dollars at this point. And the Governor requested we add this to it.

PRESIDING OFFICER: (SENATOR DEMUZIO)

SENATOR WATSON:

Yes. Thank you. One other question. Section 15c, under Conservation, I see five million dollars for grants for shoreline development and other water-related improvements. Would you please explain that provision?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Carroll.

SENATOR CARROLL:

Yes. I asked the Governor's Office the same question because of the obtuse way in which they presented it. It's my understanding it's for a Peoria marina of five million dollars. The Governor's Office so advised me. It was a Governor's Office request.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Watson.

SENATOR WATSON:

What in this supplemental appropriation is there for Medicaid providers?

PRESIDING OFFICER: (SENATOR DEMUZIO)

### SENATOR WATSON:

So we're going to put five million dollars into a marina, and we've got people that aren't receiving Medicaid services throughout this State that are being left out. I -- I just -- I have a problem, quite honestly, with that. What about, Senator, on the, I believe, Central Management Services paying their -- the Workers' Compensation benefits that are due; paying the awards to those people who have been given an award by the Attorney General's Office? I understand that some of those people are left out of this -- this amendment also. Is there -- can you respond to that, please?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Excuse me. Can we have some order please? Senator Jones.

All right. Senator Carroll, did you -- did you hear the question?

Senator Carroll.

#### SENATOR CARROLL:

Whether I heard it or not, I think I could answer it. Yes. These are the priorities set by the Second Floor, by the Office of the Governor. In the area of Workman's Comp through CMS, they are suggesting that we pay the bills through March, and nothing that has come in since March. So it would only cover up through March. And not — to answer your prior question — their priorities were not to pay the medical vendors, you know, hospitals, nursing homes or doctors, but to pay these bills.

Senator Watson.

SENATOR WATSON:

Is -- I just have problem with this kind of approach. I mean, we've got people out there that are hurting, and now we're going to give five million dollars for a marina in Peoria? Senator Carroll, I've had some constituents in my district, in Avon Township, who have gotten judgments from the Court of Claims. I haven't had a chance to go through all this, but is the Court of -- are the Court of Claims judgments involved in here? Are the judgments to be paid from the Court of Claims involved here? PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Carroll.

SENATOR CARROLL:

Most of the Court of Claims judgments are in Senate Bill 409, which is already in the House -- would be in a different piece of legislation.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator Severns.

SENATOR SEVERNS:

Thank you, Mr. President, Members of the Senate. I rise just to question: why are we doing this? We all know that we have a budget crisis going on. We all know that we have nearly a billion

dollars, or probably more, of bills that will be generated from FY'91 going into FY'92 unpaid. In my district - and I expect in the remaining fifty-eight districts - we have pharmaceuticals, hospitals and nursing homes that have bills that have gone unpaid for over a hundred days. In this supplemental we have nearly seventeen million dollars worth of General Revenue Funds that the Governor has requested to make payments to agencies. For lawsuit settlements, for lump sum payments for marinas, for studies, real estate transfer purchases. I'm not saying that -- that these requests are without merit, but when you put them side by side to the pharmaceuticals that have gone unpaid for over a hundred days, I think we have to wonder what we're doing here. I don't think there's a single request that matches up to the crisis in the Medicaid area that -- that this State is suffering from And I think to just casually put forward -- for the Governor to casually put forward a supplemental appropriation request that includes seventeen million dollars worth of General Revenue Funds, when we're wondering how we're going to pay the bills for services that have already been provided, I think is the wrong message to send to the providers of this State. I don't think there's anything worth doing in this supplemental today that has a higher merit than the bills that are already outstanding. I would urge a No vote.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Further discussion? Senator Brookins.

SENATOR BROOKINS:

Thank you. Will the Senator yield for a question? PRESIDING OFFICER: (SENATOR DEMUZIO)

Indicates he will yield. Senator Brookins.

SENATOR BROOKINS:

Senator Carroll, did I understand you to say that this was requested by the Governor of the State of Illinois?

### SENATOR CARROLL:

Yes, I know it might surprise you to consider me the spokesman for the Governor, but these are the supplemental requests that have come from the Office of the Governor.

Senator Brookins.

### SENATOR BROOKINS:

To the bill, Mr. President: I hold in my hand a note to call the Chicago Tribune to answer why there is going to be six months cut in Public Aid. Every time I return to Chicago I see people eating out of the garbage cans. I see people homeless and sleeping on the benches and et cetera. And I know that we have not funded -- are proposing to cut funding for mental health, the mental institutions, and et cetera. And here we're giving these funds for marinas, for other things. What -- what is my answer? Will you give me an answer? So that when I call this newspaper I can answer it intelligently? That's what I'm looking for. I think that Senator Severns said it correctly. Why are we voting for these things? Who wants them? Thank you.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator Fawell.

## SENATOR FAWELL:

Thank you, Mr. President. You know, I've been looking at a number of these things and — and very frankly, some of these things are — are necessary. We've got some — first of all, we've got some federal funds that if we don't match, I imagine are going to go by the wayside. We've got things like Jacksonville Developmental grants. We've got migrant day care for 107.5 million. We've got a hundred and fifty thousand to Chicago Family Resource AIDS Respite Center. We've got fifty million dollars

going to -- I presume that's DCFS, basically, isn't it? Children's Service Funds? We've got two hundred and thirty million dollars for dependent care programs and expansion of school-age day programs. If we don't hurry up and get supplemental passed, very frankly, July 1st is going to be upon us, and a lot of other people are going to be going out with not only services, but they're also going to go without their paychecks. Seems to me that we ought to seriously think that maybe somebody has sat down with both sides of the aisle and tried to come up with things that have to be done, and done now. None of us are going to like everything in here. I don't like the fact that the Donnelley Building is in here, but apparently Chicago seems to feel that's necessary. And I think we ought to vote Ave. PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. I -- further discussion? Senator Geo-Karis. SENATOR GEO-KARIS:

I'm sorry to speak up for a second time, but one more question of the sponsor.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Sponsor indicates he will yield. Senator Geo-Karis. SENATOR GEO-KARIS:

I've had nursing homes and hospitals in my area that haven't been paid for at least seven months. One nursing home, which is across the street from me - we owe them a million and a half dollars. Are we doing anything in this supplemental appropriation to take care of these bills?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Carroll,

No.

### SENATOR GEO-KARIS:

Well, Mr. President, Ladies and -- Ladies and Gentlemen of the Senate, I can understand some of these priorities, but I'm a little nonplussed, so to speak, since we haven't done anything about -- about paying those bills that we do owe. And we cannot put our people in nursing homes and the hospitals out in the streets. So perhaps maybe we should send this back for restruction <sic>.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Further discussion? If not, Senator Carroll may close.

### SENATOR CARROLL:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. These are the requests of the Office of the Governor for a supplemental appropriation. A significant number of it is federal dollars. However, in answer to a question that was asked to me off-mike, those funds that we had jeopardy of losing, to the best of our knowledge, we had already taken care of in other supplemental appropriations. These are funds that would become available, and it is a hundred and five million dollars, of which about sixteen and a half million is General Revenue. I would ask for a roll call.

# PRESIDING OFFICER: (SENATOR DEMUZIO)

Question is, shall House Bill 3-7-5 pass. Those in favor will vote Aye. Those opposed, Nay. The voting is open. Have all voted who wish? Take the record.
