Senator Leverenz, Chairman of the Committee on Commerce and Economic Development, reports House Bill 3201 Do Pass.

### PRESIDENT ROCK:

Senator Demuzio, for what purpose do you arise, sir? SENATOR DEMUZIO:

Two purposes, Mr. President. First of all, to announce that Senator Rea is not here today due to illness, and probably will be joining us sometime as soon as he's recovered. It's a privilege to join my colleagues in recognizing and congratulating Al Grant on his dedicated service to this State in the way of rural health. And I know that when I first came to Springfield a few years ago, I could not believe there was a mentality that existed that kind of understood what I was talking about in deep south, but that was the man that I found that was
