First Conference Committee Report on House Bill 945.

PRESIDENT ROCK:

Senator Lechowicz.

SENATOR LECHOWICZ:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. The Conference Committee Report on House Bill 945 deletes the Senate Amendment No. 1 and provides that the purchasing — as one of the factors of the Metropolitan Water Reclamation District, that the purchasing agent may take into account in determining the responsibility of any bidder, whether equipment or materials are manufactured in North America. We passed this bill out of here some time ago — in a previous — a couple of weeks ago in reference to purchasing out of America. At the request of the sanitary district, in the House, they wanted to include North America, and that's what this Conference Committee does. So I move the adoption of First Conference Committee on House Bill 945. And this contains an immediate effective date.

It's just a consideration that the purchasing agent at the district can take in consideration. There's really no objection to the bill, or to the Conference Committee.

Further discussion? Senator Schuneman.

SENATOR SCHUNEMAN:

Question of the sponsor.

PRESIDENT ROCK:

Indicates he will yield, Senator Schuneman.

SENATOR SCHUNEMAN:

Senator, many bills of this kind provide that bids can be

Further discussion? If not, the question is, shall the Senate adopt the Conference Committee Report on House Bill 945. Those in favor, vote Aye. Opposed, vote Nay. Basically what it does, it raises circuit court clerk fees in counties with a population

It raises certain fees in Cook County; provides a new disbursement method for court fees in all counties, and it's optional downstate. It preempts home rule, and raises court automation document storage fees from three dollars to five dollars. Basically, as I pointed out, it's permissive. Has to be approved by the respective county boards, and I know that Judge Wayne Andersen has talked to people from both sides of the aisle, and I would hope that the Senate does concur in the Second Conference Committee Report on Senate Bill 907.

PRESIDENT ROCK:

All right. The Gentleman has moved the adoption of the First Conference Committee Report on Senate Bill -- Second Conference Committee Report on Senate Bill 907. Discussion? Senator Fawell. SENATOR FAWELL:

Thank you, Mr. President and Members of the Senate. My Motion would be to concur with House Amendment No. 1 and to non-concur with House Amendment No. 2. House Amendment No. 1 is an agreed It deals with the DuPage County Airport Authority. amendment. What the bill did was to give Kane County a new member on the DuPage County Airport Authority and say that all new members appointed by DuPage should be done so with the approval -- advice and consent of the County Board. What the amendment does is to delay the new Kane County appointment until 1993. clarifies that the mayors of the two villages that are contained in Kane County within the Airport Authority are to make the appointments. That is, as I said, an agreed amendment; however, House Amendment No. 2 is not agreed, and I understand that the House will recede from Amendment No. 2. So I would, at this time, move to concur with House Amendment No. 1.

PRESIDENT ROCK:

The Gentleman has moved to concur with House Amendment No. 1 and to non-concur with House Amendment No. 2. Discussion on the motion? Senator Macdonald.

SENATOR MACDONALD:

What seems to be the problem here? This is a very much needed amendment for my district.

Yes. It was brought to my attention by President Rock, yesterday, on the same amendment which received fifteen votes, that there was objections to the provisions contained in House Amendment No. 2. Specifically, it involved quick-take and it involved quick-take that would last for twenty-four months. And you may recall the debate when that came up yesterday, I believe it was. And so as a result of President Rock's objections, I concur with his objections, and I indicated to those proponents of this measure that if it, in any way, affected the outcome of the underlying bill, that it would be cast aside and that's what we intend to do right now.

SENATOR MACDONALD:

I hope that everyone will understand that there is no residential property involved here. Although it is quick-take, certainly, I helped Senator Joyce (Holmberg) with her problem with Rockford Airport, and I have certainly done everything I can for every other airport understanding the need - transportation-wise - of airports in other people's districts. I would suggest to you

that this is an extremely important amendment for my area, and I would like some reconsideration over the rejection of that part of the -- Amendment No. 2 on this bill.

SENATOR KARPIEL:

Thank you, Mr. President. Well, in regards to Amendment No. 1 that we are concurring in, I've had several people ask me what I thought. I think this is a good amendment and I do support it.

PRESIDENT ROCK:

Further discussion? All right. The Gentleman has moved that the Senate concur with House Amendment -- concur with House Amendment No. 1 to Senate Bill 214. One of them creates the Attorney General's Task Force on Environmental Legal Resources. That was Senate Bill 232, by Senator Welch, that passed the Senate. It exempts from the jurisdiction of the ICC, motor vehicles hauling waste from the facility of the generator to the recycling facility - Senate Bill 66, Senator Woodyard, and House Bill 197, Senator Woodyard passed both Houses. Requires ENR to develop a large scrap tire disposal pilot program, targeted at piles over a million. Requires ENR to develop one -- implement a plan to eliminate large scrap piles. One pile shall serve as a demonstration project, and the results shall be reported to the General Assembly. white goods for landfills - Senate Bill 1439, that Senator Welch passed the Senate. Requires a fee of a dollar per tire sold at retail stores in the State - it's Senate Bill 1311 that Senator Philip passed the Senate. And also gives DOR the authorization to collect the fee and allow foam as cover in landfills - Senate Bill 296, that Senator Weaver passed the Senate. I'd be happy to answer any questions if there are any.
