The next amendment was a similar amendment affecting the water supply, and also it says that, "sludge from a waste water treatment plant shall be exempt from State and local waste disposal fees, provided the waste water treatment plant is operating pursuant to and in accordance with a permit from the And the additional provision added in Illinois EPA." the conference committee report creates a -- creates a pilot program for recycling at the Illinois State University concerning a proposed attempt to start recycling at universities throughout the State. Third, it's a university I'm somewhat familiar with, and I think that instead of going to the largest university, we should go to one that is more moderate in the number of students that they have. I think we have to start somewhere, and I think that's probably a good place to start.

PRESIDENT ROCK:

Senator Macdonald.

Well, Senator, you're from the DeKalb area and Northern Illinois University is there, which is a bigger university. And why -- why would you not have chosen Northern Illinois? PRESIDENT ROCK:

Senator Welch. SENATOR WELCH:

Well, I'm very familiar with Northern Illinois University, and because of that familiarity, I don't think they could handle this. So, I've decided to try to do it at Illinois State. I know that there is some interest down at Illinois State, and I thought that they might be best able to handle this.

PRESIDENT ROCK:

Further discussion? Senator Maitland. SENATOR MAITLAND:

Thank you very much, Mr. President, Members of the Senate. I wonder if the sponsor would yield for a question. PRESIDENT ROCK:

Well, I'm not going to mention any particular names. Let's just leave it at the point that this is a program we've been talking about, and I've been talking about putting throughout the State. What happened was, I -- I don't think it could work at every single university without a pilot project, and decided on Illinois State University to -- to be the pilot of the ship. PRESIDENT ROCK:

Senator Maitland.

# SENATOR MAITLAND:

Well, Senator, as you know, the night that I found this on my desk and realized what was happening, I -- I did ask you if the University knew anything about it and I think you implied that someone was going to share some thoughts with them. I did call the President that night about eleven o'clock, and I think, quite frankly, maybe got him up, but I thought it was necessary to call him, and he knew nothing of this project - quite frankly, told me that he wasn't interested in it, would like for the -- the conference committee report, as long as this was in it, to be defeated and further called me back the next day after thinking about it more in detail and was, frankly, upset as I was that this was being chosen for Illinois State University without them knowing it or without the local Legislators. And I, based -- it may be a good project, Senator Welch, I don't know. But I think, at this late hour, in this Session, with all the other problems we

have, to bring something like this before the Body, of this magnitude, is absolutely wrong, and I would ask my -- my colleagues on both sides of the aisle to reject this conference committee report.

PRESIDING OFFICER: (SENATOR LECHOWICZ)

Any further discussion? Senator Schaffer.

Senator, it would occur to me that a more logical way to approach this would be to direct the Board of Higher Ed to select an appropriate university that would be a willing recipient. I think all of us want to promote recycling, but to foist it on a university by surprise, without prior consultation, pretty well dooms your project. I would strongly suggest that we go to another conference committee and ask the Board of Higher Ed to negotiate with the several universities and find a volunteer that would get into the program with some enthusiasm, or you may, in fact, doom what you're trying to do.

PRESIDING OFFICER: (SENATOR LECHOWICZ)

Any further discussion? Senator Welch, to close. SENATOR WELCH:

Well, I think Senator Schaffer makes a good point, but I have to respond to Senator Maitland. Senator, to say that this is such late date and such a major project as this - this is just a а project to get a university to recycle paper and aluminum and This isn't going to be an earth-shattering program. cardboard. This is a very small program. To say that the President of the University was shocked, well, maybe when you woke him up at eleven o'clock he was. He never bothered to call me when they decided to put a branch office in Peoria. I think that kind of surprised me too, and since I'm the one -- since I'm the one sponsoring their budget bill, it would have been nice of the President to call me to let me know, because frankly - well, I'll

use the word that I'm shocked, too, I guess, since that's the word of the day. But let me just say that I think that it's a -it's a bit absurd to rail against a pilot recycling project at a university where they should all be doing it anyway, and say that this is a major innovation in legislation in a conference ... I mean, this is a little bit of overkill, Senator Maitland. I would ask that we dump this conference committee report and ask for a second conference committee.

There'll be a Democratic Caucus, immediately in 212. Senate stands adjourned.
