It has strong support of the AFSCME and also AFL-CIO; has very strong support in this Body. And I ask that we override the Governor's veto, and let those persons who are retired receive their life insurance.

All right. The Gentleman has moved that Senate Bill 1059 pass, the veto of the Governor to the contrary notwithstanding. Discussion? Senator Madigan.

Thank you, Mr. President. Unfortunately - and on this issue I must rise in opposition to this Motion to Override - the fiscal cost of this is two hundred and eighty thousand dollars. The premium cost, according to our analysis, can run up over a million dollars. Based upon what's happened in the last couple days, and our own Economic and Fiscal Commission, and the other things that we've done, I really think - although I admire what Senator Jones is trying to do here - that we simply cannot afford this measure. And I think that we should come back with this in the Spring in perhaps another bill, and try to take care of these people who may or may not have some life insurance, for those people that have retired back prior to 1966. Unfortunately, I must ask everybody to sustain the Governor's veto on this.

Further discussion? Further discussion? Senator Jones, to close.

## SENATOR JONES:

Thank you, Mr. President. With all due respect to the minority spokesperson, I don't know where he pulled those huge figures from. They must have got them out of the sky somewhere, but that is not the case. There is no million dollars of cost We're talking about a mere hundred and this fiscal year. seventeen thousand dollars, and this is what CMS estimate that the cost would be for the current fiscal vear. So these million-dollar figures that he's throwing around -- actually is not applicable to this piece of legislation. And I know he believes in it. That's the reason why he supported it when it was this Body, as well as all the other Members on the other side of the aisle. And ask for a favorable vote on this override.

## SENATOR MAROVITZ:

Thank you very much, Mr. President. This bill, Senate Bill 934, automatically enjoins any party to a dissolution action or

his agent from encumbering any property, abusing each other or or removing any minor child from Illinois without court order. Ιt establishes that the valuation of property -- of marital property shall be determined at the date of trial. This bill, as we amended it yesterday, is the same as the original Senate Bill 548, which was passed by both Houses without a particular provision, which the Governor found objectional <sic>, and he vetoed the bill because of that objection. In his veto message, the Governor said that he had no problem with any other parts of the bill except one particular part which he found objectionable, and which this Body removed in toto yesterday from the bill. As the bill stands, there is absolutely no objection from anybody - all the -- all the judges that deal with child welfare and matrimonial cases, attorneys, the women's groups, the men's groups. There is no opposition to the bill, and it protects children in divorce matters without having to go in and -- get costly fees and court costs. I would ask for a -- a total agreement on the bill.

### PRESIDENT ROCK:

All right. The Gentleman has moved the passage of Senate Bill 934. Discussion? Senator Schaffer.

# SENATOR SCHAFFER:

Mr. President, if the sponsor would yield.

# PRESIDENT ROCK:

Sponsor indicates he will yield, Senator Schaffer.

# SENATOR SCHAFFER:

Senator Marovitz, I believe we're talking -- the objectionable part had to do with that statute of limitations on the ability to claim. Or are we on a different issue?

## PRESIDENT ROCK:

Senator Marovitz.

## SENATOR MAROVITZ:

Different issue. This had nothing to do with statute of

SENATOR SCHAFFER:

So this bill in no way impinges on that issue? What is the status of that issue?

PRESIDENT ROCK:

Senator Marovitz.

SENATOR SCHAFFER:

The Governor did an amendatory veto. Is that a House bill coming over?

PRESIDENT ROCK:

Senator Marovitz.

SENATOR MAROVITZ:

That --

PRESIDENT ROCK:

SENATOR MAROVITZ:

That's House Bill 658, which is in the House right now. It has nothing whatsoever to do with this.

PRESIDENT ROCK:

SENATOR HAWKINSON:

Thank -- thank you, Mr. President. Just to confirm that our staff indicates that the -- the objectionable parts -- or the controversial parts of this bill have been removed. You didn't mention it, Senator, but as I understand it, any reference to periods of cohabitation have also been removed?

SENATOR MAROVITZ:

That is correct. It was removed by amendment yesterday.
