Thank -- thank you, Mr. President. House Bill 2515 amends two statutes. First, it amends the Public Utilities Act to allow the Illinois Commerce Commission to adopt rules for verification procedures when telecommunication companies change consumer -- customer's -- their consumer's carrier. These rules are compatible with the Federal Communication Commission verification procedure. Second, the bill would amend the Consumer Fraud Act. It allows the Attorney General to file actions to enforce the FCC rules against "slamming" as a deceptive practice. Also, it allows some exemptions on the 9-1-1. All these -- all this language is agreed to by all involved: AT&T, Ameritech, GTE and the Illinois Commerce Commission. So that's basically what it does. A lot of it is technical. If anyone has any questions, I'll try to answer.

Any student found to be a nonresident may be charged tuition by the school board. It provides that any person who knowingly enrolls, or attempts to enroll, a student who is not a resident on a tuition-fee {sic} (tuition-free) basis shall be guilty of a Class C misdemeanor. I would ask for a favorable vote, and answer any questions.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Is there any discussion? Senator Molaro.

SENATOR MOLARO:

This is a point of order. We seem to be having a problem with our computer screen. We're neither getting the bills, nor the analysis, and it's very difficult to vote on these with at least not getting some synopsis of what the bill does. Not that the speaker's not doing a great job explaining it. The Senator is,

Senator Molaro, it's my understanding that every Member also, in addition to the computer on your desk, has a hard copy in your binder of your bill and your staff analysis. And I would suggest you speak to your staff person. If he did not place it on your desk, ask him where they put it. Senator Palmer.

SENATOR PALMER:

Thank you, Mr. President. A question of the sponsor.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Sponsor indicates she will yield. Senator Palmer.

SENATOR PALMER:

Senator Parker, I understand there was some opposition to this bill, in that the argument was made that it's too narrowly defined as far as who is the custodial keeper of children. Has -- have you had any discussion? My analysis shows that you were going to hold it on 2nd to have a meeting. Has the meeting gone forth?

Yes. That meeting has gone forth, and the bill was amended. There was a concern between -- they had SCOPE and School Management Alliance on the one concern, and the other was with a legal aid lobbyist and Department of Public Aid. They did meet. They have come to an agreement. And what it was is that we added on, as an amendment, we added on two separate additional clarifications for residency. One was custody exercised by an adult caretaker who is receiving aid under the Illinois Public Aid Code for the pupil who resides with that adult for reasons other than having access to the educational programs of the district. So that -- helped Public Aid. And the other that we added was

I urge an Aye vote.

Thank you, Mr. President, Ladies and Gentlemen of the Senate. House Bill 3436 came to the Senate on a unanimous vote by the House, because it dealt with the stopping of motor vehicles on railroad tracks. And the changes were supported, and are supported, by the School Bus Transportation Association and the Illinois Railroad Association. In committee we added several amendments. One was to require all school buses, whether they're in charter service or not, to stop at railroad crossings. We had a amendment that would allow that school pre-trip inspections could be done by mechanics, rather than the driver, because they're better acquainted and better qualified to do so. We also had changed the vehicle widths as created by the National Highway System. That was supported by IDOT. We closed a loophole in the railroad grade crossing law, and it's supported by the Illinois Commerce Commission. And the last amendment was requested by the Township Officials, which dealt with the commercial drivers' license Act about the drug and alcohol abuse testing for small townships under three thousand population. And I'll answer any questions; otherwise, I'd ask for your support.

Thank you, Mr. President. Will the sponsor yield?

We had a roll call on this vote last year, which was 49 to nothing, even when it included some other unrelated matters.
