We sent it to the House. It was reviewed there and subsequently It went to the Governor's desk. The Governor had an amendatory veto with some technical language. I moved to concur -- or, accept the Governor's amendatory veto language in November during the Veto Session. And unfortunately, Senate Bill 51, when it went over to the House, got hung up when they abruptly adjourned in -- I believe it was November 14th. So the -- the provisions of Senate Bill 51 were added by the House as an amendment to Senate Bill 515, and -- including the -- the Governor's amendatory veto language. So I would ask everybody in the Chamber to support me in -- in this motion. If there are any questions, I'd be happy to answer them.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Any -- any further discussion? Senator Jacobs.

# SENATOR JACOBS:

Thank you, Madam President, Ladies and Gentlemen of the Senate. Is -- is this the bill -- because we just got this and I'm not that aware of what we're talking about, Senator. Last

year we -- we passed some legislation that -- that increased the amount of -- of value that you could build into a home without paying the taxes for a period of five years. Is that included in here, or is that the legislation we're talking about?

Chapman & Cutler came in and objected to some of the demographic information that was used. They made some suggestions as to cleaning this up, and that's what this does. This cleans up the language so the Triad District can go ahead with their building program.
