It also includes changes that were recommend by Equip For Equity {sic} (Equality), and these changes require the consultation with the disabled person as to his preference as to the standby or short-term guardian. There's several items that were added by the Bar Association that have to do with probate, and this bill is supported by the Chicago Bar Association, the Guardianship and Advocacy Commission and Equip for Equity. I ask for your support of House Bill 2367.

Senator Lauzen.

SENATOR LAUZEN:

Thank you, Mr. Chairman. The Illinois Franchise Disclosure
Act was passed in 1974, twenty-five years ago, and prior to the

enactment of federal disclosure requirements. House Bill 3463 simplifies and reforms the Illinois franchise registration process by removing unnecessary paperwork while preserving remedies available if there is fraud and other disputes. It brings Illinois into uniformity with thirty-eight other states and makes franchising opportunities more available to Illinois citizens, House Bill 3463 has the both as franchisees and customers. support of the Illinois Chamber, Retail Merchants Association, Marketers, Restaurant Association, NFIB Franchise Association. Ι International And distributed approximately thirty letters of support from franchisees and franchisors from across the State. I'd like to express my appreciation to Senators Obama, Jacobs and Tom Walsh for their bipartisan sponsorship of the legislation. This passed the Judiciary Committee 9 to 1.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Is there any discussion? Senator Jacobs.

SENATOR JACOBS:

Yes. Would the Senator yield for some...

PRESIDING OFFICER: (SENATOR DUDYCZ)

Sponsor indicates he will yield. Senator Jacobs.

SENATOR JACOBS:

For legislative intent, Senator: Why is this legislation needed in Illinois?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Lauzen.

SENATOR LAUZEN:

House Bill 3463 is intended to reduce red tape for companies trying to do business in Illinois. Of the twelve states that still require franchisors to register with the State, the registration and review process in Illinois is widely considered to be the most onerous and time-consuming. This process is no

longer needed because the FTC promulgation of its Rules on Franchising in 1979. This bill makes Illinois consistent with the federal rule and the thirty-eight other states that have decided to follow FTC format.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Jacobs.

SENATOR JACOBS:

Senator, how will this bill affect business -- businesses franchising in Illinois for the first time?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Lauzen.

SENATOR LAUZEN:

As they already do, first-time franchisors will be required to file a Uniform Franchise Offering Circular with the Attorney General's Office. The AG's Office will have twenty-one days to determine whether the UFOC is materially deficient as defined by the UFOC Guidelines published by the North American Securities Administration {sic} (Administrators) Association. Office will no longer be able to go beyond the NASSAA {sic} (NASAA) Guidelines. If the UFOC is missing material information that would directly impact a potential franchisee's decision to invest in the system, the AG's Office can prevent the franchisor from selling franchises in the State. The review standards are described in General Instruction 260 of the NASAA Guidelines, which calls for a summary rejection of incomplete filings. The purpose of House Bill 3463 is to eliminate the excessive delays and inconsistent and unreasonable reviews that exist today - any -- any review should be limited to gross deficiencies in the UFOC. PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Jacobs.

SENATOR JACOBS:

How would renewals be affected?

Senator Lauzen.

SENATOR LAUZEN:

Thank you. As with the current law, House Bill 3463 requires franchisors to file a copy of their UFOC with the AG's Office once a year. Like changes that have been made in Michigan and Wisconsin, this would be a filing requirement without any -- without any required review process. However, if a company fails to comply with the requirements of this bill or the UFOC Guidelines published by the NASAA, the State maintains the right to issue a cease and desist order. In addition, House Bill 3463 in no way changes the tools available to the State or private parties to take civil or criminal actions against fraudulent operators.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Jacobs.

SENATOR JACOBS:

Senator, what if a material change occurs in the UFOC in the interim?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Lauzen.

SENATOR LAUZEN:

Consistent with the FTC Rule, amendments to the UFOC will need to be filed with the State within ninety days of the occurrence of the event that causes the material change. Like renewals, amendments would be treated as a mere filing requirement. However, the AG's Office would continue to be able to use all previous mentioned enforcement tools to prevent companies with material-deficient UFOCs from conducting business in the State.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Jacobs.

SENATOR JACOBS:

How would franchisors currently doing business in Illinois be treated in the transition?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Lauzen.

SENATOR LAUZEN:

Since everyone currently doing business in Illinois has already had their UFOCs thoroughly examined at least once, filings made by these franchisors should continue to be treated as renewals/amendments after this bill takes effect.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Jacobs.

SENATOR JACOBS:

Just one final question. Would the Attorney General's Office continue to review advertising?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Lauzen.

SENATOR LAUZEN:

No.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Any further discussion? Senator Geo-Karis.

SENATOR GEO-KARIS:

Mr. President and Ladies and Gentlemen of the Senate, I think this bill really is a horrible bill, because it affects the rights of the small franchisees. The small franchisees are at the mercy of this bill if it is passed. I might tell you that I have a quotation here from one of my constituents. Quote, "For over twenty years the Franchise Disclosure Act has kept unscrupulous sellers of franchisees out of the State, and that's exactly where we want to keep them." End of quote. I might also tell you that the information that the present Franchise Act requires would be eliminated to a great extent, and I — I might remind you also the State Bar Association is opposed to the bill and rightfully so.

And I talked with the Attorney General's Office, to the Attorney General himself, and they're -- they're neutral on the bill. They didn't come out in favor of the bill. They're neutral on it. And there was an inference that -- that they were for it, which is not so. They are neutral on the bill. The State Bar Association had made some suggestions for an amendment to the bill which would safeguard the rights of the small franchisees, the people who buy the White Hen Pantrys, the convenience stores and what have you. Those are the small businessmen, and we're going to hurt them if we pass this legislation. This bill is a travesty and injustice of the small franchisees. The big ones have plenty of money to compete, but the small ones are limited. I ask you for a No vote on this bill.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Any further discussion? Senator Carroll.

SENATOR CARROLL:

Thank -- thank you, Mr. President, Members of the Senate.

Question of the sponsor, if I might.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Sponsor indicates he will yield. Senator Carroll.

SENATOR CARROLL:

Having just read a little bit about it, it seems that you're saying that the AG has certain -- the Attorney General has certain powers to stop an offering of a new franchise if there are materially deficient informations in the filings. However, it doesn't apply to any existing franchisor in the State, who might likewise have given deficient information to a potential franchisee. Why are we not, you know, having the same standard whether it's a new company coming in or an existing company that's trying to rip off the franchisee?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Lauzen.

Thank you, Senator. What I can do is refer back to -- I think that the premise of your understanding at this point in your review may not be accurate, at this point. The Attorney General -- from Judiciary Committee -- several of the Members of Judiciary Committee had asked me then to follow up with the Attorney General's Office to get clarification of what their neutrality In a document that comes from -- that's titled "Attorney General Fact Sheet" from their office, there are two statements think answer the thrust of what you're asking and -- and your concern. Because we're all concerned that people are protected within the State of Illinois. Number one, quote, "The Attorney General is losing no power to issue enforcement orders under Senate {sic} Bill 3463." And then later on in the paper, says, quote, "When compared to the Attorney General's authority to take enforcement actions under the Consumer Fraud Act, the Attorney General has more power under House Bill 3463."

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Carroll.

SENATOR CARROLL:

Thank you. Senator Lauzen, I -- I'm sorry, but that doesn't answer the question. And the question seems -- Illinois is known to have the most protective, to franchisee, law in the nation. Now, if you're saying that for a new company coming in here that's never done business in Illinois, we're empowering the Attorney General to stop them from doing business because of some fraudulent or -- or misleading or -- or insufficient information, but we're not giving the same protection for all of those who are already here -- I don't care if they can go under the Consumer Fraud Act. They can go under, you know, the speed limits Act, but it has nothing to do with the information they're required to give and the protection to the investor, the person who's putting their

life savings into it, because it happens to be a franchise that's preexisted in Illinois that can suddenly be giving out either misinformation or insufficient information that the current franchise disclosure laws give certain powers to the Attorney General to stop them from doing. This law seems to take away that enforcement activity. Even if the Attorney General doesn't care, that's not who we're protecting.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Lauzen.

SENATOR LAUZEN:

Senator Carroll -- well, I would refer you back to the bill itself, and it -- it says that any franchisor, in making any amendment, it's within the standard -- the federal standard of the Uniform Franchise Offering Circular, and it says in the bill on page 12, lines 8 through 11 - and this -- this applies to any amendment which covers any existing franchisors in the State, which I think is the concern that you're addressing - it says, "(2) that the disclosure statement or any amendment thereto includes any false or misleading statements of a material fact or omits to state any material fact required to be stated therein or necessary to make the statement(s) therein not misleading..." It's under that description that the Attorney General could stop the franchisor from doing business in Illinois.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Carroll.

SENATOR CARROLL:

Part of the issue, though, dealt with incomplete statements where the AG has power now. And under your proposal, the AG can stop a new franchisor for incomplete statements, and -- but cannot do it for a -- if it's a new franchisor, but cannot do it if it's an existing franchisor. Why? I mean, why are we doing that?

PRESIDING OFFICER: (SENATOR DUDYCZ)

SENATOR LAUZEN:

Again, I would have to refer back to -- you know, I -- I would love to have the legal background that you do, Senator Carroll. However, my background actually is more as a franchisee, as an accountant. I have to refer back to what the Attorney General, himself, and his staff says when it says -- addressing your question, I think, and your concern directly, not avoiding the issue that you're referring to, because your concern, I believe if I'm wrong, correct me - is that you don't want us to any way diminish the enforcement powers that the Attorney General has. And again, in the Attorney General's statement, the Attorney General is losing no power to issue enforcement orders under this Senate bill -- or, under this House bill. And then it says, again, emphasizing that point, that we're not putting anyone at risk in this House bill, quote, "When compared to the Attorney General's authority to take enforcement actions under the Consumer Fraud Act, the Attorney General has more power under House Bill 3463."

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Carroll.

SENATOR CARROLL:

I guess, then, my concern is really this, and maybe it's an answer to which you're not aware, because it may not have been raised this way before. My concern is not the Attorney General; it's the franchisee. And since we've had the one that's protected the citizens of Illinois in investing greater than the federal, to say that they'll now go under the federal doesn't protect them. We've had better. Obviously, there's things in here that are not as good for the franchisee, as protection, than existing law, or there wouldn't be the effort to change it. This seems to be one area where they're saying that — that while you may have

protected it against some new company coming into Illinois, you've diminished the franchisee's rights for an existing franchisor who -- who has filed something misleading. I don't care that this is -- that the new version is better than the Consumer Protection Act, 'cause the existing law is better than this. So we're still taking away, it seems to me, protections of the franchisee, the people of Illinois who are investing in -- you know, I don't want to pick any name, but a small business where they're putting their savings into some kind of franchise and now have great protections in Illinois. And we're saying we want to take away some of those protections, and I don't see a logical reason for it.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Any further discussion? Senator Geo-Karis, for a second time. SENATOR GEO-KARIS:

Mr. President and Ladies and Gentlemen of the Senate, I apologize for speaking a second time, but I echo the concerns of Senator Carroll. We are taking away the protections from the small franchisee, and our law, present law, has been the best one in the country. Why do we want to deny the proper protection to the small franchisees? And I can tell you I've had a number of them in my — in my district that have been — have had some very horrible situations. I ask you for a No vote on this bill.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Any further discussion? If not, Senator Lauzen, to close. SENATOR LAUZEN:

Ladies and Gentlemen, Ι would just say that the characterization of the franchise law -- disclosure law in Illinois as the best in the country is -- is badly misleading. recognized as the most cumbersome, slow in the country, and this is an attempt to correct it. I think that the benefits of franchising to the people of Illinois come in two major areas: first of all, to the consumers, where you have

consistent quality at low prices, and, number two, to the small business owner. I am a franchisee. For the last ten years of my life, I've sent royalty payments that are twice my mortgage payment to the franchisor, and within the last two years, have renewed my -- my contract -- my franchise contract. So I believe that I speak for the small business owner, with actual life experience in this area. It reduces the risk -- franchising reduces the risk of failing in business. Four out of five who go into business are out of business in five years, from federal statistics. You exchange royalty payments for the accumulated experience of the franchisor. You pay not to make the same mistakes that many others before you have made. Let's simplify it, make these opportunities more available to citizens Illinois.
