Is -- is that a limiting change that will knock out any school district that is smaller than four thousand from the benefits of this Act? And if so, why?

PRESIDING OFFICER: (SENATOR DONAHUE)

Senator Butler.

SENATOR BUTLER:

Yes, it's a limiting factor.

PRESIDING OFFICER: (SENATOR DONAHUE)

Senator Hawkinson.

SENATOR HAWKINSON:

Why do you intend to limit this to larger school districts - the benefits of this bill?

PRESIDING OFFICER: (SENATOR DONAHUE)

Senator Butler.

SENATOR BUTLER:

I think it was an effort to limit the exposure on this, in order to tighten up the window.

PRESIDING OFFICER: (SENATOR DONAHUE)

Senator Hawkinson.

SENATOR HAWKINSON:

But why deprive smaller school districts of the benefits instead of, say, doing it in the reverse fashion? You could limit it by limiting it to smaller school districts, as opposed to larger school districts. What's the purpose of not allowing smaller districts the benefit of -- of this legislation? And could you explain -- remind us of what the benefits of this legislation are that we're now going to be not letting the smaller districts access?

PRESIDING OFFICER: (SENATOR DONAHUE)

Senator Butler.

SENATOR BUTLER:

I think -- I think it could've gone either way, Senator. But this was the result of some negotiations to -- again, to limit the exposure to those districts which would need it the most. You could broaden it; there's no question that you could've come at it the other direction. But I think, as a result of the negotiation, this was deemed to be probably the most effective and the least costly.

PRESIDING OFFICER: (SENATOR DONAHUE)

Senator Hawkinson.

SENATOR HAWKINSON:

Could you tell us what the benefits of this legislation are?

I mean, what kind of funding will this be? Is this -- is this for school districts needing alternative schools? Is this for those in financial distress? I see both mentioned in the Veto Message.

PRESIDING OFFICER: (SENATOR DONAHUE)

No. This strictly deals with financial-distressed schools. It has nothing to do with any other.

PRESIDING OFFICER: (SENATOR DONAHUE)

Senator Hawkinson.

SENATOR HAWKINSON:

Just -- so just to be clear: If a smaller school district -- and this is fairly large; anything under four thousand pupils would be deprived. I think most of our downstate districts would be smaller than -- than this. If any of those districts are in financial distress, they will not be able to access this -- this funding. Only those school districts with four thousand or more pupils as of the last school year will be able to access. Is that correct?

PRESIDING OFFICER: (SENATOR DONAHUE)

Senator Butler.

SENATOR BUTLER:

The best way to answer that is say it not only limited size, but it's also limiting in terms of the -- of the program, the length of the program. So it's -- it's a one-year program.

PRESIDING OFFICER: (SENATOR DONAHUE)

Senator Hawkinson, are you completed? Is there further discussion? Is there further discussion? Senator Butler, to close.

SENATOR BUTLER:

I ask for your favorable vote.

We've had increases of two hundred and twenty percent of helping people in respite care for their disabilities that we've shown throughout the State. And I think it's an excellent program. It has to report to the General Assembly by March 1st, year 2000. So I would ask that this technical change be approved. So I move to accept the specific recommendations of the Governor to Senate Bill 1838.
