SENATOR BOWLES:

Thank you, Mr. President, Members of the Senate. This bill maintains the current law for incarceration, parole, periodic imprisonment, and supervised mandatory release. It adds a new provision, however, which provides that any person who has been convicted of a sex offense perpetrated upon a victim less than eighteen years of age is entitled to visitation rights while that person is on probation or on conditional discharge, or that -that person has been discharged from probation or conditional discharge, only - only - after that person successfully completes a treatment program approved by the court. This is a trailer bill that Senator Hawkinson suggested, which clarifies that a person who is convicted of a sex offense perpetrated on a victim under the age of eighteen, is sentenced to probation or conditional discharge, can be granted visitation rights after completion of the treatment, rather than after the completion of their -- their sentence and treatment. In other words, they -- they can -- they can still be serving a portion of their sentence, but they must have completed the treatment approved by the court.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Is there any discussion? If not, the question is, shall Senate Bill 27 pass. All those in favor will vote Aye. Opposed will vote Nay. The voting is open. Have all voted who wish? Now what they've done Breese, which is -- which is to their credit, is they've gotten all the various groups together and have come up with what they call an agreement. Part of the TIF district money is going to be going to the school district. And the schools traditionally opposed this legislation. In Breese, both the Central High School and Breese Elementary support this because some funds will be going to -- to those schools for work that's going to be done. Now the -- the urgency of this, and the reason I'm trying to expedite this - this was part of the package that was put together last year by Senator Radogno - is that Breese Elementary will be receiving a school construction grant, and as a result of that, they're going to need -- need funds that it -- will be made available through the TIF district for a parking lot and a entrance and an exit of that parking lot. So there is a certain amount of urgency to this because the construction will begin soon. It was heard in the Revenue Committee and there was some questions, but I don't believe there was any opposition. There were a couple people -- or, one, I believe, individual who voted Present; otherwise, it passed out of the Committee without any opposition. I would ask for your support.

Thank you, Mr. President. Senate Bill 167 conveys two parcels of land on the campus of the Howe and Tinley Park Developmental Center in the Village of Tinley Park. Some fifty, fifty-five, fifty-six acres goes to the Village for nondevelopmental purposes. The State gets substantial remuneration for this. The one-and-a-half-acre parcel goes to United Cerebral Palsy, where they will build a one-million-dollar state-of-the-art facility to

treat clients in the communities, as well as clients from the two mental health facilities. There is no opposition. I would look forward to your support.

Thank you, Mr. President. Will the sponsor yield?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Sponsor indicates he will yield. Senator Walsh.

SENATOR T. WALSH:

Now, you said that part of it goes to United Cerebral Palsy. What is the -- the Village Tinley Park going to do with the other part of it?

PRESIDING OFFICER: (SENATOR DUDYCZ)

SENATOR MAHAR:

Thank you, Mr. President. I would say -- I'm going to guess and say, Tom, that about forty percent of that is wetlands, which will remain undisturbed. The remainder is for recreational open space, potential recreation trails, bikeways. They're going to -- wetland restoration. There'll be no houses developed there. It will not go to private purpose. It'll be strictly public purposes.

SENATOR RAUSCHENBERGER:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. Senate Bill 168 provides that in -- in cases where municipalities seek to disconnect from fire protection districts, that the citizens of the fire protection district may request a referendum by filing petition for it - a backdoor referendum - to put the question on the ballot. It has an effective date of January 1 or, January 1, 2000. So it doesn't affect anybody who is currently transacting or thinking about disconnecting. There's plenty of time for them to complete whatever transactions. The idea of municipalities disconnecting from fire protection districts, in many cases, in effect dissolves the other unit of government, and it's become controversial in a lot of areas where people who are residents of the fire protection district, property taxpayers of a -- of a unit of government created by referendum, have no rights in -- the decisions are being made by the village This simply gives them a backdoor referendum right and a future effective date.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Is there any discussion? Senator Cullerton.

SENATOR CULLERTON:

The sponsor yield?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Sponsor indicates he will yield, Senator Cullerton.

SENATOR CULLERTON:

How did you -- how did you determine that there should only be a one-percent requirement for the referendum being on the ballot - one percent of signatures? Why didn't you choose five percent?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Rauschenberger.

SENATOR RAUSCHENBERGER:

The -- the bill comes to us from the Fire Protection District, and I think what they would tell you is that when a municipality disconnects, it's generally because a municipality represents seventy or eighty percent. So it's a small number of people who are forced to lose their government, so they wanted a fairly low threshold for the backdoor referendum. We selected it 'cause we thought that was okay.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Cullerton.

SENATOR CULLERTON:

Is the Village of Hanover Park still opposed to the bill? PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Rauschenberger.

SENATOR RAUSCHENBERGER:

The Village of Hanover Park, I think, is opposed to anything the Legislature does that involves fire protection districts or municipalities. But I have had extensive conversations with them, letting them know that this bill is not effective until next year and it should not affect them in any way.

SENATOR O'DANIEL:

Thank you, Mr. President, Members of the Senate. Senate Bill 174 amends the Illinois Procurement Code and exempts concessions awarded by the Department of Agriculture for the sale of food and beverages and other goods and services at the Illinois State Fair and the DuQuoin State Fair. This -- this bill would totally exempt the food and beverage vendors from competitive bidding or be subject to waiver from the Governor of the State Illinois. I don't know of any opposition. There was a -- I talked to the Chairman of State Government Operations and he had no problem with us moving it on over to the House, if they want to change it a little. So, any questions, I'd attempt to answer, and if not, I'd appreciate a favorable roll call.
