Section 405/12 of this Act, that we're considering amending, was enacted to provide specific statutory authority for an affected minor's parents to act in a child's name for Section 2032A purposes as natural guardian and without a court

In '97, Congress decided to extend the principle of conditional estate tax relief to small business owners; therefore arose the need to update 405/12 of the Act to allow parents to take advantage of the new congressional legislation.
