And unfortunately, the wording as is in this bill at this point does not solve Eastern's problem, and I would request that we would be able to address that and only that in this bill.

I don't know how we're going to resolve the problem. The sale of the house is only going to be about two hundred thousand or thereabouts max. The -- the offset with respect to the housing allowance is twenty-four thousand a year. I'm willing to work with you on this, but I don't see how we're going to resolve this. Thank you.
