This bill provides, for the taxable year 2001 and thereafter, that the assessed value of real property owned and used by fraternal organizations chartered by the State of Illinois prior to 1900, or its subordinate organizations or entities, that prohibit gambling and the use of alcohol on the property and those members provide direct or indirect financial support for charitable works such as -- such shall be frozen by the chief county assessment officer at fifteen percent of its 2000 or fifteen percent of the assessed

value of the years it qualifies or qualifies after the 2000 assessment level. It also provides that additions and improvements made to the property subject to the assessment will also increase by the fifteen percent of the value of the improvement. The appointees shall provide the Commission with experience in areas such as, but not limited to, knowledge of miliary history, particularly the American Civil War, and the education of our citizens.
