School districts wanted to waive certain provisions of the school calendar, have the children in school less time so that they could afford more time for a -- teacher conferences. We thought that that was inappropriate. You don't want to shortchange the children. If you want a school conference, have it in addition to the days that are required. And then, secondly, there is a provision in here that affects North Pekin school district, and they were seeking to permit students from outside the school district to attend their school at a reduced tuition rate, and that was objected to by the State Board, as well as other Members of the Committee. So that's the sum and substance of the amendment. I'd be happy to answer any questions. Ask for your favorable consideration.
