Thank you, Mr. President. I rise to remind the Members of the Illinois Senate of the annual Sportsmen's Caucus next Monday night. We'll have our annual Legislative Sportsmen's Caucus and auction at the Fairgrounds, 6 o'clock, next Monday night.
