She's in the gallery behind me. mine from Wilmette. conceptualized, developed and produced a documentary film entitled "Refrigerator Mothers" which was broadcast nationally on public television and which has won many awards at film festivals, including the Grand Jury Prize at the Indiana Film Festival and the Florida Film Festival. The film has also garnered top recognition from national organizations, among them the Autism Society of America and the National Council on Family Relations. It was her own intensely personal experience, having a child with autism and raising that child, which inspired her to make that film. And I'd like to ask you all welcome her to the Senate today.
