And I think most business people does not have a

I mean, is that employer going to turn around and get sued and have to pay out money to this person because they're using the cover of being a volunteer firefighter?

What they have to do, they have to provide proof that they was on the firefighting and the fire district will have to write a letter saying the guy was on this fire and he left at 8:30. The cost of deduction for college savings participants capped at ten thousand will be approximately a savings of 2.2 million. But placing an equal ten thousand cap upon the deduction for Bright Start investments will save approximately -- I mean, the 2.2 million will be the cost, but capping the deduction on Bright Start investments will be a savings of approximately 1.5 million dollars. So, when ISAC comes and says they should be treated the same as Bright Start, I'm very enthusiastic to help them as soon as they'll give up their -- their -- their tuition guarantee, which they sold to us, I think, on -- on unrealistic grounds. So, I just caution Members that, you know, every time we see ISAC in here on this College Illinois!, it's another Randy Erford idea about how we can pay more of the costs. And, I just think that they need to be a lot more accountable on the whole program. I -- I realize you bring the bill in good faith and I'm going to vote for it, but College Illinois! is going to be a liability question in the future

I don't think this would have anything to do with the pending case. This is saying that the ICC should adopt rules. So, it would be prospective.

PRESIDING OFFICER: (SENATOR DeLEO)

Okay. Seeing no further -- I think -- I think you led off with "This is my last question." Senator Roskam.

#### SENATOR ROSKAM:

We have time to rewind the tape if you want to take a couple minutes. I'm sure -- I'm sure I have an independent recollection of not saying that. Last question. Thank you, Mr. President. I am informed that there is actually a pending case before the Commerce Commission. So, are you saying on the record here, Senator, that this would have nothing to do with the pending case?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Halvorson.

#### SENATOR HALVORSON:

Not necessarily. I don't know for sure if it would have something to do with that. I'm a -- we'll find out. How about if I take this out of the record today so we can answer all those questions for Senator Roskam, and we can do this tomorrow. PRESIDING OFFICER: (SENATOR DeLEO)

The sponsor indicates the bill be asked to be taken out of the record. Thank you. Okay. Moving right along on House Bills 3rd Reading, we have House Bill 5450 and with leave of the Body, we'll return to. Senator Collins, Senator Jacqui Collins, on House Bill 5562. Do you wish to proceed, ma'am? She indicates, Madam Secretary, she'd like to proceed. Please read the bill. SECRETARY HAWKER:

Senator Collins.

### SENATOR COLLINS:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. House Bill 5562 amends the Charter School Law of the School Code permitting the Chicago Board of Education to designate attendance boundaries for up to one third of charter

schools in Chicago. This bill is needed because some charter schools would prefer to accept students that are from the community near the schools since they were designed to serve low-income and at-risk students. Currently, however, there is no priority given to students based on geographic boundaries. Under the bill, attendance boundaries would be designated only if the Board determines that they are needed to relieve overcrowding or to better serve low-income or at-risk students. I would appreciate due passage of House Bill 5562. Open for questions.

PRESIDING OFFICER: (SENATOR DeLEO)

Thank you, Senator. Is there any discussion? Is there any -- Senator Cronin, for what purpose do you rise, sir?
SENATOR CRONIN:

For a question of the sponsor...

PRESIDING OFFICER: (SENATOR DeLEO)

Sponsor indicates she'll yield for a question, sir. SENATOR CRONIN:

Senator Collins, forgive me. I -- I was not in committee at the time that this bill was debated, and I just wanted to raise a -- a few concerns, if I may. You're aware that the -the -- kind of the history of the Charter School Law is that the virtue of the law is that it has few limitations, regulations and restrictions. And I don't necessarily disagree with what you're seeking to do here, but, you know, if you look at the history of what's happened with the Charter School Law in the last two years, we now have a law that was, you know, billed as a model in the nation because of its -- the -- the freedom and the discretion and the openness of it. Now they have to have a certain number of schools, have to comply with some of the union collective bargaining agreements. Now we have, you know, geographic boundaries that are -- need to be a consideration. I'm concerned that the Charter School Law is being limited gradually, and over a period of time, the virtue of the law will no longer be there. It will be just like any other school with a lot of the bureaucratic red tape and problems and challenges that many of the schools face. That's not your intention here with this bill, is it?

PRESIDING OFFICER: (SENATOR DeLEO)

#### SENATOR COLLINS:

I -- what I think this legislation does is it protects the intent of the original charter school legislation, because it does provide access to serve the low-income and at-risk children. That was the statutory language and the intent, initially, with the drafting of charter schools. This only -- and this is on the -- and this is not a permanent basis. If a school decides to participate in this, as far as the designation, it's not a permanent and they can always opt out of it. And it's at the discretion of the Chicago Board of Education.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Cronin.

#### SENATOR CRONIN:

Just for clarification and I don't know if you were a Member of the General Assembly when the bill came in. So unless your research about the intent of the law is different than my knowledge and, you know, recollection, the intent was not necessarily to create a -- a local school for -- not necessarily. The intent was to create an alternative, a school free from the bureaucracy, free from the red tape, to -- to -- to let creativity and teachers and parents and -- the community leaders to come together. I don't know how Chicago will choose which charters fall into the -- the third with the geographic boundaries. I don't know how they're going to do that, but this is certainly another -- imposition on them. And I -- I don't think it's a bad objective. I just want you to understand that this runs contrary to the intent of the Charter School Law.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Collins.

## SENATOR COLLINS:

Those questions did come up in committee, and since you weren't there, let me sort of revisit some of the questions that were raised. And I thought I had submitted some responses to the questions to all the Members of the Education Committee. Because the questions -- when the questions came up in the -- before the committee, I contacted the Chicago Public Schools to get information about the origin or the genesis of the charter

school legislation, as well as how would they select one-third of the schools. The information that I received indicated that the charter schools were at the initiative -- or the genesis of the charter school legislation was an initiative of educators who specifically wished to serve at-risk children. Now, the other -- in reference to the other inquiry, it also indicated that the schools that volunteer -- they would be able to volunteer. Only schools that volunteer for the designation would receive the designation and CPS will not impose the designation on a school against its will. As the bill states, we would only grant the designation to relieve overcrowding or to enable a school to better serve low-income or at-risk children.

PRESIDING OFFICER: (SENATOR DeLEO)

Any further discussion? Senator Obama, what purpose do you rise, sir?

#### SENATOR OBAMA:

Purposes of a brief question, Mr. President.

PRESIDING OFFICER: (SENATOR DeLEO)

A question. The sponsor indicates she'll yield for a question, sir.

## SENATOR OBAMA:

I was just curious whether the -- the charter school -- the alliance of charter schools that currently exists, whether this is a proposal that's been talked -- talked through with them and whether they've got a position on the bill. Because the -- I -- I -- I appreciate the intent. I know that there are charter schools in my area that want to make sure that they're -- also have a neighborhood feel to 'em. On the other hand, I also want to make sure that we're not constricting the nature of charter schools when the whole point of them was to make them a little bit different from existing schools. So -- you know, I won't pursue this line of questioning, I just want to find out what the existing charter schools think about this legislation.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Collins.

### SENATOR COLLINS:

Well, let me just say, I didn't hear from the charter school association or alliance. This bill did result from a

concern of your alderperson, Alderman Toni Preckwinkle, because she was concerned that she saw a lot of students commuting to the charter school. I think the University of Chicago wants to start -- in conjunction, start a charter school in your area. And she felt that the kids in the community -- because there's -- that area is going through a vast transformation with the public housing, she was afraid that the children who were inhabitants of the public housing and will remain in the community would be at a disadvantage because of the level of commuters coming in and the other residents, because no boundaries were set. So this was out of her concern and that's the origin of the -- of the legislation. And no one has contacted me in being in opposition to it.

PRESIDING OFFICER: (SENATOR DeLEO)

Thank you, Senator Collins. Seeing no further discussion, Senator Collins, to close.

SENATOR COLLINS:

I would just ask for a favorable -- vote.

Thank you very much, Mr. President and Ladies and Gentlemen of the Senate. This bill is -- this House bill is an initiative of the Illinois Attorney General, Lisa Madigan, which is being proposed to the General Assembly because of a -- an Appellate Court case, People versus AgPro, Inc., et al, of which a court narrowly interpreted Section 42(e) of the Environmental Protection Act to limit the ability of the AG or a State's attorney, in some cases, to go into court to craft a mandatory injunction to clean up a site or to change a site for the betterment of the -- the environment. This power was assumed to be implied in Section 42(e). Over the years, Attorney General Jim Ryan used this. He used it several times in Madison County when I was State's Attorney. Prior to that, Ty Fahner, Neil Hartigan used this. It's unfortunate that the Appellate Court narrowed this ruling. The Attorney General did appeal this to the Illinois Supreme Court. It's still at issue, but to clarify it over the summer and the fall, I would ask for an Aye vote. PRESIDING OFFICER: (SENATOR DeLEO)

Thank you, Senator. Is there any discussion? Any -- Senator Roskam, for what purpose do you rise?

SENATOR ROSKAM:

Thank you, Mr. President. Will the sponsor yield?
PRESIDING OFFICER: (SENATOR DeLEO)

Sponsor indicates he'll yield for a question, sir. SENATOR ROSKAM:

Senator Haine, what was the argument that the business groups used in -- in opposing the bill?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Haine.

#### SENATOR HAINE:

Senator Roskam, I'm not -- they argued, as I recall, in the committee, that it expanded the power of the Attorney General, which is narrowly correct if you're taking the post Appellate Court decision, which narrows the power. So this bill, in this window between the Appellate Court decision and the present day, is narrowed. So this bill would bring it back to where it was assumed to be prior to that Appellate Court case.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Roskam.

#### SENATOR ROSKAM:

So, in other words, the Appellate Court -- presumably looked at the statute and trimmed the powers of the AG. The business groups like that, and now you're saying let's -- let's give the Attorney General -- let's reassert that power. Okay. Now, I understand. You're nodding yes. Why do we need to do that? What -- what is happening out there that is being unmet and that the Attorney General needs more authority?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Haine.

#### SENATOR HAINE:

Thank you very much, Senator Roskam. I believe that the history of this great office, since Attorney General William Scott, has been to be proactive in environmental cleanup. I believe all these AGs, which I've cited all the way back to Attorney General Scott, have used the power of that office to -not only to prevent environmental damage, but to clean up sites, to encourage or to mandate through court orders sites to be put back into a pristine state or a good state. So, this is -consistent with the mandate of the Attorney General in the past, and it's consistent with this Attorney General's mandate. there are many sites where the Attorney General would want a court order crafted that would remake the site after the damage has been done. With this court order, it's arguable that the court would say you do not have that power. You may restrain a future violation, but you may not craft a court order or ask me, the judge, to craft a court order that would change the site to ameliorate the damage done.

PRESIDING OFFICER: (SENATOR DeLEO)

Seeing no further discussion, Senator Haine, to close, sir. SENATOR HAINE:

I would encourage an Aye vote. This is a consistent -this is -- this bill returns, as I say, a power that's within
the sound discretion of the Attorney General and the custom of
that great office.

This bill is crucial to older and ill adoptive parents, who otherwise would not be able to legally secure future adoption plans for children in their care. This House Bill -- I'm sorry. House Bill 6564 passed out unanimously from the Health and Human Services Committee, and I would appreciate a favorable vote.

## SENATOR CRONIN:

hopefully adopt it so we could take care of our downstate teachers.

#### SENATOR FORBY:

Okay. I would like to go ahead and pass this right now. The other bill's in the House. It's not out of the House yet. PRESIDING OFFICER: (SENATOR DeLEO)

Senator Brady, you want to put your light -- push your -- Senator Brady, for what purpose... Continuing question? And other question?

#### SENATOR BRADY:

Yes, Mr. President.

Senator, our staff informs us that that bill has been bludgeoned to the House Rules and is dead. Therefore, this would be our -- one of our few remaining options. But our staff tells us that that bill is in -- dead in House Rules.

#### SENATOR COLLINS:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. House Bill 6786 creates specific conditions of parole that, at the discretion of the Prisoner Review Board, will be

applied to persons who are currently required to register on the Sex Offender Registry for committing felony sex offenses. It is — this bill is an initiative of Attorney General Lisa Madigan. It is basically a first step in changing the way we treat sex offenders in Illinois, and constitutes the first phase of the — implementation of a comprehensive supervision program for sex offenders. The provisions of House Bill 6786 will apply to persons being released to parole or mandatory supervised release on and after the effective date. House Bill 6786 passed unanimously out of the Judiciary Committee and I would ask for a favorable roll call.

PRESIDING OFFICER: (SENATOR DeLEO)

Thank you very much, Senator. Is there any discussion?

Any -- Senator Geo-Karis, for what purpose do you rise, ma'am?

SENATOR GEO-KARIS:

Will the sponsor yield for a question?

PRESIDING OFFICER: (SENATOR DeLEO)

Sponsor indicates she'll yield for a question, ma'am. SENATOR GEO-KARIS:

In essence, I wasn't quite clear what your bill did. Now, this takes up sex offenders, and what are you doing about them?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Collins.

#### SENATOR COLLINS:

It codifies the conditions in which the sex offenders who have been released on parole or mandatory supervised --supervision would be -- how can you say -- conditions for supervision, basically, because now they have one size fits all for sex offenders. And so this looks at each case based on the type of crime. Sex offenders are not like car thieves or burglars, and so now when they're paroled, they don't get any kind of specific supervision based on the type of crime that they committed.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Geo-Karis.

#### SENATOR GEO-KARIS:

You mean to tell me that -- that a sex offender will get a particular type of supervision? Once he's a sex offender, he's a sex offender, isn't he?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Collins.

#### SENATOR COLLINS:

Yes. But see, the -- the supervision would be tailored to the sex offender. Right now if a sex offender is released, it's not necessarily based on the offender -- committing a sexual offense. He might be treated like a burglar or a car thief just because he's a parolee.

PRESIDING OFFICER: (SENATOR DeLEO)

Is there any further discussion? Any further discussion? Senator Righter.

#### SENATOR RIGHTER:

Thank you, Mr. President. Will the sponsor yield?
PRESIDING OFFICER: (SENATOR DeLEO)

Sponsor indicates she'll yield for a question, sir.

#### SENATOR RIGHTER:

Thank you, Mr. President. Senator Collins, I'm looking at our analysis that sets forth the condition -- the parole conditions that the Prisoner Review Board can impose, and I'm looking at number four, at least as it's written on our analysis. I don't know if it's number four in the -- in the legislation, but it says, obtain the approval of an agent of the DOC prior to accepting employment or pursuing a course of study or vocational training and notify DOC prior to any change of employment, study or training. What's the point in that?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Collins.

### SENATOR COLLINS:

To ensure that they do not come in contact with children or their types of victims.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Righter.

## SENATOR RIGHTER:

Last question. Thank you, Mr. President. Senator, is there a reason not to make some of these mandatory conditions of parole?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Collins.

### SENATOR COLLINS:

Well, as I understand it, this allows the Prisoner Review Board to apply to the person, the sex offender. It's a way of setting forth specific conditions that apply to the crime before they release them back to the community. It's still at the discretion of the Prisoner Review Board.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Righter.

#### SENATOR RIGHTER:

Thank you, Mr. President, for your indulgence. I understand that, Senator Collins. My question was that, are not at least some, if not all of these, appropriate to apply in all cases? I mean, would we not want, in all cases, where sex offenders are paroled, for someone to be watching where they might go to school because they might come in contact with potential victims?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Collins.

### SENATOR COLLINS:

One moment, please. Based on the information that I'm receiving from the legal counsel here is that we still would like to see that the Prisoner Review Board give them the discretion to make that determination.

PRESIDING OFFICER: (SENATOR DeLEO)

Okay. Seeing no further discussion, Senator Collins, to close.

### SENATOR COLLINS:

This -- legislation increases the restrictions on sexual offenders. It just codifies, puts into the statute, ways of patrolling and monitoring sex offenders to make all our communities safer. So I just -- it's restrictive. It just enhances the safety of our communities by mandatorily fitting the supervision to the offense. I don't know -- any other way to say it. I just ask for a favorable vote.

### PRESIDING OFFICER: (SENATOR DeLEO)

Thank you very much. The lady asks for a favorable roll call. The question is, shall House Bill 6787 {sic} pass. All those in favor will vote Aye. All those opposed will vote Nay. The voting is open. House Bill 6786. Let me make that clear. Have all voted who wish? Have all

voted who wish? Madam Secretary, please take the record. On that question, there are 54 Ayes, 1 voting Nay, 0 voting Present. House Bill 6786, having received the required constitutional majority, is declared passed. Senator Clayborne, on House Bills 3rd Reading, House Bill 6811. Senator Clayborne, wish to proceed, sir? Senator Clayborne seeks leave of the Body to return House Bill 6811 to the Order of 2nd Reading for the purposes of an amendment. Hearing no objection, leave is granted. On the Order of 2nd Reading is House Bill 6811. Madam Secretary, are there any Floor amendments approved for consideration?

#### SECRETARY HAWKER:

Floor Amendment No. 1, offered by Senator Clayborne.
