SENATOR LIGHTFORD:

They're looking to expand in economic development areas and would like to have the opportunity to increase their tax imposed, on retailers' occupation and their use tax, from a half a percent not to exceed one percent. #### SENATOR LAUZEN:

Thank you, Madam President. I would just like to -- let's see. To the bill: This -- this did pass out of committee, but there were -- over the objection of four No votes. The concern was that this enables a sales tax increase. It is in this location -- and I respect Senator Lightford's work to help this town in her area. I think that many of us recognize, along with the sponsor, may recognize that a sales tax is the most regressive type of tax that we have in the tax arsenal. The suggestion that increasing a tax, a sales tax, is going to help development is a contradiction in economic terms. So I would just suggest that those who are concerned about regressive taxes should vote No.

### SENATOR HENDON:

Thank you, Mr. President -- Madam President. I rise in strong support of this bill. Senator Lightford clearly knows the needs of her community, and I'd ask for support for her on this legislation. Thank you.

## SENATOR LIGHTFORD:

Thank you, Madam President. But the Village of Broadview is a non-home rule community. They're trying to expand in economic development and the correlation does work together. There's condominiums that they're trying to build and they're

right in the heart of O'Hare and Midway Airports. They're just wanting to allow themselves the opportunity to grow and expand with the many communities around them. And because it is referendum, this gives the voters the opportunity to put the onus on them, in terms of what they're trying to accomplish in their village. And I'd ask for an Aye vote.

PRESIDING OFFICER: (SENATOR HALVORSON)

The question is, shall Senate Bill 272 pass. Those in favor will vote Aye. Opposed, Nay. The voting is open. Have all voted who wish? Take the record. On that question, there are 26 Yeas, 29 -- Nays, none voting Present. And the bill, not having received the required constitutional majority, is declared failed. Senator Lightford.

### SENATOR HAINE:

It goes further and defines titration as the administration of a drug in small increments until the desired effect is reached. Creates a penalty for exceeding the maximum dosage. Allows licensing requirements for certain specialties. It's supported strongly by the Illinois Dental Society and the Illinois Dental Hygienists' Association. And I would ask for an Aye vote, if -- if you would assist me in extracting this bill from the Senate.

## SENATOR CULLERTON:

Thank you, Madam President, Members of the Senate. This bill deals with driver's education. We amend the School Code. It's supported by the Driver's Education Association and the Illinois Education Association. Currently, under State law, school districts are reimbursed for providing driver's training and the bill -- the law calls for six hours of driving a -- a car on -- on the road. There is a loophole in the law that allows for school districts to only have three hours of driving if they pass a proficiency exam, and unfortunately there's been abuses of

this and school districts have just been across the board exempting kids so that they only have three hours instead of six hours. So what we've done in this bill is to say, if the school does that, then the reimbursement would be reduced accordingly. Again, has -- I believe it passed unanimously - yes, it did - out of the Executive {sic} (Education) Committee, and supported by the IEA and the Driver's Education Association. I'll be happy to answer any questions.

Senator Forby.

### SENATOR FORBY:

Thank you, Madam Chairman. Senate Bill 299 consists of the Rend Lake Conservancy District Board. Former U.S. Representative Glenn Poshard has done a great job in leading the effect to clean up the operation of the district. I am working with State Representative Kurt Granberg on this legislation to allow the county board of Franklin and Jefferson County and the Mayor of Mt. Vernon and West Frankfort and Benton to replace the members to establish a new board if they see fit. The legislation would stagger the terms of the new appointments. A provision would be permitted that a trustee to be removed in case of incompetent, negative -- of duty, or malfeasance. This is an ongoing problem we've had in Rend Lake Conservancy District. I think this will be the last thing that will probably clean things up down there and make things right. So, a lot of mayors has called me. A lot of county boards called me and a lot of the people in the

district had called me, said "We still think there needs to be something done with the board." This will let the mayors or the county boards replace somebody if they want to. If they don't want to, they can put the same person back on. I'll try to answer any questions.

PRESIDING OFFICER: (SENATOR HALVORSON)

SENATOR J. JONES:

Thank you, Madam President. To the bill. I -- I spoke last fall with Senator Forby. This Rend Lake Conservancy District is in both of our home -- home counties. There has been a lot of problems there over the past couple of years really, with misuse of funds and the like, and -- and I think the present board is -is doing an awful lot in -- in cleaning that up. You know, they had a -- a temporary acting director there that -- that gave 'em a lot of guidance over the past several months. And they've hired a new executive director. And I think that -- that they're moving forward. But I still agree with Senator Forby to a certain extent that we need to do something to change this, and I have a bill that -- that hasn't been called yet in committee that -- that I think would do the right thing. My problem with this bill that -- that Senator Forby is presenting right now is I think it's going to set a precedence throughout this State that if people have problems with a board, they'll come to us to introduce a piece of legislation to dump that board and reappoint people. I think the appropriate way is, is the bill that I have introduced, Senate Bill 1951, that will make this board elected The people in both of our home counties, Jefferson next year. and Franklin County, will be able to go to the polls in November of next year and -- and vote a new board in there, and they will be responsible to all the elected officials and the constituents of the district, rather than just three mayors and two county board chairmen. So, I think this sets a bad precedence and -and, reluctantly, I'm going to have to vote No on it. And I request that my Members on this side of the aisle do the same thing.

But now we're going to appoint new people. How will that be different? You know, let's say that we don't -- you aren't happy or we're not happy with them, we -- are we going to do this again and appoint new people? It just -- it seems to me that it's sort of more of the same. Is -- is -- it -- tell me the difference between what we're doing now and what they -- what they presently do.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Forby.

### SENATOR FORBY:

You know, I don't disagree with John Jones, as to have 'em elected, but that's going to be a year down the road. The people want something done right now. So, if we do this now and it don't work, we still can have 'em elected down the road. I don't see a problem with that and that's why I -- why the people want to do it now. We have several different conservancy districts in the State and this is the way they appoint their boards and they haven't had any problem. So this system does work. I think the county board and the mayors think they can make it work. So I think they ought to have a chance to do that and I think we can see that in the next year. If that don't work, we can have -- be with John Jones and have 'em appointed.
