But, in fact, they're still going to be getting their paychecks, I think, from the Administrative Office of the Illinois Courts, which is the administrative wing of the Illinois Supreme Court. I mean, what's different -- what's -- what does this bill do that isolates us from that Supreme Court decision? PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Martinez. SENATOR MARTINEZ:

Thank you. Thank you, Senator. It -- it seems that for the past fifteen years the court reporters of the State of Illinois have been struggling to have the ability to be represented by the unions. It would just take and divide them into three different units. Each of the judge in that unit will be the ones to have

The bill only reauthorizes taxes that have been levied in the past and does not allow new taxes. It was supported by the Township Officials of Illinois. And I'd be happy to answer any questions.

The bill will also remove the requirement that a commissioner representing an area within the authority located outside a municipality must reside in that area. I know of no opposition.
