Since the executive form of government was enacted in Will County, this bill would change the appointment to the county executive with the full advice and consent of the county board in Will County, and it also adds two members that the county executive, with the advice and consent of the board, would get, to make that number nine members instead of With the regional growth in Will County, and since this does affect Will County, as opposed to simply Joliet, we believe that this is appropriate to expand the -- the number of members from seven to nine. This bill also has an amendment for the Waukegan district, which would basically make that number go from -- believe it's from two to four for the Mayor of Waukegan for a similar port district in Waukegan. I'd be happy to answer any questions and I ask for a favorable vote.

Under the terms of the bill, local law enforcement and local officials would have to instigate the installation by passing an ordinance. They would then work with the ICC and IDOT to install a -- a camera system that would monitor the grade crossing and police it. Citations would be issued and there are a full bevy of protections and -- and appeals within the legislation. As amended, I'm not aware of any opposition and I ask for your Aye votes.
