Today Illinois enjoys a great relationship and is second in the nation in trade with Mexico. Please join me in welcoming our guests. First, I'd like to hear from our colleague, Senator Marty Sandoval.

Personally, I think we ought to do this for all race -racetracks in Illinois. Racing is really hurting. Horseracing in Illinois is -- is declining rapidly and Fairmount is sort of leading the charge, so to speak, in regard to this. reduced the number of racing days and it has a huge impact on -just an economic impact on the whole metro east region. So, this is at least some means by which this track can get some additional funds and it -- and Bill's right, Senator Haine is correct that the -- the impact of this is not necessarily just at the racetrack, which is some four hundred jobs, I believe, there, but the ancillary people, the breeders and the trainers and those people that work in agriculture outside of the region that bring hay and straw and other animal products and other farm products to -- to the track, it's very important for them also. House Bill 4699.

(Secretary reads title of bill)

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Axley.

SENATOR AXLEY:

Thank you, Madam President and Members of the Senate. House Bill 4699 amends the Illinois Highway Code and is an initiative of the Township Officials of Illinois. Under current law, when a township's road mileage does not exceed four miles in length, the township road district is automatically dissolved. On occasion, a road district will enter into an intergovernmental agreement with a municipality to maintain some of the municipality's roads. House Bill 4699 provides that if a road district has entered into such an agreement with a municipality, the road miles covered by that agreement are included in determining a road district's

total road miles for the purpose of determining whether a road district should be abolished. The Illinois Department of Transportation is neutral on this bill and there is no opposition. I'd be happy to answer any questions.

PRESIDING OFFICER: (SENATOR HALVORSON)

Is there any discussion on Senator Axley's first bill? Senator Garrett.

SENATOR GARRETT:

Thank you. Senator Axley, are you sure you understand this bill? For instance, how many township roads are you talking about? How many are there and how many miles are you talking about specifically?

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Axley.

SENATOR AXLEY:

There are currently fourteen hundred and thirty-three townships in the State of Illinois. All townships would be subject to this new bill. However, in the -- in the Chicago metropolitan area -- in the suburban area, that is where the annexation by municipalities is taking place and those townships would be most subject to this bill.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Garrett.

SENATOR GARRETT:

...many townships are there? You didn't give me the number of townships that would be affected by this. You just gave me the miles.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Axley.

SENATOR AXLEY:

There are fourteen hundred and thirty-three townships in this State.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Garrett.

SENATOR GARRETT:

How many miles?

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Axley.

SENATOR AXLEY:

Senator Garrett.

SENATOR GARRETT:

So, Senator Axley, you're asking us to vote for something that we don't even know what we're voting for. We don't know how many miles are going to be affected and you don't know how many miles?

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Axley.

SENATOR GARRETT:

How can we support something like this?

PRESIDING OFFICER: (SENATOR HALVORSON)

Excuse -- is that a question, Senator Garrett?

SENATOR GARRETT:

Yeah, I think we need to know.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Axley.

SENATOR AXLEY:

...think we should support this bill because it is a great bill for all of the residents of Illinois who currently live in townships and who would like their roads maintained by their local township.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Garrett, please bring your remarks to a close. There's a lot of speakers.

SENATOR GARRETT:

Well, I $\operatorname{\mathsf{I}}$ -- I would just ask my colleagues to really think long and hard about this convoluted township road bill. Thank you.

PRESIDING OFFICER: (SENATOR HALVORSON)

Any further discussion? Senator Risinger.

SENATOR RISINGER:

Thank you, Madam President. Will the sponsor yield for a question?

PRESIDING OFFICER: (SENATOR HALVORSON)

Sponsor indicates she's in for the long haul.

Yeah, I'm -- I'm very concerned about my community of Peoria, Peoria Township. Can you tell me how this bill would affect Peoria Township?

Yes, if the township roads were to go under four miles, the -- the township road district would not automatically be abolished. If they would have an intergovernmental agreement to maintain municipality roads with the City of Peoria, then at the option of the township board, they could continue to have their road and bridge district.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Risinger.

SENATOR RISINGER:

Do you -- do you know how many miles Peoria Township has? I mean, are we getting close to that number or are we far away from that number?

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Axley.

SENATOR AXLEY:

No, Senator. In Peoria Township, I -- I do not know the actual number.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Risinger.

SENATOR RISINGER:

Whenever I drive down the road, I have a hard time telling whether I'm on a township road or a county highway or a city road. Is there some way that you could let me know or tell me how I know that I'm on a township road?

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Axley.

SENATOR AXLEY:

Well, you would probably have to contact your local township to find out exactly where those township roads are.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Risinger.

SENATOR RISINGER:

Are there -- are there any township roads in the City of

Peoria? Do you know that?

SENATOR CULLERTON:

I -- I'll end on that. That's fine. That's fine.

Okay. So when is the exact date that this bill will take effect -- the exact date?

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Axley.

SENATOR AXLEY:

Upon the Governor's signature.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Millner.

SENATOR MILLNER:

So, it's effective immediately?

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Axley.

Have you held hearings? Have you -- as the young gentlemen here next to me said, he asked a specific question, which I think bears greatly on what's going on here. Have you met with any other people to see how they feel about this issue?

Senator Axley.

SENATOR AXLEY:

I've -- I've met with the supervisors from my own area and

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Maloney.

SENATOR MALONEY:

Thank you, Madam President. Last year, this Body passed Senate {sic} Bill 2062. It had to deal with criminal background checks for residents of nursing homes. House Bill 4785 clarifies the process for which these background checks will be made. -- if -- if in fact a conviction does turn up, the Department of Public Health will do a criminal history report. In other words, they will make a determination as the best course of action as to how to handle the patient in the -- in the nursing home. For example, if the person is seventy-five years of age and the -the criminal background check shows that they stole a car thirty years ago, this wouldn't have any relevance to the other -probably wouldn't have any relevance to the other residents of the facility. However, if the background check does turn up some serious or crimes of a violent nature, then the Department of Public Health would have to deal with a -- a specific individual plan as to how to help that person. This does not -- this is not designed to prevent care. This issue was brought over a year ago as a result of several abuses that were found out in some of our nursing homes and this, I think, goes a long way to protecting the most vulnerable among us. I'd be happy to answer any questions.

PRESIDING OFFICER: (SENATOR HALVORSON)

Is there any discussion? Senator Righter.

SENATOR RIGHTER:

Thank you, Madam President. Will the sponsor yield, please? PRESIDING OFFICER: (SENATOR HALVORSON)

Sponsor indicates he'll yield.

SENATOR RIGHTER:

Senator, what you've described is a -- a system by which someone at the Department of Public Health, some -- an administrator at the Department of Public Health is going to look at the report that's been generated and make a decision about whether or not the crime that the potential resident committed was serious enough for what? I mean, if they decide that it's that serious, what happens and what are the parameters around which the decision's being made?

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Maloney.

SENATOR MALONEY:

My understanding is, is that Public Health gathers the information, provides the information to the facility and then the facility makes the decision as to how to deal with that particular individual.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Righter.

SENATOR RIGHTER:

Okay. So, the nursing home facility itself is deciding whether or not they want that person to come in, as opposed to someone in the Department of Public Health. Is that right?

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Maloney.

SENATOR MALONEY:

That's correct, Senator, and that's the process that's currently in place.

PRESIDING OFFICER: (SENATOR HALVORSON)

Is there any further discussion? Seeing none, Senator Maloney, do you wish to close?

The Fair Patient Billing Act establishes fair standards and responsible practices that all licensed hospitals, and the agencies they hire, must follow when they bill and collect debts Has multiple components. One is a patient notification of hospital financial -- assistance, where hospitals are required to conspicuously post in -- admissions registration areas notice of availability of financial assistance. They are required at time of -- admission or soon thereafter to notify patients in writing that not all hospital members participate in patient insurance plans consumers will be subject to out-of-network charges. On the patient billing process side, hospitals will be required to implement a -- a process for patients to inquire about or to dispute hospital bills. They will -- calls with regards to the inquiries about hospital bills will be required to be returned within a couple of -- two days. And patients will also have more detailed hospital bills and would be able to request a itemized With regards to collection actions by hospitals, hospitals would not pursue legal action for nonpayment of hospital bill against uninsured patients who have demonstrated that they have insufficient income and assets to meet their obligations and the hospital or their agents may only pursue collection actions after the uninsured patient has been given the opportunity to the -- assess the accuracy of the bill, apply for financial assistance under the hospital's financial assistance policy and avail themselves of a reasonable payment plan. And Jessica Housby deserves the best she can get and I appreciate your help.

I think this is a first step, quite frankly, toward that process. While I was hesitant to support it in committee, after having talked to some people
