Thank you. Thank you, Mr. President. House Bill 398 amends the rulemaking procedures of the Administrative Procedure Act to require an administrative agency seeking to promulgate rules to adhere to the rules and procedures of JCAR even if a court finds, for example, JCAR's power to suspend rules is unconstitutional.

PRESIDING OFFICER: (SENATOR MUNOZ)

Is there any discussion? Senator Hendon.

SENATOR HENDON:

Thank you, Mr. President. Just briefly to the issue. I will be voting with it, but just for the record, I wanted to make sure that Governor Quinn hasn't done anything wrong or given us any reason to take any power from him. I guess this is a residual effect from what we just did here with the impeachment of Governor Blagojevich. But it is not - and I ask the sponsor - it is not the intention of this legislation to have JCAR become more powerful than the Executive -- Chief Executive of our State? And I'll be voting for the legislation. PRESIDING OFFICER: (SENATOR MUNOZ)

Senator Rutherford.

SENATOR RUTHERFORD:

Mr. President, thank you. And I also want to congratulate you being in the Chair, President Munoz. It's nice to see you up there. I -- I've got a couple of -- well, one comment and then a question to Senator Clayborne. To Senator Hendon's comment, I would note that the Joint Committee on Administrative Rules has not met since Governor Quinn has taken the oath of office. So this is in reflection to previous administration, not a reflection on Governor Quinn's administration. I would

affirm that, Senator Hendon. The Joint Committee meets next Wednesday. Senator Clayborne, two questions. One of them is that this legislation would provide that if rules were promulgated that did not go through the Administrative Code, thus going before the Joint Committee, that they would be determined to be illegal or inappropriate and not applicable. Is that correct, Senator?

PRESIDING OFFICER: (SENATOR MUNOZ)

Senator Clayborne.

SENATOR CLAYBORNE:

That -- that's correct.

PRESIDING OFFICER: (SENATOR MUNOZ)

Senator Rutherford.

SENATOR RUTHERFORD:

Thank you, Mr. President. My follow-up question, then, Senator Clayborne: Also, in this legislation, I read that if rules are promulgated and a court finds that the Administrative Code or the Joint Committee invalid -- help me understand the logic how this statute could still have those rules continue to have the force of law.

PRESIDING OFFICER: (SENATOR MUNOZ)

Senator Clayborne.

SENATOR CLAYBORNE:

Well, Senator, I assume that because this is voluntary, that maybe the court will view this a little differently and say that the agency had the ability either not to promulgate rules or to promulgate rules, and when they decide to promulgate rules, then they decided to abide by our existing rules.

PRESIDING OFFICER: (SENATOR MUNOZ)

Any further discussion? If not, Senator Clayborne, to close. Oh, I'm sorry. Senator Jacobs, did you...

SENATOR JACOBS:

Just quick question of the sponsor.

SENATOR CLAYBORNE:

That's similar to what the previous Senator questioned me about. Basically, again, the same answer, is that this is voluntarily. I mean, they can volunteer not to promulgate rules, but if they decide to promulgate rules, then they'll abide by the rules of JCAR.

Seeing no further discussion, Senator Clayborne, to close.
