They make modifications of three categories of waivers. First, we are approving the behind-the-wheel waivers for one year only. Next, we are also denying one district's request to exceed administrative costs in order to give raises to their superintendents. And finally, we are capping the fee waiver request for a district at three-fifty at the request of the Senator.
