So -- this provides further -- further strengthens the argument as to why we need to override the Governor's veto. The first has to do with how it would -- potentially compromise the independence of the internal auditors. Secondly, it would inadvertently weaken the procurement officer for IDOT - the change that was being made - and we don't want to do that. And then -- and then finally, there -- it would shift the resources away from those independent auditors if they were to be moved to another agency, and that would have the net result of weakening our capacity to police how taxpayer dollars are being spent. I believe there'll be a follow-up trailer bill to this as well, that can hopefully move forward to greater progress. And I'd urge your support of the motion.
