Thank you, Mr. President. Today I'm also joined with -- by a very, very good friend. She's been my childhood friend for over thirty years. I see her wonderful son is also with her. He is -- actually graduated from -- from elementary school with honors, going on to -- to Holy Trinity. And I want everybody to welcome my best friend and my sister, Martha Torres, and her son, Daniel.

PRESIDING OFFICER: (SENATOR HARMON)

Guests in the gallery please rise to be welcomed to the Senate. Ladies and Gentlemen of the Senate, the Chair recognizes Senator Koehler for a serious point of personal privilege. Please give your attention to the gentleman.

SENATOR KOEHLER:

Yes. Thank you, Mr. President. We've had yet another tragedy in Central Illinois. In fact, there were two soldiers that were killed this past week, one from East Peoria and the other from Germantown, which I believe is in Senator John O. Jones' district. But I'd like to, after I read a little bit about Paul Smith, ask us to take a moment of silence to remember him and his family. Paul Smith, forty-three, was a Sergeant with the Illinois Army National Guard. He was killed Friday when the vehicle he was riding in was struck by an IED in

Kandahar, Afghanistan. Staff Sergeant Joshua Melton, twentysix, from Germantown, about forty-five miles east of St. Louis,
was also killed. And two other soldiers were injured. The
soldiers are all part of the 33rd Brigade Combat Team, deployed
last summer and fall to help train the Afghan Army and the
National Police. Smith's unit, Troop C, 2nd Battalion, 106th
Cavalry Regiment, was providing protection for Embedded Training
Teams and the Afghans when they were killed. They are the
thirteenth and fourteenth soldiers to have been killed from the
33rd. It's a tragic loss. It's a -- one that the family is
having to deal with all of a sudden. And I'd like us to
remember them in our thoughts and prayers, if you would take a
moment with me.

PRESIDING OFFICER: (SENATOR HARMON)

Please rise from a moment of silence on behalf of our fallen soldiers. (Moment of silence observed) WBBM-TV seeks leave to videotape the proceeding. Seeing no objection, leave is granted. Senator Meeks, for what purpose do you seek recognition?

And so my thoughts and prayers, I know along with the Senate here, goes -- goes out to both those families in -- in their great loss.
