It's the final and last piece of the transfer of the Thomson prison. And it will cause it, also, to -- we retain jurisdiction in the State. If something does go wrong and they don't follow through with the federal plans, then we will be able to take the jurisdiction back.

Thank you, Senator. Is there any discussion? Any discussion? Senator Righter, for what purpose do you rise?

SENATOR RIGHTER:

Will the sponsor yield, please, Mr. President?
PRESIDING OFFICER: (SENATOR HARMON)

Sponsor indicates that he will yield. Senator Righter. SENATOR RIGHTER:

Thank you, Mr. President. Senator, I know this is an issue on which you've worked for some time and I just have a few questions. I've not really been plugged into the issue, like I

know you have and the committee's work has been. What is the -- what's the sale price? What -- what is -- what is Illinois getting in exchange for transferring this prison site over to the federal government?

Well, as you may recall, Senator, when the prison was first built under Governor George Ryan, Republican Governor George Ryan, they built it for a hundred and forty million dollars. What was not included was the forty million dollars to open the prison. So, as you well know, the prison was never opened. We have currently sold the -- the prison to the federal government for a price of a -- exceeding a hundred and seventy million dollars. But most -- most importantly, I believe that -- the important thing is, the State will reap a benefit of a lot of jobs. And it looks to be up to a thousand jobs in a very small community in my district and we're just pleased as punch to be moving forward.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Righter.

SENATOR RIGHTER:

What will those people be doing? Those thousand jobs, Senator Jacobs, you've talked about, what will -- what will that consist of?

PRESIDING OFFICER: (SENATOR HARMON)

Senator Jacobs.

SENATOR JACOBS:

They will man the new maximum security prison that the

federal government is going to open there. There'll also be ancillary jobs outside the facility. But the direct jobs will be a -- over a thousand jobs, and these are good-paying jobs too. I don't know if anybody's noticed. But, maybe, I might even apply for one, because they're -- they're darn good jobs. But you have to be between twenty and fifty years old, so I can't get in unfortunately. But the jobs are sixty-five/seventy-five thousand dollars a year and they're twenty years and out.

SENATOR RIGHTER:

Last question, Senator Jacobs, if I might, and -- and that has to do with, we hear on a regular basis in this building, and certainly back home, concerns about overcrowding in Illinois' current Department of Corrections system. I'm sure that you've heard that as well and I'm sure that you've had to address that publicly. I've not heard your comments on that relative to the Thomson sale. Can you give me your view on that? And with that, I'll end my questioning. Thank you very much, Mr. President.

SENATOR JACOBS:

Yeah, thank you, sir. Clearly, we would've liked to open the prison ourself, the State of Illinois, and we almost had that done. Right before Governor Rod Blagojevich was arrested, there had been an agreement to move forward to open the Thomson prison. However, it did include closing some older prisons, and

that ruffled a few feathers in Pontiac. So it didn't happen. So, you know, I'm just glad to have it open and -- by hook or by crook. Thank you, Mr. President, Members of the Senate. Senate Bill 48 repeals the Unified Child Support Service {sic} (Services) Act. Currently, the Act allows counties to submit applications to the Department of Healthcare and Family Services to create their own child support programs under federal guidelines instead of State guidelines. There were only a few applications received the year following passage of this Act in 2003 and none of the applying counties qualified under federal standards. According to the Department of Healthcare and Family Services, no applications have been received since then, so they're requesting that this Act be repealed. And I'll be happy to answer any questions.

Current law, they're already getting both the e-mail and the certified letter. Is there anything in your bill that says if someone's nonresponsive to the e-mail -- I mean, how do you know that they actually got the -- the claim?

SENATOR FRERICHS:

I guess you'd probably have -- I don't know if they have read receipt or not, but these are claims that the e-mails are

These are financial aid and health care benefits programs specifically mentioned in this legislation - include Covering ALL KIDS Health Insurance Program and the Veterans' Health Insurance Program and financial aid under Articles III, IV, and V of the Illinois Public Aid Code. amends the Video Gaming Act, creating a grandfather clause for liquor establishments that hold liquor license pursuant to the Liquor Control Act's grandfather clause despite being located within a hundred feet of a church or a school. This bill allows such establishments to obtain the video gaming license, provided that the establishment obtained its original liquor license before the church or school moved in within the hundred-foot prohibited zone. This comes to me by the way of the AMVETS club in Peoria. Next door, the -- a church bought the old Shrine Mosque. The AMVETS have had a liquor license for decades and they were caught in this -- this bind. So I'd appreciate your support.

PRESIDING OFFICER: (SENATOR HARMON)

Thank you, Senator. Senator Sullivan's going to take the Chair.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Is there any discussion? Senator Righter, for what purpose do you rise?

SENATOR RIGHTER:

Will the sponsor yield, please, Mr. President?

Wage Law that allows public safety employees to negotiate this through their collective bargaining agreement. This piece of legislation will actually allow them to do that. And I would like to read legislative intent into the record. The purpose of this legislation is to permit the negotiation of alternative work schedules that would otherwise be prohibited by the federal These schedules are often used in law Minimum Wage Law. enforcement and allow employers more flexibility in scheduling, thereby reducing overtime costs. As is currently the case, an employer could not insist that a union negotiate over the waiver of this provision of the Minimum Wage Law. Thank you, Mr. President. Senate Bill 1219 amends the Notary Public Act to allow the Secretary of State to implement Internet-based system for notary applications, thereby simplifying the application process and reducing the amount of time that staff has to -- put in verifying the application data. It also removes a sunset date provision in the law that deals with the appearance of the notary seals and other identification requirements. Specifically, the sunsetting provision sets minimum requirements for the legibility of a notary's signature and the size, shape and appearance of the official seal. Senate Bill 1219, the sunset date of July 1st, 2013, would be removed altogether, allowing the seal/signature identification requirements to remain in place indefinitely. The proponents are the Illinois Secretary of State. There are no opponents that I know of at this time.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Thank you. Is there any discussion on Senator Van Pelt's first bill? Senator Althoff, for what purpose do you rise? SENATOR ALTHOFF:

Will the sponsor yield?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Indicates that she will yield. Senator Althoff.

SENATOR ALTHOFF:

Senator, a notary seal, is -- is that type -- a protected animal and can you explain to me where that animal lives?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Van Pelt.

SENATOR VAN PELT:

Actually, the notary seal is a seal that allows you to

notarize certificates.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Althoff.

SENATOR ALTHOFF:

Does -- does this notary have a special sound attached to it when you use it to certify a document?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Van Pelt.

SENATOR VAN PELT:

Actually, there is a clicking sound.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Althoff.

SENATOR ALTHOFF:

Senator, are you sure it shouldn't be more of a barking sound?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Van Pelt.

SENATOR VAN PELT:

That is something that can be considered later for -- if you'd like to introduce something requiring that later. But, right now, I'd like to present the bill as -- as it is written.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Althoff.

SENATOR ALTHOFF:

Senator, I will look forward to working with you on that trailer bill and we'll actually discuss most parts of barking, clicking, and other appropriate sounds.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Thank you. Further discussion? Senator Delgado, for what

SENATOR DELGADO:

Thank you, Mr. President. Question of the sponsor.

Senator Van Pelt, I'm a little concerned about the sunset provision. Can you tell me, if it's a cloudy day, will we have a sunset? Will we be able to tell when that sunset arrives? Did you check the weather on that?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Van Pelt.

SENATOR VAN PELT:

Senator, I have not checked the weather on -- for July 1st, 2013, but I do know that normally it's a sunny day, July 1st, and I would expect the sun would be shining and that we need the sunset provision addressed. Thank you.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Delgado.

SENATOR DELGADO:

Well, but -- but, in this case, you want the sun to set, not to shine, so you're going to have to help me with that part. But considering that you want to -- you have some -- some -- you -- and how will we -- on your -- on your seals, are they going to have plenty of ice around them and -- keeping them nice and cold so that they can click and make those nice sounds they make, or will you find other ways?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Van Pelt.

Senator, the seal is a -- a contraption that is used to stamp documents. It is not an animal or a seal as in the animal kingdom.

Well, I'll tell you, madam, I -- at this point in time, between not being sure when that sun's going to set, even if it's on July 1st, if we -- and if indeed we might have a full moon that day, I don't know, you might want to think about pulling this from the record for it being the first bill. But being one of our colleagues, I just want to make sure - it being someone who cares about all the animals and all the different things - that when we find out what a notary seal -- when I explain that to my nephew this afternoon, I'll show him a nice picture of that notary seal. Thank you, Mr. President.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Thank you. Further discussion? Senator Silverstein, for what purpose do you rise?

SENATOR SILVERSTEIN:

Point of inquiry to the Chair about Senator Van Pelt's bill.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Please state your inquiry.

SENATOR SILVERSTEIN:

I -- I just want to know, when she filed the bill, did she notarize it?

PRESIDING OFFICER: (SENATOR SULLIVAN)

We will have our legal staff look into that. I'm sure it was probably not done properly, but we'll check on that. Senator Steans, for what purpose do you rise?

SENATOR STEANS:

Indicates she will yield. Senator Steans.

SENATOR STEANS:

Well, first, Senator Van Pelt, I'm wondering whether you were attracted to this bill because of the -- the seal pelts that are involved and whether you have any relationship to these.

Senator Van Pelt.

SENATOR VAN PELT:

Can she please rephrase the question?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Steans.

SENATOR STEANS:

Well, right, I thought maybe that the pelts of the seals had some affiliation with you and I'm wondering whether you have any conflict of interest on this bill.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Van Pelt.

SENATOR VAN PELT:

Absolutely no conflict at all. It has nothing to do with seals in the animal kingdom, but has something to do with a contraption that is used -- contraption that's used to stamp documents and -- and to notarize them.

Senator Steans.

SENATOR STEANS:

Another -- it seems like you're setting minimum requirements around what the signatures must look like, some minimum specifications. I'm wondering if people such as the new Secretary of the Treasury, Lew, would no longer be able to be a notary public if he wanted to or, basically, any doctor I know. I'm sort of concerned that this may be really narrowing the field on our eligible pool of notaries.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Van Pelt.

SENATOR VAN PELT:

I'm sure that we will not reduce the pool of eligible notaries. It's -- it's simply that the signature must be legible and applied to every document that a notary certifies.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Further discussion? Senator Righter, for what purpose do you rise?

SENATOR RIGHTER:

Will the sponsor yield, please, Mr. President?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Indicates she will yield. Senator Righter.

SENATOR RIGHTER:

Thank you. Senator, first question I have is - I've looked at our online system about your bill and I can't find any evidence of cosponsor - do you have any cosponsors at all on this bill, anyone else who's for this other than you?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Now, I'm guessing you know Secretary White, do you not?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Van Pelt.

SENATOR VAN PELT:

Yes, I do. Thank you.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Righter.

SENATOR RIGHTER:

Then, knowing him and obviously referencing him in the bill, I'm sure that you can answer this question in exacting detail. Exactly what is the Secretary of State's process in implementing a bill? Tell me what they do in their office.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Van Pelt.

SENATOR VAN PELT:

I would like to request that we stick to this particular

bill and discuss this particular bill rather than to talk about what happens in the Secretary of State's Office, which I'm not well informed about. But I also would like to note that I have other chief cosponsors to this bill, including Linda Holmes, Mary -- Mattie Hunter, Toi Hutchinson and, of course, Mr. Hastings.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Righter.

SENATOR RIGHTER:

Okay, that was pretty good, but I think now we're going to broaden the scope of our inquiry a little bit based on that --based on that response. Further in the bill - and let's talk about the bill, Senator - it references Section 2-104 of the Act. What does Section 2-104 of the Act provide for?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Van Pelt.

SENATOR VAN PELT:

Electronic applications, I believe, system for appointments and written oaths for appointment and commission as a notary public.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Righter.

SENATOR RIGHTER:

So, give me a little help here, Senator. Your bill amends Section 2-102. Tell me how Section 2-102 and 2-104 work together to accomplish the goal that you're trying to get to here.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Van Pelt.

SENATOR VAN PELT:

That 102 -- Section 2-102 is the application and, also, Section 2-104 is the oath. And now I have bipartisan support for my bill by someone who I can't read their signature, but -- Senator Righter is now a chief cosponsor.

Senator Righter.

SENATOR RIGHTER:

Believe me, Senator, and I would guess at least a handful of your colleagues on your -- side of the aisle will tell you, that I'm just here to help; that I'm just trying to help you get your bill passed. And it seems like, right now, it's a really lonely effort for you and a little bit of a bewildered effort for you, so I'm just going to try and help you, give a little nudge, and get this passed the Senate. So, thank you very much for answering my questions, Senator. Thank you, Mr. President.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Thank you. Thank you, Senator. Further discussion? Senator Jacobs, for what purpose do you rise?

SENATOR JACOBS:

Thank you, Mr. President. And on -- on the risk of beating a dead seal, I want to ask, what kind of seal are you using? Is it a wax seal? Is it a decoder ring? Exactly what kind of seal are you using these days?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Van Pelt.

SENATOR VAN PELT:

It's a self-inking stamp. It's the one that I use as a notary.

Senator Jacobs.

SENATOR JACOBS:

I can remember, Senator, when I was new and I did my first bill. I did not understand as a downstate kid, redneck kid, I didn't understand how diverse this Body is. I didn't understand that there was legends sitting next to me; that there was people of great power and interest. But I am particularly concerned about talking about the size, shape, and appearance. Are you referring to your colleagues or are you referring to the seal? PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Van Pelt.

SENATOR VAN PELT:

Everything in this provision is in regards to the bill. It's no reflection on our colleagues at all.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Thank you. Further discussion? Senator Haine, for what purpose do you rise?

SENATOR HAINE:

Would this most distinguished Senator yield for a question?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Indicates that she will yield, Senator Haine.

SENATOR HAINE:

Now, Senator Van Pelt, we here are concerned profoundly with the separation of church and State. And your bill raises some significant questions. Have you thought of these questions involving the separation of church and State with this bill?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Van Pelt.

SENATOR VAN PELT:

I have thought extensively about the separation between State and church, but in regards to this bill, it has no reflection on the church. It does have a reflection on the State only.

I thought so. Let me enlighten you that the notary public, the office - and it is an office - goes back to the -- to Roman law and the notaries during the Middle Ages were quite often, if not exclusively, priests, because they were the only ones who were literate to read the lectionary. Notaries were appointed by the Pope only. Now, does this bill imply that our distinguished Secretary of State is going to assume papal authority during the absence of a Pope at this time? I want to know the answer to that question. A lot of people are wondering about that. The Pope flies away in a helicopter and here we have a bill appointing notaries, which is a papal function.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Van Pelt.

SENATOR VAN PELT:

I -- I don't believe that Secretary Jesse White will be taking on papal authorities or responsibilities. And on top of it, I think this is why we must have separation between church and State, so that the State can do its function. Thank you.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Haine.

SENATOR HAINE:

Thank you, Senator Van Pelt. Now here's another concern. You do, as we all do, revere the Declaration of Independence of the United States, right?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Haine.

So, my question is, is the Secretary attempting now, if the Pope is not a factor, to take over the powers of the King in appointing notaries? Is this streamlining that power? Does this have unchecked authority that calls into question the usurpation of the powers of a monarch in this State?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Van Pelt.

SENATOR VAN PELT:

Absolutely no. I think that it is clear that this simply is the State Legislature allowing the Secretary of State to establish an electronic notary process to streamline the application process for both staff -- to reduce staff time and also make it easier for people to get that application in on time.

PRESIDING OFFICER: (SENATOR SULLIVAN)

SENATOR HAINE:

To conclude, and to use the words of Senator Righter who's perfected them into an art form, I want to caution everyone on my side of the aisle to be concerned about the usurpation of papal and monarchical powers in this bill. Thank you.

Thank -- thank you, Senator Haine. Our last speaker seeking to speak is Senator Raoul. For what purpose do you rise?

Is it going to be a seal (barking seal audio played) or a clicking sound? Is it a seal or a click? Is it a notary click bill or a notary (barking seal audio played) seals?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Van Pelt.

SENATOR VAN PELT:

It is an -- an electronic notary republic {sic} application bill and there is a stamp involved. Maybe we should say stamp, notary stamp, so we can be clear that we're not talking about that sound that you made.

You know, you just told me that you're concerned about job creation in this State and now you're introducing this bills that -- this bill that will get -- take away jobs from hardworking people that have been with the Secretary of State for years and you're going to give this responsibility to a computer to do their jobs. What are we going to do about the crime that comes as a result of this? I urge a No vote on this bill.

PRESIDING OFFICER: (SENATOR SULLIVAN)
