She continued to serve in the Illinois House and Senate for forty years. Earlean Collins was elected the first African-American woman to the Illinois Senate in 1977 and served until 1999. Adeline -- Adeline Geo-Karis was a trailblazer, and in 1985, she became the first woman to serve as Assistant Majority Leader in the Illinois Senate. In 2003, the first Hispanic woman, Senator Iris Martinez, was elected to the Illinois Senate. And in 2009, State Senator Christine Radogno became the State's first woman Caucus Leader, Minority Leader of the Illinois Senate. So I'd like to thank you and wish you to recognize and celebrate Women's History Month with me. Thank you.
