We've seen measures like this before, most recently with Northfield. In the recent election, there were several referendums approved. Because of the -- the mechanics of the way the question is asked and the rate is determined and applied to EAV, these taxing districts realized much less than they had asked the voters to approve. This would cure it for this year only. I don't believe there are any other taxing districts that would need this sort of curative measure. I do intend to advance legislation later in the Session that would hopefully prevent this from happening in the future. But for now we're left with the task of trying to cure it for this one particular taxing body, where the voters approved a referendum, but the results, for unintended reasons, are not what the voters approved.

Senator, can -- can you please walk through, not necessarily word for word, what the ballot question was and what the result has been and what your bill would do to change that, but something close to word for word, so we have an understanding of exactly what we're doing here?

## SENATOR HARMON:

Thank you, Mr. President. Thank you for your question, Senator. And it's -- it's right on point. The -- the taxing body, the fire protection district, went to the voters with the question, "Shall the taxing rate be increased by .25 percent above the PTELL limiting rate?" In addition to that, it sets forth in very clear terms that the approximate amount of taxes extendable at the most recent levy were 4.2 million, and if the referendum is approved, it will be roughly 6.2 million. It also says that for the next tax year, the approximate impact on a house with a fair market value of a hundred thousand dollars is eighty-two dollars and fifty cents. The reason this is a problem is because of the way we formulate the question. Taxing bodies figure out how much money they're going to need, then they use the current extended -- the EAV to determine a rate. Then they ask for that rate, and after the rate is approved, they come back and apply it against the EAV. If the EAV has changed dramatically, as we have seen, the result is not the dollar amount set forth on the -- the referendum question, but something far less in this case. In the past, in other circumstances, it's been much more. And that's a problem as

well. Again, I have another bill I hope will fix that. But I think the voters understood the dollar amounts and the impact on their homes much more than they understood the -- the rate as a -- as a key piece of the question.

So, then, after the ballot measure was approved and then those -- that tax rate was applied to the new EAV, what's been the outcome?

As I understand it from -- from the district, instead of generating approximately two million dollars, applying the -- the tax rate to the current EAV, the reduced EAV, would generate about six hundred thousand dollars.

## SENATOR McCARTER:

We had a discussion on this in the committee yesterday and I think my -- my objection to the bill then and now is that we have a system that we work within today, which is a -- the -- taking -- establishing a rate against an EAV. We're attempting here to kind of bypass the system, and I understand it's -- it's

to fulfill the intent of what the voters put forth, and I -- and I -- so I -- I don't think there's any -- I think there's good intentions here. But the problem is, if we -- if we continue to do this here, we'll do it with somebody else. And my -- my next question was, when -- when EAVs do -- go back up, do we change the rate? Now, that said, I -- I am in complete agreement with -- with Senator Harmon's Senate Bill 2256 and (22)57, which present -- prevents this from happening in the future. I think that's -- those are great bills which will keep us from coming back and having to do this. So, although I'm -- object and -- and not in favor of this bill, I would suggest that we all support those other -- 2256 and 2257. Thank you.

Because if the EAV goes up, the -- the aggregate extension does not; the rate will -- will be changed to reflect that. So, there -- there's a -- there is a -- a collar on this. The bill also allows the Illinois Gaming Board to waive the requirement of any specific products if it's determined that the requirement is not necessary to protect the integrity of the game. It also provides that items purchased from a licensed supplier may continue to be used in the event the supplier subsequently changes his name, logo, mark, or ceases to be licensed as a supplier for any reason. ## SENATOR MURPHY:

Senate Bill 1224 -- Senator -- Senate Bill 1224 amends the State pension systems for future hires only and says that money paid for unused sick days in the last year of employment - sick and vacation days - is not included in the calculation for final pensionable salary. Bill passed with no No votes out of the Executive Committee. I think we have bipartisan support for this. And this is one small thing I hope we can do on pensions today. I'd appreciate an Aye vote.

## PRESIDING OFFICER: (SENATOR LINK)

Is there any discussion? This is a record; all the lights are {sic} lit up. Seeing none, the question is, shall Senate Bill 1224 pass. All those in favor will vote Aye. Opposed,

Out of the record. Senate Bill 1307, we'll skip over. Senate Bill 1310. Senator Bush, on your first bill. Mr. Secretary, please read the bill.

Senate Bill 1310.

(Secretary reads title of bill)

Senator Bush.

## SENATOR BUSH:

Didn't have the button pressed all the way down. Anyway, thank you, Mr. President, Members of the Senate. Senate Bill 1310 is a bill that enhances public safety on our waterways and protects us by strengthening provisions in the Boat Registration and Safety Act regarding a boat's carrying capacity, the definition of an "authorized emergency watercraft", and increases penalties for certain violations. It clarifies that a person being towed by a watercraft is considered part of the total numbers of passengers. It also adds flashing blue lights to the list of colored lights necessary for a watercraft to be designated as an authorized watercraft. The IDNR Office of Law Enforcement currently uses flashing blue lights. It also increases the penalties for certain violations relating to boat

rentals. And it changes the penalty for falsifying or altering a watercraft -- registration from a petty offense to a Class A misdemeanor. The IDNR wants to ensure consistency among penalties for offenses related to watercraft tilting and -- titling, excuse me, and registration - or boats that tilt. Anyway, I don't know of any opponents to the bill and I'd be happy to answer any questions.

PRESIDING OFFICER: (SENATOR LINK)

Are there any questions on Senator Bush's first bill? Senator Noland.

SENATOR NOLAND:

Thank you, Mr. Chairman {sic}. Senator, as you know...

PRESIDING OFFICER: (SENATOR LINK)

She will -- she indicates she will yield.

### SENATOR NOLAND:

Thank you, thank you, thank you very much, Leader. Thank you for yielding for this question. As you may know, I chair the Criminal Law Committee and I'm just kind of curious, why would we -- it's been a long time since I think anyone in our country's been concerned about this, so I want to know why we would be concerned that water skiers, tubers, parasailers, and other persons would be practicing witchcraft.

## PRESIDING OFFICER: (SENATOR LINK)

Could -- could we keep the noise down in the Chamber on Senator Bush's first bill? Senator Bush.

PRESIDING OFFICER: (SENATOR LINK)

Senator Bush.

### SENATOR BUSH:

Thank you, again, for the question. Watercraft is a -- is a vessel by which people will ride on our waterways. Some people call them boats.

PRESIDING OFFICER: (SENATOR LINK)

Senator Noland.

### SENATOR NOLAND:

So your bill is just simply limited to boats.

PRESIDING OFFICER: (SENATOR LINK)

Senator Bush.

## SENATOR BUSH:

Perhaps motorized canoes.

PRESIDING OFFICER: (SENATOR LINK)

Senator Bush, you -- you should talk into the microphone. Senator Noland.

### SENATOR NOLAND:

Now, I understand -- you said, "canoe"? Is that correct? Now, I've never seen a motorized canoe. Could you explain to me or give me an idea of what a motorized canoe is? And I'd like

### SENATOR NOLAND:

Thank you very much, 'cause I'm trying to envision a water skier behind a canoe. And, you know, I know that you would have to row awfully fast in order to be able to propel a water skier behind a canoe, and I was just wondering if your bill provided for that.

PRESIDING OFFICER: (SENATOR LINK)

Senator Bush.

## SENATOR BUSH:

Thank you for the -- the question, and -- and I apologize for any confusion I might have created by suggesting that a canoe may be motorized. No. I mean, we're looking at boats that carry skiers, also jet skis and -- that carry skiers, tubers, that would be of -- of that fashion of watercraft.

## SENATOR NOLAND:

Good. Thank you, Senator. I'm easily confused. I think my colleagues would concur with that. But, let me ask you this,

### SENATOR NOLAND:

I'm aware, and I'm aware that we all want to go home as well. So, you know, having served in the Navy, and -- we had sailors that would fly too. We called them pilots. And they were the best pilots on -- on -- serving in our military, as you might expect me to -- to suggest. I want to say thank you very much for bringing this bill. You've done an outstanding job. And I wish you well in your career here and your further hazing here this afternoon. So, thank you very much. Did a great...

PRESIDING OFFICER: (SENATOR LINK)

Senator Sullivan.

## SENATOR SULLIVAN:

Thank you, Mr. President. Would the sponsor yield for a question?

PRESIDING OFFICER: (SENATOR LINK)

Indicates she will.

## SENATOR SULLIVAN:

Thank you. Senator Bush, my analysis says that you're -- you're suspending boating privileges. Why would you take

boating privileges away from individuals here in the State of Illinois? My Senate district has the Mississippi River on one side, the Illinois River on the other side. I can't imagine why you would sponsor legislation to take away the privilege to go boating. Why would you do that?

### SENATOR BUSH:

Thank you so much for that question. It's certainly not the bill's intention to stop anyone from boating. The intention of the bill is to make sure that when people are boating, we're increasing the safety, making sure that we're counting people -- is the correct number. So that anybody that's being towed by a boat, say in a parasail or in a tube and skiing, is counted in the number. It's certainly not the intention of the bill to stop people from enjoying our beautiful waterways.

PRESIDING OFFICER: (SENATOR LINK)

Senator Righter, for what purpose do you rise? SENATOR RIGHTER:

Thank you, Mr. President. And I know it's not traditional during the abuse that's dished out on a new Member on their first bill to do this, but I would move the previous question. I want to make clear for you, Mr. President, and the Chamber, I'm not doing that to spare Senator Bush - sorry - any -- any difficult questions, but I notice on the Calendar that about nine bills from now another new Member to the Illinois Senate has their first bill and we'd really like to get to that today. ## SENATOR ALTHOFF:

Thank -- thank you, Mr. President. Will the sponsor yield?

Senator, following the previous questioner's tact, I notice

Congratulations on your first bill.

PRESIDING OFFICER: (SENATOR LINK)

Senator Raoul.

### SENATOR RAOUL:

Question of the sponsor.

PRESIDING OFFICER: (SENATOR LINK)

She indicates she will yield.

## SENATOR RAOUL:

Senator Bush, I'm -- I'm -- I'm -- I'm gravely concerned here. You know, I've gotten to know you over the course of the last several weeks, months, and -- and I got the sense that you're a person really sensitive to racial equality. Am I -- am I right about that?

PRESIDING OFFICER: (SENATOR LINK)

Senator Bush.

## SENATOR BUSH:

I -- I thank you for that question, because if there is any need to clarify, yes, I'm someone who -- racial equality is very important to me.

And -- and so that's why I'm a little confused here, you know, 'cause I'm -- I'm not a boat owner, but if I were, would there be one standard for my lights and another standard for your lights?

Clearly, the standards should be equal and -- and fair.

PRESIDING OFFICER: (SENATOR LINK)

Senator Raoul.

### SENATOR RAOUL:

Then tell me, Senator Bush, why does your bill have to refer to colored lights? Why can't it be the lights -- the same lights for everybody? Why do you have to talk about colored lights? I thought that we were in 2013. I thought we've advanced since that time. I don't understand it. I think my lights should be treated the same as your lights, and your lights -- your bill shouldn't have a special provision for colored lights. I ask that you pull this bill out of the record and amend your bill; otherwise, I urge a No vote on this bill.

## SENATOR HAINE:

## SENATOR BUSH:

We improve with time. You know, you're a little nervous in the beginning. But, anyway, I -- I would just urge a Yes vote. And -- and thank you to Senator Righter. I look forward to many interesting equal debates with you. Thank you.
