This was brought to me by a retired judge, and the bill amends the Jury Act and the Jury Secrecy Act with some of the following: It provides that if a juror's predominant language is not English and they can understand the English language if interpreted or translated, then the -- then the juror can serve on -- on jury. Provides that if a juror predominant language is not English, then the juror shall have interpreter during all periods of trial and may be accompanied by and communicated with a court-appointed interpreter when the jury's sequestered during deliberation. It also provides that the court shall determine and allow a reasonable fee for all services provided under this subsection to be paid out of the general county fund. It also requires the interpreter to take on an oath swearing to make a

true interpretation of the proceedings and deliberations to the juror and to not interject his or her own thoughts, conclusions, opinions, or beliefs of the evidence presented, the instructions, how to analyze the evidence, or what the verdict should be. It also creates a pilot program for the bill and it makes applicable for the periods of two years in Lake, DuPage, Kane, Will, and Cook counties. And it also requires the Administration {sic} (Administrative) Office of Illinois Courts to record the amount of funds expended, languages interpreted, and extent to which interpreters are used in each county in which the pilot programs operate. And I'll be happy to answer any questions.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Righter, what purpose do you rise?

SENATOR RIGHTER:

Will the sponsor yield, please?

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Sponsor said she will yield.

SENATOR RIGHTER:

Senator Martinez, I just -- I want to walk through, because in the way it is now, Senate Bill 977 is much different than the introduced version. And I want to make sure that I, some other Members are very clear about the changes that are being made. It's now just a two-year pilot program and now is applicable just to Cook, Lake, DuPage and Kane counties. Are -- is both of those statements true?

And Will. Will County.

I mean, is -- is that how this works or -- I mean, give me the -- give me the practical ABC's of how this will play out in the courtroom.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Martinez.

SENATOR MARTINEZ:

The way the judge envisions to see this work is, if -- I think even on the forms they send to you when you are notified that you're to -- to serve as a -- as a juror, I think right there we want to talk about maybe putting into the language there, one of the things, is if, you know, the person wants to have an interpreter. That's one of the first things that we've been talking about. Second, when that juror is sitting there -- when that person is sitting there and the jury selection is happening, if an attorney, either on the defense -- you know, on the defense or on the -- on the State's, will ask that individual questions, and I think the first thing they're going to ask is, are you comfortable in English? That -- that person might not be comfortable in -- in the -- in the English language and, at that point, can ask if he wants an interpreter. If that person then stays on the jury, if he's selected to serve, then that interpreter will see him through to the very end, even up until deliberations.
