We are negotiating, in the preliminary phases, an election law bill to deal with some of the required cleanup following our -- our last election law bill in the spring. Again, this is a shell bill. It would be amended in the House and come back to us for concurrence if and when the appropriate provisions are negotiated.

#### PRESIDENT CULLERTON:

Is there any discussion? Senator Righter.

### SENATOR RIGHTER:

Thank you, Mr. President. Will the sponsor yield, please? PRESIDENT CULLERTON:

He indicates he will.

#### SENATOR RIGHTER:

Senator Harmon, in your conversations with the Leaders in the House, has there been any conversation about negotiating the bill here, where it already is? And we can put it together and then the Members know what they're voting on, and then the House can take what -- what we have negotiated with them in a cooperative fashion.

## PRESIDENT CULLERTON:

Senator Harmon.

#### SENATOR HARMON:

Thank you, Mr. President. Senator, I appreciate your question, and that would clearly be my preference. We are dealing with a procedural reality with 6-day posting and this being a Senate bill. If we don't pass it out of the Senate this week, the House would be in a more difficult position to take it up in the

second week of the Veto Session to send it back to us. We will be fully engaged in those negotiations.

### PRESIDENT CULLERTON:

Senator Righter.

#### SENATOR RIGHTER:

I guess, then, let's rewind the tape a little bit. I take from your answer that you feel it is necessary that this bill be passed before Veto Session or what is oftentimes termed the "lameduck" Session ends, before a new Governor takes office or a new General Assembly takes office. Why is it necessary to do it so quickly?

## SENATOR HARMON:

Thank you, Mr. President. I don't know whether there will be a lame-duck Session. I don't know if this General Assembly will return in January. I don't know what our schedule will be in January. We do have municipal elections in February. And so, if we want to take up anything that would be effective in that election, we need to act now in the regularly scheduled Veto Session.

The Loyola University Chicago men's volleyball team finished the 2014 season with a record of 29 wins, 1 loss, and at one point, won 27 consecutive matches. This spring, in front of a capacity crowd in the Gentile Arena, the men's team defeated Stanford University in a four-set win in the NCAA Men's Volleyball Championship game, earning the school its first-ever volleyball championship title. Supplemental appropriations bills oftentimes pass later into the calendar year. What's a little different about this year is, is that we'll have a new General Assembly seated in January and we'll have a new Governor seated in January as well. So what is the urgency, other than trying to get this in front of the current Governor before he leaves office, that -- that -- that's pressing this timeline?

#### SENATOR KOTOWSKI:

You know, I -- I can't speak to that. All I can speak to, it's the -- the same financial challenges that we've had that -- when we dealt with the budget in May. They -- they -- they happen throughout the year. Whether we have a supplemental now or a supplemental in the future, it just gives us an opportunity to address these financial challenges that - as you're well aware of - that we currently face.

#### PRESIDENT CULLERTON:

Senator Righter.

### SENATOR RIGHTER:

Thank you, Mr. President. Well, Senator Kotowski, you've got me worried now, because you can't -- you're the sponsor of the bill, but you can't speak to the timing of moving the bill - even though you're in control of the timing of the moving of the bill. So what I'm trying to figure out is why are you moving the bill, a supplemental appropriation, which could contain very important issues, why are we in a hurry to do that before the Veto Session ends and before the new Governor can take his seat.

## SENATOR KOTOWSKI:

Yes. Senator Righter, there's -- there's -- there's no -- this is very straightforward here. It's a supplemental bill and it's a shell bill. It gives us an opportunity to address some of the challenges that we have here on a spending standpoint. And so -- I mean, this is -- it is what it is. If there -- when the

content is put on the bill, if at all, if there's any, we'll have a hearing on it, we'll discuss it, and we'll have a, you know, a full-throated debate on the merits of that legislation. This allows us just to have this in place in order to make sure we can do that.

Thank you, Mr. President. Very briefly to the bill, if I might.

A new Governor is going to take office in January. Let's have the balanced government and new Governor that the voters asked for in place before we decide to start spending even more of the taxpayers' money. I would urge a No vote.
